Discussion and/or action to award bid for used Street Sweeper for \$20,000 to J&F Equipment Sales

Babaletakis reminded the Council that they had given permission to go to bid in May, the Town only received one bid and it was within budget.

Public hearing pursuant to Clifton Town Code § 51.24(B)(1) to consider and receive testimony and evidence regarding disputed sewer utility charges asserted by Barbara Waddell Reyes

Resident Luis Montoya spoke to concerns of the Town plugging residents' sewer lines. He stated that if he remembers correctly from his time on the Council is that there are multiple residents that are tied into the same main tap, causing complications with plugging. He recalls approximately 80 residents in this situation. Babaletakis assured him that the Town would not plug a resident if it adversely affects another resident.

Resident Barbara Waddell Reyes was given the opportunity to present to the Council. She presented communication between her and previous Town Manager Rudy Perez as well as current Town Manager Tina Babaletakis as well as billing from Morenci Water & Electric showing no water usage. She stated the frustrations of getting her address changed to just one number and how at that time she was informed that if she disconnected her water at 679 Turner Ave., she would be able to disconnect her sewer.

Town Manager Babaletakis presented that records show that the Town did change her address in the sewer system, at the appropriate time, however continued to bill for sewer as the accounts with Morenci Water & Electric were still both active and continue to remain active. The Town was still mailing her two bills, both for 669 Turner Ave. After Ms. Waddell Reye's initial complaint, she did direct staff to send one bill, but with two sewer taps. Staff made the change leaving the delinquent balance on the now closed account. After conferring with the Town Attorney's staff was able to bring the delinquent balance over to the now consolidated account for 669 Turner Ave.

Discussion and/or action, after considering all testimony and evidence presented by Barbara Waddell Reyes, to make a final determination on the disputed utility charges and to provide direction to staff regarding enforcement of delinquent sewer accounts pursuant to § 51.24.

Council opted to convene into Executive Session to discuss legal options with the Town Attorneys.
