Call to Order:

The meeting was called to order at 2:02 p.m. by Mayor Laura Dorrell followed by the Pledge of Allegiance.

Call to the Public

Leslie Ray, Director of the Visitors Center, provided an update on Greenlee Tourism. She announced that Karen Frye will serve as the new chairperson. Leslie also shared information about the Greenlee Marketplace, a venue for buying and selling a variety of local products and goods.

Council Reports

Council Member Brown spoke of the poor condition of Metcalf Road. He encouraged all residents to voice their concerns and asked for patience as the Town Manager works to respond to each issue.

Council Member Carrillo commented on the recent mixer held in the Town of Clifton. She expressed appreciation for the opportunity to connect with local businesses and said she looks forward to the next one.

Council Member Waddell Reyes spoke about her weekend away with her son.

Mayor Dorrell shared her thoughts on the recent mixer, expressing appreciation for the strong turnout. She acknowledged the Dream Builders and the positive impact they've made on the community. The Mayor also mentioned receiving a concern from a resident and emphasized the importance of community members speaking up, as it helps the Town explore different ways to address local issues.

Committee Reports

Rates and Fees (Dorrell)

The minutes from the previous meeting were approved. The Council discussed several financial topics, including the bed tax, fire fees, and the potential implementation of a dump station fee in North Clifton.

Grants and Funding (Carrillo)

Meeting was canceled.

Buildings and Properties (James)

Meeting was canceled.

Roads and Streets (Lorenzo)

Work has begun on Park Avenue. Coordination with water and electric departments took place last week to prepare the area, beginning on the north side near Vozza. Public notice of the road closure was posted on Facebook and physically on-site, with closure starting June 18. The goal is to have the project completed and paved by the end of the month. Discussions are ongoing with Morenci Water and Electric to cover costs for Metcalf, Highline, and Webster.

New Business

Discussion only Presentation on available changes to the Town of Clifton's Tax Code; Presenters Lee Grafstrom and/or Kathleen Jackson for the Arizona League of Cities and Towns

Lee Grafstrom, Tax Analyst, gave a presentation on the Town's revenue sources, focusing on the Clifton Tax Code. He proposed a potential increase in the hospitality industry tax rate from 3% to 5%. The Town is considering code and rate changes to support this adjustment. Lee emphasized the importance of following a strict timeline to implement any changes.

Discussion and/or action on the Train Depot roof; provide direction to staff on the desired scope of work for Train Depot roof repairs

The Town Manager is seeking clarification from the Council on how to proceed with the Train Depot roof repairs. Initially, the Buildings and Properties Committee voted to replace the entire roof. However, in a subsequent session, the subcommittee voted to repair only the flat portion. After on-site assessments by Public Works and the contractor, the recommendation was to fix only what is necessary. The Town Manager is requesting direction from Council on whether to proceed with full or partial roof replacement.

Motion to fix the flat end on the North and South side of the roof made by Council Member Waddell Reyes, second to the motion made by Council Member Carrillo.

Discussion and/or action on Vacant Property Registration

Town Manager discussed initiating a Vacant Property Registration process. Staff will begin identifying all empty lots and creating a master list. This list will be used to ensure properties are in compliance with local ordinances and to prepare for future blight enforcement efforts.

Discussion and/or action to adopt newly revised Town of Clifton Personnel Policy Draft effective date 7/1/2025

The Town manager discussed the adoption of the newly revised Town of Clifton Personnel Policy. Since the previous working session, four new additions have been incorporated. Council Member Brown inquired about the review frequency of the policy. The Town Manager noted that it has been one year since the last review and reaffirmed that she manages day-to-day personnel matters, but will bring any significant issues to the Council's attention.

Read by the Mayor. Town manager spoke that this is the second review to see if there are any questions or concerns to bring a better legal meaning and allowing for citations for the blithe ordinances.

With user accounts now assigned this is the next step in the data sharing process. The Town Manager requested Council approval and signature of the Data Access Agreement to move forward with accessing the data.

Departmental budgets were outlined, with explanations of anticipated expenditures and planning for the upcoming fiscal year.
