Quorum Present

The Town's legal counsel, Trish Stuhan, participated via telephone. The meeting was called to order by Mayor Laura Dorrell followed by the Pledge of Allegiance

Mayor Dorrell held a moment of silence for Walter Mares, journalist, former employee, and beloved community member who passed away this week

Call to the Public:

Martha Lujan Social Performance Director with FMI, notified the Council of an upcoming project in the area. Freeport Minerals the parent company will be exploring the possibility of using Geo Thermal energy technology to help supplement and assist in mining at the Morenci mine. They will be doing exploratory drilling. The testing will involve lights and noise and will take about three weeks and cannot be stopped once it is started. Will start at the end of April and each well will take about three weeks and there will be three wells in 2 different areas. Resident Steve Ahmann expressed concern that the project could potentially have a negative impact on the hot springs in Clifton for Tourism.

Sheriff Eric Ellison, current Greenlee County Sheriff's department. The department has been working hard to slow down the large number of speeders on Hwy 191. It does seem to be making a difference. The department has also hired another investigator. They are also actively seeking multiple grants.

Council Reports

Council Member Carrillo working with Arizona Game & Fish for residents to recycle their used Christmas Trees, for use at Roper Lake. Other recycling possibilities for trees.

Vice Mayor James informed the public of a scam call regarding missing a "court date" he reported it to the courts and sheriff's department.

Council Member Waddell Reyes acknowledged she showed up late (arrived during Call to the Public). She spoke with someone from the railroad regarding the dust and other problems during work. She asked them to keep in contact with the Town Manager and keep her informed.

Mayor Dorrell thanked the Tourism Council for the great event of the Spring River Festival. Updated the Council and public on the moving mural that the high school honors art class is working on. It will be of Chase Creek Street.

Rates and Fees (Dorrell)

Fair Housing Month Proclamation - Mayor Laura Dorrell

Mayor Dorrell read the Fair Housing Month Proclamation declaring April Fair Housing Month in Clifton

Discussion only, request of support in recognizing the importance of early childhood development and recognizing the week of April 5^{th} – 11^{th} as Week of Young Child in Clifton, presented by Shari Elkins, Regional Director, Graham/Greenlee Region for First Things First

First Things First Regional Director Shari Elkins presented to the Council the importance of early childhood education and explained some of the things that First Things First does.

Week of the Young Child Proclamation - Mayor Laura Dorrell

Mayor Dorrell read the Week of the Young Child Proclamation declaring the week of April 5th-11th the week of the child in Clifton.

Discussion only: report from US Forest Service on recent events and programs of interest to the Town of Clifton, presented by Vince Voelker District Ranger, Joe Names Fire Management Officer, and Lehi Vizcaino

Members of the US Forest Service staff presented on what they have been doing in our area recently, discussed staffing changes and job duties of staff present. They also presented that there will be a higher risk of wildfires this year. They hope to increase the communication between themselves and local governments.

Discussion and/or action to authorize the Mayor to enter into a Cooperative Agreement with the State Forester for the protection of its forests and wildlands as authorized under A.R.S. §§ 37-1303, 37-1302(13), 48-805(B)(17) and; the protection of forest, wild and agricultural lands, and rural structures as provided for within the Cooperative Forestry Assistance Act, 16 U.S.C. Section 2106

Fire staff presented the cooperative agreement to the Council and public. Babaletakis clarified the Town's responsibility with reporting if called to help. They explained that if we had a wildfire within town limits they would also assist. Attorney Stuhan clarified whether the town would have to reimburse the Forest Service for any charges incurred during a fire. They agreed the paperwork states it is possible; however, they have never seen it actually happen in their time.

Presentation of AZ Water Association's 2025 "Small Plant of the Year" award for the Town of Clifton's Wastewater Treatment Plant – Alan Forrest, AZ Water Association, President

Alan Forrest presented the Town of Clifton with a plaque awarding them as "Small Plant of the Year" for the Wastewater Treatment Plant.

Discussion and/or action for the Town of Clifton to host a Greenlee County Chamber of Commerce Mixer in May

Babaletakis and Council discussed having the Town host a Chamber mixer at the Council Chambers sometime in late May. The Council agreed that it has been a while since the Town has hosted a mixer

Discussion and/or action to purchase a table for the Greenlee County Chamber of Commerce Annual Event on April 26^{th} at 6:00pm

Mayor Dorrell mentioned that historically the Council would approve the purchase of the table, but that they would leave it open for staff to attend and the Council could attend on their own.

Motion to approve the purchase of a table for the Greenlee County Chamber of Commerce Annual Event on April 26th at 6pm made by Council Member Ahmann, second to the motion made by Council Member Lorenzo

Discussion and/or action regarding the selection of the Town of Clifton Welcome Sign

Babaletakis presented the two current options for the Welcome Sign, the general consensus was that it would be better for one large coming into Clifton from the south as opposed to two smaller ones. Council members expressed their desire for color on the sign to make it stand out.

Discussion on the town logo was held about variations of the logo that the town has.

Discussion and/or action to approve \$518,446.91 for Sunland Asphalt & Construction, LLC, an authorized vendor with 1 Government Procurement Alliance (1GPA), to provide road and street maintenance to Park Avenue and to authorize the Mayor to execute the Purchase Order Contract between the Town of Clifton and Sunland Asphalt.

Babaletakis explained the changes made to the scope of work, it will go further to the end of Park Ave and not pave the portion of the road near the railroad tracks and informed the Council that there is a verbal agreement with Morenci W&E to pay 45%. Discussed that the project should be completed prior to June 30, 2025.

Motion to approve \$518,446.91 for Sunland Asphalt & Construction, LLC, an authorized vendor with 1 Government Procurement Alliance (1GPA), to provide road and street maintenance to Park Avenue and to authorize the Mayor to execute the Purchase Order Contract between the Town of Clifton and Sunland Asphalt made by Council Member Brown second to the motion made by Council Member Waddell Reyes.

Discussion and/or action to direct Town Attorney on the drafting of Ordinance and/or Personnel Policy as it pertains to the Town Magistrate and Town Attorney

Babaletakis explained that the Town's ordinances are currently conflicting 32.25 and 34.15 one states that the Council appoints the Magistrate and the other states that the Town Manager appoints the Magistrate, it is recommended that the Council appoint. Attorney Stuhan's office will draft updated ordinance. Ordinance and Personnel Policy will need to be updated and drafted to clarify the role of the Town Attorney and who they represent. Babaletakis summarized that the Attorney will work with the Manager on day-to-day issues and represent the Council or the Town as a whole.

Discussion only Update on the Town's efforts in Sewer Debt Collections

Babaletakis explained that the sewer debt was not how it first appeared, there is up to approximately \$200,000 that is "uncollectible debt". Which leaves approximately \$100,000 that still will need to be collected. Collection efforts have been amped up. Mailed out 333 postcards, 55 paid about 17%. Notice of intent to plug will be sent next. Sewer plugs have been ordered.

Discussion or consideration regarding appointment of Planning and Zoning Commission Members

Council members were informed that there are two vacancies and three candidates, Council discussed the candidates. Clerk Jernigan suggested that the Council select 2 of the candidates as members and the 3rd as an alternate. Stuhan stated that there is no legal conflict of interest of having a Council Member's spouse because there is no financial compensation. Council Member Ahmann will still recuse herself.

Council members each gave their preference for the two candidates and alternates.
