Call to Order: The meeting was called to order by Mayor Luis Montoya followed by the Pledge of Allegiance.

New Business

Update regarding the town's USDA-RD Grant Application for the Wastewater Treatment Plant Improvement Project: Town Engineer, Chad Crockett, Bowman Consulting reported on the status of the Preliminary Engineering Report with regards to addressing issues or clarifications presented after review of the report by USDA Engineers. Approximately 90% of the comments have been addressed by Bowman Consulting.

The pending major issue is the location of the existing Wastewater Treatment Plant and floodplain requirements. The current WWTP is located in a 100- year floodplain however a new facility funded by USDA will been to be evaluated and protected from the 500-year event. Mr. Crockett further explained that the impact of this requirement would cause the new facility to be elevated approximately 10ft. However, he and USDA are still reviewing data to determine the most accurate information. Although possible, other considerations would be the additional cost to the project and the impact to the floodplain/floodway by elevating the site.

Mr. Crockett reported that he immediately started looking at alternate sites for the WWTP, but most available locations also bring challenges. Alternate locations included Table Top property; property formerly used as the town landfill as late as the 1970's; a ball field in Wards Canyon which also has floodplain issues and Freeport McMoRan property along Smelter Hill.

Council member Kovach suggested that the Greenlee County Engineer might have data from FEMA which may be helpful to obtain the necessary information to determine a more accurate elevation requirement.

Mr. Crockett assured the Council that he would continue to search for alternative locations while working on obtaining data from FEMA.
