**Call to Order**: The meeting was called to order by Mayor Luis Montoya followed by the Pledge of Allegiance.

**Call to the Public:** Greenlee County Economic Development Director, Akos Kovach provided information on the forthcoming events to include the AARP Drivers Course open to all ages and encouraged members of the Council to participate in the Growing Greenlee III scheduled for March 23, 2019.

Daniel Cervantez noted the recent retirement of Greenlee County Recorder, Berta Manuz and relayed information reported by Mr. Bill Harmon, Safford District Engineer Arizona Department of Transportation regarding the current temporary closure of Highway 191.

**Council Reports:** Council member Reyes noted an important Public Hearing on a zoning issue affecting Greenlee County.

Vice-Mayor Ahmann stated that she and Council member Reyes continue to lead the senior yoga group and find it a rewarding experience.

Council member Freida mentioned the recent change in ownership regarding the Family Dollar Store. He explained that he was curious about the ongoing construction and activity at the local facility and was informed that Dollar Tree had purchased the franchise. He expressed encouragement for the local economy due to the improvements being done.

Council member West provided information on the "Evening on Chase Creek" event hosted by Freeport McMoRan scheduled for March 27, 2019. The focus of the event is to highlight historic photos from the mining company's archives. **Manager's Report:** Interim Town Manager, Espie Castaneda reported on the following activities:

- Informed the Council of the recent Flood Siren Inspection results. Reported that the flood siren located at the Copper Crystal Park near the American Legion has NO power. The power was disconnected when Morenci Water & Electric abandoned the old power house/storage facility. Town currently working on establishing service to the siren
- Mentioned that the town's public works department has been working on cleaning out the exterior and interior of the Elk's Lodge property.
- Reported on town's efforts to continue sludge removal of the effluent pond in a more cost -effective method due to the unknown time frame of the WWTP.
- Briefed the council on the recent safety concern affecting Park Avenue due to the current rehabilitation project of the hotel in that area. Explained that Park Avenue had been closed off to both foot and vehicular traffic.
- Reported that Southwest Gas sub-contractor NPL continues gas line upgrades throughout town.

**Adjournment:** Motion to adjourn was made by Council member Reyes, second to the motion was made by Council member West. Motion carried.
