# Minutes Town of Clifton Regular Town Council Meeting September 12, 2019 2:00 P.M.

### **Members Present**

A quorum was present.

**Call to Order**: The meeting was called to order by Mayor Luis Montoya followed by the Pledge of Allegiance followed by a moment of silence in memory of the victims of the September 11, 2001 terrorist attack.

**Call to the Public:** Walt Mares, reporter for the GilaGerald.com news, informed the Council of the recent loss of a former Clifton Police Officer, Sandy Shotwell who was currently employed by the Town of Pima.

Leslie Ray, Visitor's Center Director expressed her thanks to the town council for the opportunity to attend the Arizona Governor's Conference on Tourism.

**Council Reports:** Council member Reyes reported that she and Vice-Mayor Ahmann continue to lead a yoga class for seniors. She is hopeful to encourage more participation.

Vice-Mayor Ahmann offered a summary of the events she attended during the 2019 League of Cities & Town's Conference. She reported that her participation in the Resolution's Committee was very informative as the group worked toward preparing legislation to present during the next legislative session. She also suggested that the town consider implementing a youth council which she feels may be beneficial to the future of our town. Finally, the Vice-Mayor thanked Council member Dorrell for her efforts to showcase our town during the conference.

Council member Dorrell set up the photo display she prepared for the conference and stated that she had received many positive comments from league participants who visited the booth. She also reported on the recent Gila Watershed Partnership River Cleanup along the San Francisco River.

## **Old Business:**

Discussion and/or action to award the bid for CDBG Contract #116-18: Construction Phase of the Removal of Architectural Barriers at the town's Community Center: Town Clerk, Espie Castaneda reported that NO bids had been received and explained that she had been in contact with the Arizona Department of Housing regarding the lack of response from potential contractors for the project. An additional attempt to solicit bids from contractors will begin once again in hopes of presenting a bid at the next Council meeting.

Motion to table the item was made by Council member Reyes; seconded by Council member Dorrell. Voting in favor of the motion were Council member Reyes, Dorrell, Freida, West, Ahmann and Montoya. Motion carried.

### **New Business:**

**Discussion and/or action to authorize the Mayor to execute a Proclamation declaring October 11, 2019 as Fred G. Acosta Job Corps Day:** Addressing the Council was Mr. Vaughn Croft accompanied by two active participants in the Job Corps Program. Mr. Croft explained that the program is celebrating 40 years of operation. He provided an overview of the program and invited the council to join the celebration on October 11, 2019. He also stated that all Proclamations will be on display during the event.

Second Reading of Ordinance No. 03-2019: An Ordinance Of The Common Council Of The Town Of Clifton, Arizona, Amending The Code Of Clifton Arizona, By Amending Title Iii Administration, Chapter 33 Purchasing, By Amending Section 33.09 Cooperative Purchasing, Related To Procurement Through Cooperative Purchasing; Providing For Repeal Of Conflicting Ordinances; Providing For Severability; And Providing Penalties: The Town Clerk read the title paragraph of the ordinance as required in the ordinance adoption process.

<u>Clifton Fire Department</u>: Luis Montoya, Chair; Shaun Seballos, Jacob Munoz, Elected from Membership; Delfina Pilgrim and Peter Ortega, Appointed Positions.

Motion to accept the amended Local Board Membership roster to the Public Safety Personnel System's Town of Clifton Fire Board and Police Board was made by Vice-Mayor Barbara Ahmann. Second to the motion was made by Council member Ray West.

Voting in favor of the motion was made by Council members' Ahmann, West, Dorrell, Freida, Reyes and Montoya. Motion carried.

- Informed the Council that a project kick-off meeting of the Chase Creek Tomorrow project was held on September 11, 2019.
- Explained that a web-casting vendor has been invited to make a presentation at a future meeting.
- Reported that the Chamber of Commerce is seeking a local representative and asked for suggestions.
