Council Member West asked how the rate was determined is the rate in the agreement comparable to the average going rate for effluent. Clerk Jernigan stated that while the rate was already agreed upon by both sides prior to her taking over discussions, she believes the agreement if fair and beneficial to the town. Vice-Mayor James asked how the funds received would be distributed. Clerk Jernigan informed that the monies will be put into the Sewer enterprise fund.

Jernigan updated the Council on the Town Manager search, the recruitment committee interviewed two candidates, originally the plan was to interview four candidates, however two cancelled near the last minute. The committee was impressed with both candidates interviewed and will be inviting both candidates to be interviewed by the Council.

The land exchange agreement has been finalized, the lift stations at both Paradise and Ward Canyon have been replaced and are operational. Construction will still be taking place on the exterior of the pump stations
