Tuition Policy

Tuition fees are due weekly/monthly depending on the program/schedule of your child. Fees are due every Monday. <u>Fees not</u> paid by Friday morning of the current week will incur a late fee of \$20.00.

If your account is more than 2 weeks behind your child will not be able to attend until the account is current.

Your tuition is what reserves your child's spot. Therefore, full fee is due regardless of holiday, illness, days off and building closures. Please remember that our school expenses continue when one or more children are absent.

Part-time children that need care on an <u>unscheduled</u> day may <u>pay for</u> <u>an additional day</u> if there is space available. We **do not allow children** to switch days. Mrs. Anne must approve all scheduling changes.

Building Closures

GEM will NOT ordinarily close for inclement weather, however, in severe weather situations you may wish to call before coming to be sure that staff have arrived. A minimum of two staff members must be present to open. If necessary, we will alert the following television, radio stations, the ProCare Connect app and our Grace Face book page for delays and closings.

If GEM closes for part or all day for severe weather, our policy states that we pay scheduled staff, therefore regular tuition is due.

- Communicate your child's absences and illnesses promptly via ProCare.
- Please send all supplies, extra clothes, etc., in a plastic bag for ease of drop off.
- Please send a message to your child's teacher via ProCare instead of relaying messages at carline as morning carline can be very hectic.
- Carline ends promptly at 9:30 A.M., if your child is not here by then we will assume they are not attending, unless you have communicated it to us in advance.

Illness, Communicable Diseases & COVID-19

If children become ill during the day, are vomiting, have a heavy nasal discharge/green in color, have two loose stools or a temperature of one hundred degrees or higher, we will notify parents to pick them up. **Keep children home if they have signs of the following:**

- have a fever or had a fever during the previous 24 hours
- have a heavy nasal discharge, or green in color
- have a constant cough
- seem overtired, fussy, cranky, not their usual selves
- have symptoms of a possible communicable disease, such as sniffles, red eyes, sore throat, headache, or abdominal pain, especially if accompanied by fever and/or spots
