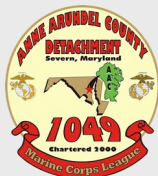

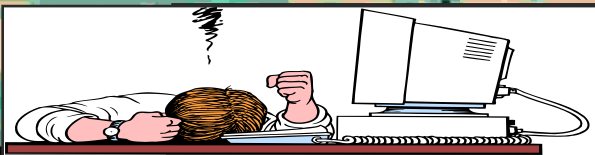

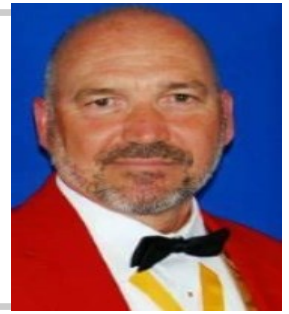

Corps History

4 January 1991

Marine helicopters evacuate 281 people from U.S. Embassy in Mogadishu, Somalia.

7 January 1969

Medal of Honor awarded posthumously to 1st Marine Division Chaplain, **Lt. V.R. Capodanno, U.S. Navy**, who was killed in action in Quang Tin Province, Vietnam on 4 September 1967.

8 January 1815

Marines, with Andrew Jackson's help, repulsed British forces at New Orleans.

9 January 2002

All seven Marine crewmen were killed when their KC-130R crashed near a forward operating base at Shamsi, Pakistan. Enemy ground fire was not suspected in the crash. These Marines of VMGR-352 were the first to die in the war on terrorism.

10 January 1995

2,600 U.S. Marines deployed to Somali (Operation United Shield) to assist in the final withdrawal of UN peace-keeping troops from Somalia.

18 January 1951

Marines of the 1st Marine Division begin mop-up operations against guerrillas in the Pohang, South Korea region, following their epic battle with Communist Chinese troops at the Chosin (Changjin Reservoir).

20 January 1968

The second battle for Khe Sanh began when Marines from the 3rd Battalion, 26th Marines attacked a North Vietnamese battalion between Hill 881 South and Hill 881 North.

22 January 1969

Operation Dewey Canyon began with the airlift of the 9th Marines and supporting artillery into the A Shau/ Da Krong Valleys.

25 January 1856

Marines and seamen from the **U.S.S. Decatur** went ashore at the village of Seattle, Washington, to protect settlers from Indian raids.

VA Can't Fix Backlogs, Can't Honor Veterans' Privacy

When it was reported that the VA Regional Office in St. Petersburg had a backlogged stack of mail totaling around 30,000 pieces, the VA inspector general launched an investigation to get to the bottom of it. To no one's surprise, the backlogged stack of mail actually totaled more than 41,900 pieces, and included at least 1,600 boxes of unprocessed veteran disability claims at a contracted scanning facility.

How did all these letters and documents end up in warehouses? A few years back, the VA began implementing a new paperless claims processing system to "modernize" the department and help the VA process veterans' claims more quickly. Interestingly enough, that system has run more than \$700 million over budget and the VA IG found that those costs had not resulted in any measurable improvement.

But who's counting, am I right?

Anyway, the VA contracted the digitizing process to a third party, which would scan these records into the system...where many of them today continue to wait for scanning. **So in the end, the VA managed to create more backlog...in the name of fixing the backlog.**

And if that isn't bad enough, it gets worse. Inspectors discovered the documents in the boxes were disheveled and disorganized, *"to say the least."* Documents with sensitive information were left in open spaces and occasionally mixed in with unrelated documents, making it confusing and all but impossible for employees to scan the documents, not to mention exposing numerous veterans' private medical information.

In fact, violating patient privacy is a popular hobby at the VA these days. [The Washington Examiner](#) reports that since 2011, **VA employees have violated the Health Insurance Portability and Accountability Act (HIPAA)**, the law establishing privacy protections for your medical information, over **10,000 times, making the VA the country's worst offender of patient privacy laws.** Visit a VA hospital and you may find your personal medical records have been accessed for no reason, been discussed on social media by a VA employee, or mailed to the wrong person.

The violations even extend to VA employees themselves. The same report states that records have been used in some cases to retaliate against whistleblowers. Who knows what atrocities the public hasn't been made aware of when a whistleblower keeps silent for fear their medical records will be released to the public.

Of course, the VA refuses to take responsibility. No surprises there. You can be a part of making them care, however. Call your senator now and urge him or her to support the [VA Accountability Act](#), which would enable the VA secretary to fire those employees responsible for backlogging claims and violating veterans' privacy. We need you in this with us.



TRICARE Pharmacy Copays to Increase:

Starting Feb. 1, copayments for brand name drugs through TRICARE Home Delivery will increase from \$16 to \$20 for up to a 90-day supply. At retail pharmacies, generic drug copays go from \$8 to \$10, and brand name drug copays go from \$20 to \$24, for up to a 30-day supply. Copays for non-formulary drugs and for drugs at non-network pharmacies will also change. All drugs obtained from military pharmacies, and generic drugs through TRICARE Home Delivery, will still be at no cost to beneficiaries. TRICARE officials say beneficiaries can save up to \$208 for every brand name prescription drug if they switch from a retail pharmacy to TRICARE Home Delivery

NEW PROTOCOL FOR ACTIVE DUTY MEMBERSHIP

- 1-All Active Duty Marines can now become regular members of the Marine Corps League for FREE,for the duration of their enlistment.
- 2-The Detachment will send a separate transmittal with all the Marines necessary information to include the join date (MCL) and the Marines end of enlistment date. The code will be H-AD. If the Marine reenlists,a transmittal will be sent to National (copy to the NJr Vice) stating the new end of enlistment date.
- 3-They will be issued a regular membership number with AD in front of it giving them all rights and privileges including voting and holding office.
- 4-The National Jr.Vice will print up a membership card with all the information and # and email it to the Detachment.The card will include the join date (MCL) and the end of enlistment date.
- 5-The Detachment WILL keep a separate list of all their Active Duty Members under this program.They will have all rights and privileges including voting and holding office.
- 6-The Detachment will also send a copy of the transmittal to the National Jr. Vice Commandant who will also keep a list of the Active Duty Marines.
- 7-The Detachment will be responsible to keep track of these Marines and keep them involved and interested by any means necessary.If the Active Duty Marine gets transferred to a new Duty Station the Detachment will work with the Marine to find him/her a new Detachment near their new Duty Station. It will then be handled like a regular transfer according to our By-Laws, that will include sending in a change of address. The National Jr. Vice will also be notified.
- 8-The Marine Corps will also be putting out the word to all Marine Corps installations regarding this new program.
- 9-The Detachment will also be responsible to give the Marine a Magazine.

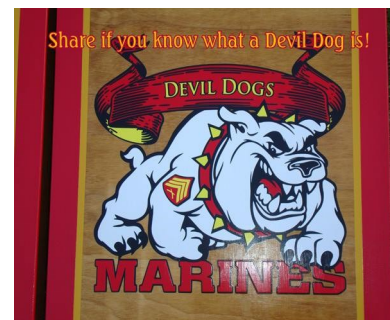

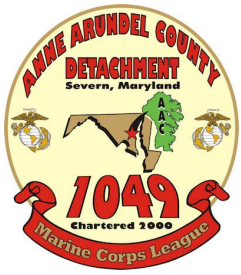
