House Of Representatives Approves Cost-Of-Living Increases

The House Representatives unanimously approved a bill July 22, 2004 that would increase the cost-of-living adjustment (COLA) for disabled veterans and surviving spouses and dependents receiving VA compensation. H.R. 4175, the Veterans Compensation Cost-of-Living Adjustment Act of 2004, would ensure that the amount of the increases would be the same as the percentage increase of Social Security payments. It would become effective December 2, 2004. According to the House VA Committee, some 2.5 million disabled veterans currently are receiving VA disability compensation, and 300,000 widows and surviving dependents receive dependency and indemnity compensation payments. If H.R.4175 is enacted. according to the Congressional Budget Office, the amount of disability compensation paid by VA to disabled veterans would raise by more than \$3 billion over the next five years. The bill also adds Osteoporosis to the list of diseases presumed to be service-connected for former POWs. The Senate VA Committee approved a similar bill, S 2483, on July 20, 2004, and directed that it be sent to the full Senate for a vote.

This Month in History

Selected November Dates of Marine Corps Historical Significance

- 1 November 1983: 300 Marines of the 22d Marine Amphibious Unit staged an amphibious and helicopter landing on the island of Carriacou, 15 miles northeast of Grenada, in a search for Cuban military installations or personnel. 17 Grenadian soldiers were captured, and arms, ammunition, and training sites were found. The next day the 22d MAU left the Caribbean area and proceeded to Beirut, Lebanon to replace the 24th MAU.
- 8 November 1990: President Bush announced that he planned to add more than 200,000 U.S. troops to those already deployed in Operation Desert Shield in the Persian Gulf area. The number of Marines in the area would be doubled by the addition of II MEF units from the Corps' east coast bases, and the 5th MEB from California. Within the next two months, Marine strength in the objective area would increase to nearly 90,000 Marines.
- 10 November 1921: This date marked the first formal commemoration of the birthday of the Marine Corps as 10 November. On 21 October 1921, Maj Edwin McClellan, OlC of the Historical Section, HQMC, sent a memo to MajGen Commandant John A. Lejeune, suggesting that the original birthday of 10 November 1775 be declared a Marine Corps holiday to be celebrated throughout the Corps. Accordingly, on 1 Nov 1921, Gen Lejeune issued Marine Corps Order No. 47 summarizing the history, mission, and tradition of the Corps, and directed that it be read to every command each 10 November.
- 13 November 1982: The Vietnam Veterans Memorial, containing the names of more than 13,000 Marines who lost their lives in Vietnam, was dedicated this date at the Memorial site in Washington, D.C. The dedication and parade that preceded it were part of a week-long National Salute to Vietnam Veterans.
- 17 November 1918: The 4th Marine Brigade, as part of the 2d Division, American Expeditionary Force, began its march to the Rhine River, passing through Belgium and Luxembourg, as part of the American forces occupying a defeated Germany.
- 20 November 1943: The 2d Marine Division, commanded by Major General Julian C. Smith, landed

on Betio Island, Tarawa Atoll, Gilbert Islands. After seventy-six hours of bitter fighting during which almost 1,000 Marines died, and more than 2,000 were wounded, MajGen Smith declared the island secure.

- **24 November 1992**: Marines lowered the flag at Subic Bay, U.S. Naval Facility, Republic of the Philippines, for the last time during ceremonies to turn over the facility to the government of the Philippines. The withdrawal ended almost a century of U.S. presence in that nation.
- 25 November 1968: The conclusion of Operation Lancaster II ended 10 months of action against the Viet Cong and North Vietnamese Army troops in the west-central sector of the demilitarized zone region. Over 1,800 enemy were killed, 42 captured, and 913 weapons seized during the operation.
- 27 November 1950: In a carefully planned assault, eight Chinese Communist divisions in Korea launched a massive attack which had as its expressed purpose, the destruction of the 1st Marine Division. This action led to the successful southward Marine Corps attack out of the Changjin (Chosin) Reservoir to the coastal port of Hungnam.





Honoring Our Medal of Honor Recipients





KENNETH L. WORLEY
Lance Corporal
United States Marine Corps
Medal of Honor — 1968
3/7/1 Vietnam

CITATION:

For conspicuous gallantry and intrepidity at the risk of his life above and beyond the call of duty while serving as a Machine Gunner with Company L, Third Battalion, Seventh Marines, First Marine Division in action against enemy forces in the Republic of Vietnam. After establishing a night ambush position in a house in the Bo Ban Hamlet of Quang Nam Province, security was set up and the remainder of the patrol members retired until their respective watch. During the early morning hours of 12 August 1968, the Marines were abruptly awakened by the platoon leader's warning that "Grenades" had landed in the house. Fully realizing the inevitable result of his actions, Lance Corporal Worley, in a valiant act of heroism instantly threw himself upon the grenade nearest him and his comrades. absorbing with his own body, the full and tremendous force of the explosion. Through his extraordinary initiative and inspiring valor in the face of almost certain death, he saved his comrades from serious injury and possible loss of life although five of his fellow Marines incurred minor wounds as the other grenades exploded. Lance Corporal Worley's gallant actions upheld the highest traditions of the Marine Corps and the United States Naval Service. He gallantly gave his life for his country.

HARRY LINN MARTIN
First Lieutenant
United States Marine Corps
Medal of Honor -- 1945
5/5/1 Iwo Jima

CITATION:

For conspicuous gallantry and intrepidity at the risk of his life above and beyond the call of duty as Platoon Leader attached to Company C, Fifth Pioneer Battalion, Fifth Marine Division, in action against enemy Japanese forces on Iwo Jima, Volcano Islands, 26 March 1945. With his sector of the Fifth Pioneer Battalion bivouac area penetrated by a concentrated enemy attack launched a few minutes before dawn, First Lieutenant Martin instantly organized a firing line with the Marines nearest his foxhole and succeeded, in checking momentarily the headlong rush of the Japanese. Determined to rescue several of his men trapped in positions overrun by the enemy, he defied intense hostile fire to work his way through the Japanese to the surrounded Marines. Although sustaining two severe wounds, he blasted the Japanese who attempted to intercept him, located his beleaguered men and directed them to their own lines. When four of the infiltrating enemy took possession of an abandoned machine-gun pit and subjected his sector to a barrage of hand grenades, First Lieutenant Martin alone and armed only with a pistol, boldly charged the hostile position and killed all its occupants. Realizing that his remaining comrades could not repulse another organized attack, he called to his men to follow and then charged into the midst of the strong enemy force, firing his weapon and scattering them until he fell, mortally wounded by a grenade. By his outstanding valor, indomitable fighting spirit and tenacious determination in the face of overwhelming odds, First Lieutenant Martin permanently disrupted a coordinated Japanese attack and prevented a greater loss of life in his own and adjacent platoons and his inspiring leadership and unswerving devotion to duty reflect the highest credit upon himself and the United States Naval Service. He gallantly gave his life in service of his country.

VA Issuing New ID Card section

(Taken from Armed Forces News Issue: Friday, November 12, 2004 – Item 9)

Because identity theft is the major fraud reported by Americans in 2003, the Department of Veterans Affairs has designed a new identity card for veterans that will safeguard confidential information. The card, known as the Veterans Identification Card, will have veterans' photos on the front and identify them as enrollees in the VA's health care system. The card includes the words "service connected" under the photo if the veteran has a serviceconnected disability. Veterans should request the new card at their local medical center. Processing will take five to seven days once eligibility is verified. The VA said it hopes to complete the conversion to the new card by mid-November. Existing cards will remain valid until veterans receive their new cards.

Alpha Co. Marine uses humor to boost morale

FORWARD OPERATING BASE ISKANDARIYAH, Iraq (Nov. 13, 2004) -- In an environment riddled with roadside bombs, suicide car bombers and raining rockets and mortars, Marines from the 24th Marine Expeditionary Unit can be forgiven an occasional bad mood.

But the leathernecks of Alpha Company, Battalion Landing Team 1st Battalion, 2nd Marines, have someone to boost their morale when times are tough - company jokester Pfc. Nicholas A. Cisek, a Brooksville, Fla., native and radio operator with 2nd Platoon, who tries to keep everyone's spirits high with his sense of humor.

"Cisek is definitely the company comedian and a very colorful guy," said 1st Sgt. Rodney Carrico, a Loogoote, Ind., native and the company first sergeant.

Throughout the company, Cisek is regarded as a source of laughter, sometimes even when he isn't trying to be funny. It may just be because of his random misfortune or his knack for getting singled out by senior Marines.

Lance Cpl. Andrew J. Abt, an Erie Penn., native, and a team leader recalled one particular inglorious moment.

"We walked out into a field and there was a creek, which was actually a disgusting cesspool," recalled Abt. "Everyone made it across fine, except poor little Cisek."

According to Abt, the platoon was in the field searching for a weapons cache when they came across the obstacle. Every other Marine had made it across, and Cisek was the last one on the other side. As he attempted to jump over it, he slipped and fell in the cesspool up to his waste. The platoon broke out with laughter.

"It was really nasty," said Abt. "But funny."

Such instances keep the atmosphere around Alpha Company a little lighter.

"Most of the time I try to be comic relief, but I know when to be serious," said Cisek. "I take the job more seriously than I did before, but when we get frustrated with things that don't make sense to us, I try to joke so that our morale stays high. After all, what we're doing has to make sense in the grand scheme of things or else we wouldn't be doing it."

His sense of humor has helped lift the spirits of his platoon mates on many occasions, especially one night in August when they earned the nicknamed the "walking dead." That night his platoon was hit by four improvised explosive devices and three separate mortar attacks. Several Marines were wounded.

Since arriving in Iraq, Cisek and his platoon have taken part in daily patrols and several missions leading to the capture of Iraqi insurgents.

Despite the hazards, Cisek is surprised he isn't more miserable.

"This is definitely not what I expected," said Cisek. "I expected to be sitting in a fighting hole in the defense. What I got was a tent with a wooden floor, air conditioning and a humvee to ride around in."

Now beginning his third year in the Marine Corps, Cisek expects to be returning to Iraq before the end of his first enlistment.

"After that, my travel agent is so fired," Cisek joked. "No, I'm just kidding, I know why we're here and I'm glad I can do what I can to make Iraq a better place for Its people. I just wish we could do more."
