July/August Dates in Marine Corps History



1 July 1920 – MajGen John A. Lejeune became the 13th Commandant of the Marine Corps

4 July 1800 – The Marine Corps Band played at Tun Tavern, Philadelphia, in their first public appearance.

11 July 1798 – The U.S. Marine Corps was re-established by an Act of Congress, succeeding the Continental Marines.

18 July 1918 – The 4th Marine Brigade sustained 1,972 casualties in the first two days of battle in an attack near Soissons, France.

26 July 1947 – The National Security Act of 1947 became effective, reaffirming the status of the Marine Corps as a separate military service within the Department of the Navy. The Act Provided for Fleet Marine Forces, and confirmed the Corps' mission of seizing and defending advanced bases, as well as land operations incident to naval campaigns.

28 July 1918 – BGen John A. Lejeune assumed command of the 2d Army Division in France, and remained in that capacity until August 1919. He was the first Marine officer to hold an Army divisional command, and following the Armistice, he led his division in the march into Germany.

6 August 1847 – LtCol S.E. Watson's Marines commenced their march on the "Halls of Montezuma" in Mexico.

7 August 1953 – SSgt Barbara Barnwell was the first woman Marine awarded the Navy and Marine Corps Medal for heroism.

12 August 1918 – The Secretary of the Navy authorized the enlistment of women in the Marine Corps.

19 August 1919 – "The Marines' Hymn" was registered with the U.S. Copyright Office.

Honoring Our Medal of Honor Recipients



RICHARD A. ANDERSON
LANCE CORPORAL
United States Marine Corps

CITATION:

For conspicuous gallantry and intrepidity at the risk of his life above and beyond the call of duty while serving as an Assistant Fire Team Leader with Company E, Third Reconnaissance Battalion, Third Marine Division, in connection with combat operations against an armed enemy in the Republic of Vietnam. While conducting a patrol during the early morning hours of 24 August 1969, Lance Corporal Anderson's reconnaissance team came under a heavy volume of automatic weapons and machine-gun fire from a numerically superior and well-concealed enemy force. Although painfully wounded in both legs and knocked to the ground during the initial moments of the fierce fire fight, Lance Corporal Anderson assumed a prone position and continued to deliver intense suppressive fire in an attempt to repulse the attackers. Moments later he was wounded a second time by an enemy soldier who had approached to within eight feet of the team's position. Undaunted, he continued to pour a relentless stream of fire at the assaulting unit, even while a companion was treating his legs wounds. Observing an enemy grenade land between himself and the other Marine, Lance Corporal Anderson immediately rolled over and covered the lethal weapon with his body, absorbing the full effects of the detonation. By his indomitable courage, inspiring initiative, and selfless devotion to duty, Lance Corporal Anderson was instrumental in saving several Marines from serious injury or possible death. His actions were in keeping with the highest traditions of the Marine Corps and of the United States Naval Service. He gallantly gave his life in the service of his country.

CITATION:

For conspicuous gallantry and intrepidity at the risk of his life above and beyond the call of duty while serving as a Rifleman with Company F, Second Battalion, Seventh Marines, First Marine Division (Reinforced), in action against enemy aggressor forces in Korea on 28 November 1950. When all other members of his fire team became casualties, creating a gap in the lines, during the initial phase of a vicious attack launched by a fanatical enemy of regimental strength against his company's hill position, Private Cafferata waged a lone battle with grenades and rifle fire as the attack gained momentum and the enemy threatened penetration through the gap and endangered the integrity of the entire defensive perimeter. Making a target of himself under the devastating fire from automatic weapons, rifles, grenades and mortars, he maneuvered up and down the line and delivered accurate and effective fire against the onrushing force, killing fifteen, wounding many more and forcing the others to withdraw so that reinforcements could move up and consolidate the position. Again fighting desperately against a renewed onslaught later that same morning when a hostile grenade landed in a shallow entrenchment occupied by wounded Marines, Private Cafferata rushed into the gully under heavy fire, seized the deadly missile in his right hand and hurled it free of his comrades before it detonated, severing part of one finger and seriously wounding him in the right hand and arm. Courageously ignoring the intense pain, he staunchly fought on until he was struck by a sniper's bullet and forced to submit to evacuation for medical treatment. Stouthearted and indomitable, Private Cafferata, by his fortitude, great personal valor and dauntless perseverance in the face of almost certain death, saved the lives of several of his fellow Marines and contributed essentially to the success achieved by his company in maintaining its defensive position against tremendous odds. His extraordinary heroism throughout was in keeping with the highest traditions of the United States Naval Service.

Jones, was tragically slain at his place of business including his boss. Mike evidently walked into the company in which he worked early Thursday morning and witnessed 2 men committing a robbery on his boss. He was immediately shot and his boss was shot also. Neither survived. Witnesses observed 2 white men fleeing the business at the time of the crime. Police are still investigating. Our condolences go out to the family.

I also would like to extend our thanks to those of you who attended Marine services on such short notice at Kirkley-Ruddick Funeral Home Tuesday 13 July in honor of Marine Robert Lee Deaton, Sr, 68, formerly of Glen Burnie and had been living in DE the past few years. Bob was a coach for Harundale Little League and Rebels football and basketball teams for several years before moving to DE. The family also requested Marine Corps League Services at the gravesite at Meadowridge Memorial Park, Jessup. Marines George Martin and Guy Hall attended the funeral and burial. George played taps on our new bugle and Guy presented the American Flag to Marine Deaton's wife Barbara Ann. The family made a substantial donation to Community Lutheran Church of Frankford, DE. in memory of MCL #1049.

The U. S. Marine Corps Reserve Toys for Tots Program is an official activity of the U. S. Marine Corps and an official mission of the U.S. Marine Corps Reserve. The Commandant of the Marine Corps, in Marine Corps Order

5726.14E, delegated management authority and responsibility for the Program to the Commander, Marine Forces Reserve. The Commander of the reserves has delegated to the President, Marine Toys for Tots Foundation, authority and responsibility for the disposition of all donated funds.

The Toys For Tots Foundation was named Outstanding Nonprofit Organization of the Year for 2003 (DMA Nonprofit Federation), was selected as one of ten charities on the 2003 "Gold Star" list (Forbes), the #1 Children's Charity of 2003 (Reader's Digest), and the #9 of Top 100 Toy Websites in 2003 (Starburst).

This recognition was no doubt earned by the Commandant's Marine Corps Order requiring reserve unit to associate themselves only with groups and volunteers who bring credit upon and exemplify the spirit of the Marine Corps and the Program. Marine Corps Reserve Unit and Toys for Tots Coordinators are to consider disassociating individuals or groups from participation or terminating campaigns of people who do not conduct themselves in an acceptable manner. Donors are to be encouraged to contribute new unwrapped toys. Marines may not solicit cash donations but unsolicited cash donations may be accepted and forwarded to the Foundation in accordance with strict accountability instructions set forth in the Marine Corps Order. Toy distribution is to be coordinated with local agencies and churches to ensure equitable toy distribution.

With thousands of commuters traveling back and forth to Washington, D.C. every day, no doubt we will experience a boost in toy collections from this new source. 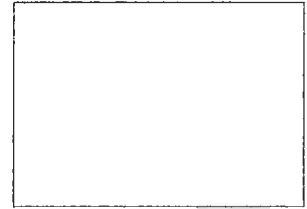
