According to J. Robert Moskin, a noted military historian states that following its great triumphs of WW II, the Marine Corps should have been riding high. Less than 5 years, between the surrender in Tokyo Bay and the North Korean attack across the 38th Paralell the Corps wrestled with a few problems. For the first half of this short period, Marine Corps problems had to be solved by Commandant Alexander A. Vandergrift, the hero of Guadalcanal who in April 1945 had become the first 4-star general of active duty in the history of the Corps. Trying to get the men home after V-J Vandergrift's was in "torrential." In all the services, demonstrations erupted among the civilians in uniform demanding to go home. On 10 Jan 46 a delegation of noncoms delivered a petition to Lt. Gen. Roy Geiger in Hawaii, he broke all of them to privates and h ad his SGT. rip off their chevrons. **MAJOR** Vandergrift wrote Geiger that demonstration "to an old-line Marine still borders on near mutiny."

After WW II the marine corps strength had shrunk from a wartime peak of 485,000 men and women to 156,000 and by Feb 48 was down to 92,000.

One of the first lessons taught to new recruits is proper wear of the uniform and its insignia. The same principle applies to the wearing of military awards by veterans and retirees. There are a number of occasions when tradition, patriotism, ceremonies and social occasions call for the wear of military awards.

Civilian Dress

The most common manner of wearing a decoration or medal is as a lapel pin, in the left lapel of a civilian suit jacket. The small enameled lapel pin represents the ribbon bar of a single decoration or ribbon an individual has received (usually the highest award or one having special meaning to the weater. Many well-known veterans such as former Senator Bob Dole, a World War II Purple Heart recipient,



wear a lapel pin. Pins are available for all awards and some ribbons such as the Combat Action Ribbon or the Navy Presidential

Unit Citation. A small Marine Corps insignia and miniature wings are also worn in the lapel or as a tie tac. Additionally, retirees are encouraged to wear their USMC retired pin and World War II veterans are encouraged to wear their Honorable Discharge Pin (affectionately referred to as the "ruptured duck").

Honorably discharged and retired Marines may wear full-size or miniature medals on civilian suits on appropriate occasions such as Memorial Day and Armed Forces Day. It is not considered appropriate to wear marksmanship badges on civilian attire.

Wearing of Medals, Insignia and the Uniform by Veterans and Retirees

Formal Civilian Wear

For more formal occasions, it is correct and encouraged to wear miniature decorations and medals. For a black or white tie occasion, the rule is quite simple: if the lapel is wide enough wear the miniatures on the left lapel or, in the case of a shawl lapel on a fuxedo, the miniature medals are worn over the left breast pocket. The center of the holding bar of the bottom row of medals should be parallel to the deck immediately above the pocket. Do not wear a pocket handkerchief.

Miniature medals can also be worn on a civilian suit at veterans' functions, memorial events, formal occasions and social functions of a military nature.

Uniform

On certain occasions retired Marine Corps personnel may wear either the uniform prescribed at the date of retirement or any of the current active duty authorized uniforms. Retirees should adhere to the same grooming standards as Marine Corps active duty personnel when wearing the uniform (for example, a beard is inappropriate while in uniform). Whenever the uniform is worn, it must be done in such a manner as to reflect credit upon the individual and the corps. (Do not mix uniform items.)

The occasions for wear by retirees are:

- military ceremonies.
- military funerals, weddings, memorial services and inaugurals.
- patriotic parades on national holidays.
- military parades in which active or reserve units are participating.
- educational institutions when engaged in giving military instruction or responsible for military discipline.
- social or other functions when the invitation has obviously been influenced by the members having at one time been on active service.

Honorably separated wartime veterans may wear the uniform authorized at the time of their service.

The occasions are:

- military funerals, memorial services, and inaugurals.
- patriotic parades on national holidays.
- · any occasion authorized by law.
- military parades in which active or reserve units are participating.

Non-wartime service personnel separated (other than retired and Reserve) are not authorized to wear the uniform but may wear their medals.
