Are you prepared if a hurricane struck in this region? Do you have disaster supply kit, if not listed below is recommendations for contents.

Water- at least 1 gallon daily per person for 3 to 7 days.

Food- at least enough for 3 to 7 days.

- non– perishable packaged or canned food / juices
- Food for infants or the elderly
- Snack foods
- Non– electric can opener
- Cooking tools / fuel
- Paper plates / plastic utensils

Blankets / pillows, etc.

Clothing—seasonal / rain gear / sturdy shoes

First Aid Kit / Medicines / prescription Drugs

Special Items— for babies and the elderly

Toiletries / Hygiene items / Moisture wipes

Flashlight / Batteries

Radio — Battery operated and NOAA weather radio

Cash — Banks and ATMs may not open or available for extended periods.

Bill Targets Fake Heroes

(Armed Forces News Friday, August 05, 2005)

Rep. John Salazar, D-Colo., has introduced "The Stolen Valor Act of 2005," which would authorize authorities to prosecute individuals who falsely claim to rate military decorations, medals, or badges. The bill would close a loophole in the law that currently only allows prosecution against a person who actually wears an unauthorized medal.

The bill would set fines and imprisonment of up to six months, or both, for anybody who falsely claims verbally or in writing to have been awarded a decoration or medal authorized by Congress for the armed forces. Unauthorized ribbons, buttons and rosettes are included in the bill.

Fines would rise and maximum prison terms would be doubled to one year for offenders who falsely claim to have earned a Distinguished Service Cross, Air Force Cross, Navy Cross, Silver Star or Purple Heart.

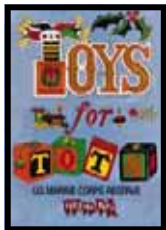

TOYS FOR TOTS 2005,

2005 IN 2005



For those of you who attended our August meeting you already know the National Toys for Tots report declared the 2004 campaign a tremendous success across the country. There were 19,030,679 toys collected and distributed to 7,543,984 needy children. Of those, the Marine Corps League contributed 1,923,533, not counting 175 Detachments totals like our 1849 toys that went to support the Marine Corps/Reserve unit at Ft. Meade because they were included in their total.

Seems a few Detachments needed a little guidance from National to get their program into compliance, but not ours. We were 100% in compliance. Importantly the \$2000 we raised went directly to the USMC Reserve unit and the foundation. National encourages everyone to remember that the program is for the kids, not the grown ups - so act it. Our relationships with Marine units, the public and sponsors must be responsible. In order to see toys go for the needy not the greedy, all T4T toys are distributed through Social Services, Salvation Army or other generous organizations that have the pulse of the community.

One major disaster was averted. A detachment lost their toys in a warehouse fire, but thanks to the community and the Marine Unit, more toys were purchased and distributed than originally collected.

In 2004 72 corporate sponsors donated \$32 million, including such names as American Express, Bank One, Daimler-Chrysler, KB Toys, Northwest Airlines, Wells Fargo and Walt Disney. The T4T foundation is listed as #1591 in the Combined Federal Campaign (CFC).

Our August meeting included an open discussion of our

options this year considering the Marines at Ft. Meade we supported last year are now in Iraq and the Marines at the Naval Academy will not be conducting a T4T campaign. My sense, and that of the other Detachment officers is that we lack the resources to conduct an independent campaign and instead need to support a Marine unit like we did last year.

I recently checked with the foundation as was told they have appointed SSGT Ransom of an active duty Marine Corps unit at Ft. Meade as coordinator for this area. Our plan now is to support their operation.

Our plan is the same as last year, we will hold toys drives at our October and November meetings and at MUVICO in Arundel Mills Mall on the Saturday of the Thanksgiving weekend, November 26th, and two weeks later on December 10th. We do not yet confirmation from MUVICO, but plan on it anyway. We are also waiting to hear from Marley Station Mall about holding a toy drive there as well. We look forward to seeing our events promoted with the help of Millennium Cable this year. We'll have these on the calendar of events on our webpage to help everyone remember.

We raised 1849 toys last year, let's try to better that. Let's raise 2005 IN 2005!

Detachment Five Man Pistol Team Wins Two Trophies at Harrisburg Hunters & Anglers "Walt Wise Memorial Police Pistol Match" September 17-18, 2005 (Harrisburg, PA) The detachment's five-man pistol team won third place "A-Class" with the .22 caliber pistol and first place "B-Class" in center fire (.32 Caliber or larger) on September 18, 2005 at the Harrisburg Hunters & Anglers "46th Annual Walt Wise Memorial Police Pistol Match" in Harrisburg, PA. The .22 caliber third place score was 1460-61x (1500-150x possible) while the center fire score was 1423-52x. Five man team members included: Rear, left to right: Marine Denny Bynum, Civ. Gary Wentworth, Assoc. Member Ted Keys. Front, left to right: Assoc. Member Ed Grove and Marine Mike Hadley. Congratulations and Good Shooting.

.Marines Denny Bynum and Mike Hadley also shot the .22 and center fire two-man teams matches. They scored second place "B-Class" with the .22 and fourth place "B-Class" with center fire. The .22 scores were 585-21x (600-60x possible) while the center fire score was 558-19.

The match was open to civilians, police, and military personnel. It was shot rain or shine. All firing was done at 25 yards using the Lewis classification system. A course of fire consisted of 20-rounds slow fire, 30-rounds Police-L course, 20-rounds timed fire and 20-rounds rapid fire (90-rounds total). Each competitor fired two courses of fire with the .22 caliber pistol and two courses of fire with a center fire pistol. This was a "NO ALIBIS" match. The only exception is when a competitor has fired on an opponent's target. In this case the contestant will have the shots scored as misses and the person having the excess of ten shots may re-fire or take the ten lowest shots. Good Shooting everyone! Remember, keep your powder dry and favor the center.

VA SURVIVING SPOUSE WEBSITE:

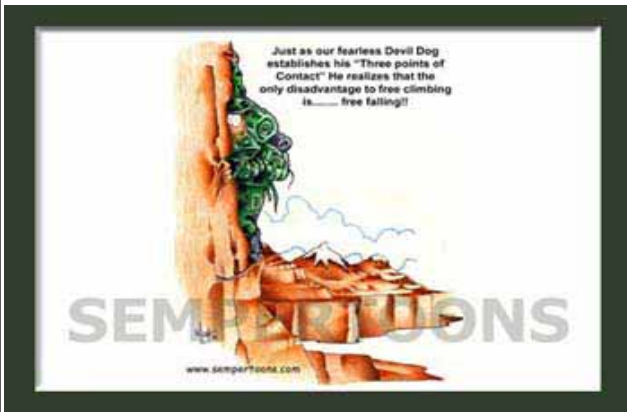
