## 2005 Distinguished Marines Postage Stamps & Marine Corps Silver Dollar

In January of this year, the Marine Corps League entered into an agreement with Unicom Corporation to sponsor and distribute an Official Collection of collectible products as a tribute to the United States Marine Corps in conjunction with the issuance of the 2005 U.S. Distinguished Marines Postage Stamps and the 2005 U.S. Marine Corps Silver Dollar.

We recently received word from the United States Postal Services that they have delayed issuing the Distinguished Marine stamp issues until November 2005 in order to coincide with the Marine Corps

### **This Month in History**

#### ***Selected Dates of Marine Corps Historical Significance***

**3 April 1945:** On Okinawa, Marines of the III Amphibious Corps continued to make good progress all along their front, clearing Zampa Misaki and seizing the Katchin Peninsula, thus effectively cutting the island in two. By this date (D+2), III AC elements had reached objectives thought originally to require 11 days to take.

**5 April 1947:** Five Marine guards were killed and eight wounded when attacked by Communist Chinese raiders near the Hsin Ho ammunition depot in Northern China. This last major clash between Marines of the 1st Marine Division and Communist forces occurred shortly after withdrawal and redeployment plans from China were issued for the 1st Division and 1st Marine Aircraft Wing on 1 April.

**10 April 1959:** Lieutenant Colonel John H. Glenn, Jr. was named as one of the original seven Project Mercury astronauts selected for space training. The seven astronauts, all volunteers, were selected by NASA from an initial group of 110 leading military test pilots. Three years later, on 20 February 1962, Col Glenn would become the first American to orbit the Earth.

**12-13 April 1918:** Marines of the 4th Brigade suffered their first gas attack on the night and early morning hours of 12-13 April when the Germans bombarded the 74th Company, 6th Marines near Verdun with mustard gas. Nine Marine officers and 305 enlisted Marines were gassed and evacuated, and 30 Marines died from the effects of the gas shells which hit in the middle of the reserve area cantonments in which they were sleeping.

**15 April 1962:** Marine Corps operational involvement in the Vietnam War began on Palm Sunday when HMM-362 with its Sikorsky UH-34s arrived at Soc Trang in the Delta south of Saigon. The task unit was called "Shufly" and

its first operational employment involved lifting Vietnamese troops into battle.

**18 April 1983:** One Marine Security Guard was killed and seven were wounded when a large car bomb exploded just outside the U.S. Embassy in Beirut, Lebanon. Lance Corporal Robert McMaugh was standing guard at Post 1, just inside the front entrance when the bomb exploded outside the door. The explosion killed 61 people including 17 Americans. LCpl McMaugh was buried at Arlington National Cemetery on 26 April.

**21 April 1951:** Marine carrier-based airplanes made their first aerial contact with enemy planes over the Korean front lines. Captain Philip C. DeLong shot down two YAK fighters and 1st Lieutenant Harold D. Daigh destroyed one more and damaged another in the heavily defended Pyongyang-Chinnanpo area. Both pilots were with VMF-312 flying from the USS Bataan.

**27 April 1805:** First Lieutenant Presley N. O'Bannon, who with seven other Marines was part of a force of Greeks and Arabs led by American Consul William Eaton, raised the United States flag for the first time over a conquered fortress of the Old World at Derne, a stronghold of the Tripolitan pirates. Two Marines were killed and one wounded in the assault on the walled city.

**28 April 1993:** The last A-6E Intruder departed from Marine Corps service. Marine All Weather Attack Squadron 332 transferred the last Marine A-6E to St. Augustine, Florida, and prepared for the squadron's transition to the F/A-18D and eventual movement from Cherry Point to Beaufort, South Carolina.

# Honoring Our Medal of Honor Recipients



**Hershel W. Williams**  
**Corporal**  
**United States Marine Corps**  
**Reserve**  
*Medal of Honor — 1945*  
*1/21/3 Iwo Jima*  
**CITATION:**

For conspicuous gallantry and intrepidity at the risk of his life above and beyond the call of duty as Demolition Sergeant serving with the First Battalion, Twenty-First Marines, Third Marine Division, in action against enemy Japanese forces on Iwo Jima, Volcano Island, 23 February 1945. Quick to volunteer his services when our tanks were maneuvering vainly to open a lane for the infantry through the network of reinforced concrete pill-boxes, buried mines and black, volcanic sands, Corporal Williams daringly went forward alone to attempt the reduction of devastating machine-gun fire from the unyielding positions. Covered only by four riflemen, he fought desperately for four hours under terrific enemy small-arms fire and repeatedly returned to his own lines to prepare demolition charges and obtain serviced flame throwers, struggling back, frequently to the rear of hostile emplacements, to wipe out one position after another. On one occasion he daringly mounted a pillbox to insert the nozzle of his flame thrower through the air vent, kill the occupants and silence the gun; on another he grimly charged enemy riflemen who attempted to stop him with bayonets and destroyed them with a burst of flame from his weapon. His unyielding determination and extraordinary heroism in the face of ruthless enemy resistance were directly instrumental in neutralizing one of the most fanatically defended Japanese strong points encountered by his regiment and aided in enabling his company to reach its' objective. Corporal Williams' aggressive fighting spirit and valiant devotion to duty throughout this fiercely contested action sustain and enhance the highest traditions of the United States Naval Service.

*1/7/1 Vietnam*  
**CITATION:**

For conspicuous gallantry and intrepidity at the risk of his life above and beyond the call of duty while serving as a squad leader with Company D, First Battalion, Seventh Marines, First Marine Division, in connection with operations against the enemy in the Republic of Vietnam. On the evenings of 20-21 December 1967, Corporal Smedley led his six-man squad to an ambush site at the mouth of Happy Valley, near Phouc Ninh (2) in Quang Nam Province. Later that night, an estimated 100 Viet Cong and North Vietnamese Army Regulars, carrying 122 mm rocket launchers and mortars, were observed moving toward Hill 41. Realizing this was a significant enemy move to launch an attack on the vital Danang complex, Corporal Smedley immediately took sound and courageous action to stop the enemy threat. After he radioed for a reaction force, he skillfully maneuvered his men to a more advantageous position and led an attack on the numerically superior enemy force. A heavy volume of fire from an enemy machine gun positioned on the left flank of the squad inflicted several casualties on Corporal Smedley's unit. Simultaneously, an enemy rifle grenade exploded nearby, wounding him in the right foot and knocking him to the ground. Corporal Smedley disregarded this serious injury and valiantly struggled to his feet, shouting words of encouragement to his men. He fearlessly led a charge against the enemy machine gun emplacement, firing his rifle and throwing grenades until he was again struck by enemy fire and knocked to the ground. Gravely wounded and weak from loss of blood, he rose and commenced a one-man assault against the enemy position. Although his aggressive and single-handed attack resulted in the destruction of the machine gun, he was struck in the chest by enemy fire and fell mortally wounded. Corporal Smedley's inspiring and courageous actions, bold initiative, and selfless devotion to duty in the face of certain death were in keeping with the highest traditions of the Marine Corps and the United States Naval Service. He gallantly gave his life for his country.

The Kitchen Table Gang also has a nationally recognized educational program for our young people and students, teaching them the history, traditions and respect for our national emblem.

## The Marine Corps has addressed a major oversight in the way it trains recruits to render honors to colors while in civilian attire.

For years, drill instructors at Marine Corps Recruit Depot Parris Island, S.C., and MCRD San Diego, guided by an errant drill manual, have taught new recruits to stand at the position of attention during the national anthem and morning and evening colors when not in uniform. Both U.S. Navy and Marine Corps regulations require service members in civilian attire to stand at attention with the right hand placed over the heart. Gentlemen who are covered must also remove their headdress and hold it at the left shoulder so that the right hand is over the heart.

Sgt. Maj. Ralph H. Drake, Training and Education Command sergeant major, said the Corps is moving quickly to correct its mistake with an amended drill manual.

"For years our method of rendering honors to colors while in civilian attire has not been in accordance with the U.S. Code, Title 36, the U.S. Navy Regulations or our Marine Corps Flag Manual," said Drake. "These all called for placing the right hand over the heart vice just standing at attention. Our new Drill and Ceremonies Order P5060.1 is now in compliance. (Marine Corps Recruit Depot) Parris Island has already modified their lesson plans on this and [MCRD] San Diego is following suit. (Drill Instructor) schools will also make the appropriate change."

Additionally, U.S. Navy Regulations 1990, paragraph 1207.3, provides guidance for sea service members in civilian attire when passing colors.

"Each person in the naval service in uniform, upon being passed by or passing a military formation carrying the national ensign uncased shall render a hand salute. A member not in uniform being passed by or passing such a formation shall face the flag and stand at attention with the right hand over the heart. If covered, men shall remove the headdress and hold it at the left shoulder, the hand being over the heart."

David Rumley has been assigned to: 1st Battalion 5th Marines, Camp Pendleton, CA; Ammunition Company, 4th Supply Battalion, 4th Field Service Support Group, Greenville SC; Ammunition Company, 2nd Supply Battalion, 2nd Field Service Support Group, Camp Lejuene, NC; Hotel Battery, 3rd Battalion 10th Marine Regiment, 2nd Marine Division, Camp Lejuene, NC (while with them his unit was deployed to Northern Iraq in support of Desert Storm participating in "Provide Comfort" and "Hammer Anvil"; then was deployed to Guantanamo Bay in support of "Safe Harbor"); Headquarters and Support Battalion, Camp Fuji, Japan; Headquarters and Support Battalion, 1st Supply Battalion, 1st Field Service Support Group, Camp Pendleton, CA; his final duty station was Marine Corps Recruit Depot, Parris Island, SC.

David Rumleys' personal military decorations include: Navy and Marine Corps Achievement, Joint Meritorious Unit Commendation, Navy Unit Commendation, Marine Unit Commendation, Marine Corps Good Conduct, Southwest Asia Service, Humanitarian Service, Navy & Marine Corps Overseas Service, Marine Corps Drill Instructor, Kuwait Liberation.

After leaving the military, David Rumley attended College at Eastern Michigan University where he earned a Bachelor of Science Degree. He has worked as Loan Officer, Manager for a Law Firm and a Defense Contractor in Saudi Arabia.
