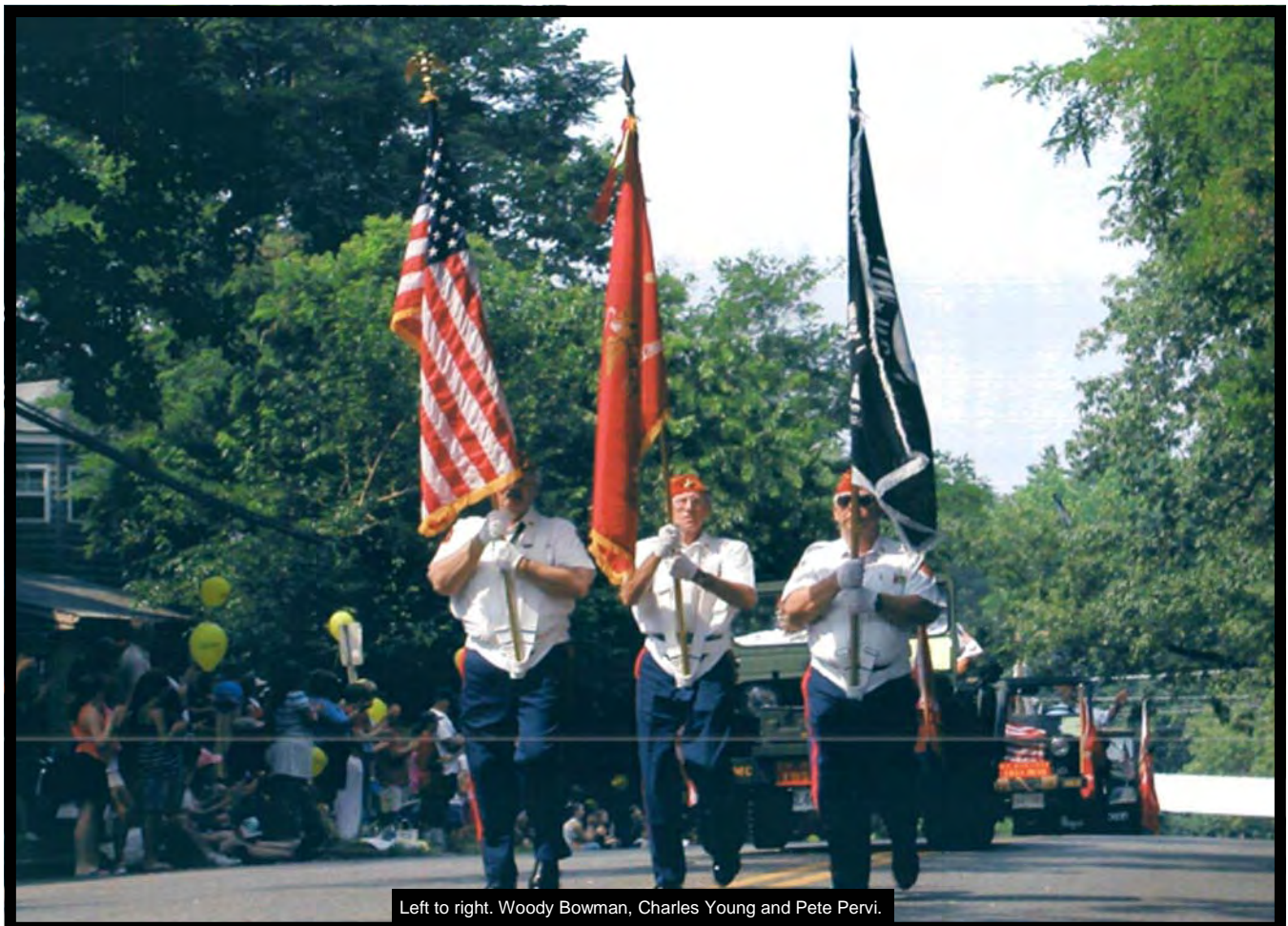

This Month in History

Selected November Dates of Marine Corps Historical Significance

1 November 1983: 300 Marines of the 22d Marine Amphibious Unit staged an amphibious and helicopter landing on the island of Carriacou, 15 miles northeast of Grenada, in a search for Cuban military installations or personnel. 17 Grenadian soldiers were captured, and arms, ammunition, and training sites were found. The next day the 22d MAU left the Caribbean area and proceeded to Beirut, Lebanon to replace the 24th MAU.

8 November 1990: President Bush announced that he planned to add more than 200,000 U.S. troops to those already deployed in Operation Desert Shield in the Persian Gulf area. The number of Marines in the area would be doubled by the addition of II MEF units from the Corps' east coast bases, and the 5th MEB from California. Within the next two months, Marine strength in the objective area would increase to nearly 90,000 Marines.

10 November 1921: This date marked the first formal commemoration of the birthday of the Marine Corps as 10 November. On 21 October 1921, Maj Edwin McClellan, OIC of the Historical Section, HQMC, sent a memo to MajGen Commandant John A. Lejeune, suggesting that the original birthday of 10 November 1775 be declared a Marine Corps holiday to be celebrated throughout the Corps. Accordingly, on 1 Nov 1921, Gen Lejeune issued Marine Corps Order No. 47 summarizing the history, mission, and tradition of the Corps, and directed that it be read to every command each 10 November.

13 November 1982: The Vietnam Veterans Memorial, containing the names of more than 13,000 Marines who lost their lives in Vietnam, was dedicated this date at the Memorial site in Washington, D.C. The dedication and parade that preceded it were part of a week-long National Salute to Vietnam Veterans.

17 November 1918: The 4th Marine Brigade, as part of the 2d Division, American Expeditionary Force, began its march to the Rhine River, passing through Belgium and Luxembourg, as part of the American forces occupying a defeated Germany.



20 November 1943: The 2d Marine Division, commanded by Major General Julian C. Smith, landed on Betio Island, Tarawa Atoll, Gilbert Islands. After seventy-six hours of bitter fighting during which almost 1,000 Marines died, and more than 2,000 were wounded, MajGen Smith declared the island secure.

24 November 1992: Marines lowered the flag at Subic Bay, U.S. Naval Facility, Republic of the Philippines, for the last time during ceremonies to turn over the facility to the government of the Philippines. The withdrawal ended almost a century of U.S. presence in that nation.

25 November 1968: The conclusion of Operation Lancaster II ended 10 months of action against the Viet Cong and North Vietnamese Army troops in the west-central sector of the demilitarized zone region. Over 1,800 enemy were killed, 42 captured, and 913 weapons seized during the operation.

27 November 1950: In a carefully planned assault, eight Chinese Communist divisions in Korea launched a massive attack which had as its expressed purpose, the destruction of the 1st Marine Division. This action led to the successful southward Marine Corps attack out of the Changjin (Chosin) Reservoir to the coastal port of Hungnam.

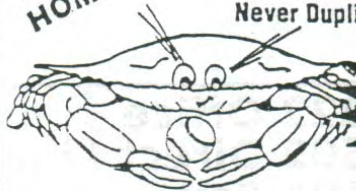

Honoring Our Medal of Honor Recipients



John Henry Balch
Pharmacists' Mate 1st Class
United States Navy
Medal of Honor — 1918
France
CITATION:

For gallantry and intrepidity at the risk of his life above and beyond the call of duty, with the 6th Regiment, U.S. Marines, in action at Vierzy, on 19 July 1918. Balch unhesitatingly and fearlessly exposed himself to terrific machinegun and high-explosive fire to succor the wounded as they fell in the attack, leaving his dressing station voluntarily and keeping up the work all day and late into the night unceasingly for 16 hours. Also in the action at Somme-Py on 5 October 1918, he exhibited exceptional bravery in establishing an advanced dressing station under heavy shellfire.

On 19 August 1919, Balch was honorably discharged as a Pharmacist's Mate First Class. One-month later, Rear Admiral F. B. Bassett presented the Medal of Honor to him at the YMCA in Chicago, Illinois. On 2 September 1942, Balch rejoined the Navy as a lieutenant and served in the United States, Australia and the Philippines before retiring on 1 June 1950 from the Naval Reserve as a commander.

In addition to the Medal of Honor, Balch also received the Distinguished Service Cross (Army), the Silver Star Medal (Army), the French Croix de Guerre with diploma (Gilt Star and Bronze Star), the Italian Crux de Guerre with diploma, and the Portuguese Cruz de Guerra for his actions during World War I.

CITATION:

For conspicuous gallantry and intrepidity at the risk of his life above and beyond the call of duty while serving as a Squad Leader in a Provisional Rifle Platoon composed of Artillery men and attached to Company J, Third Battalion, Seventh Marines, First Marine Division (Reinforced), in action against enemy aggressor forces at Yudam-ni, Korea, on 2 December 1950. Vastly outnumbered by a well-trenched and cleverly concealed enemy force wearing the uniforms of friendly troops and attacking his platoon's open and unconcealed positions, Sergeant Johnson unhesitatingly took charge of his platoon in the absence of the leader and exhibiting great personal valor in the face of a heavy barrage of hostile fire, coolly proceeded to move about among his men, shouting words of encouragement and inspiration and skillfully directing their fire. Ordered to displace his platoon during the fire fight, he immediately placed himself in an extremely hazardous position from which he could provide covering fire for his men. Fully aware that his voluntary action meant either certain death or capture to himself, he courageously continued to provide effective cover for his men and was last observed in a wounded condition single-handedly engaging enemy troops in close hand grenade and hand-to-hand fighting. By his valiant and inspiring leadership, Sergeant Johnson was directly responsible for the successful completion of the platoon's displacement and the saving of many lives. His dauntless fighting spirit and unflinching devotion to duty in the face of terrific odds reflect the highest credit upon himself and the United States Naval Service.

Marine to Receive Medal of Honor

7th Marines, investigated his actions and nominated him for the Medal of Honor. After two years and seven months making its way to the White House, the nomination now has the necessary approval from the president. The president will present the medal and citation at a date to be determined.

Hoping the president would make the Medal of Honor announcement on their son's birthday, Dan and Debra Dunham drove to Quantico from their home in Scio, N.Y. Dunham is buried in Scio.

"The public now knows what Jason did," said Deb. "We still have a loss, but the gift that Jason gave helps us go on.

"The good part is that we get to make new memories and bring new people into the family; the bad news is there will be no new memories with Jason."

The president acknowledged Dan and Deb sitting in the front row. The parents held each other close as the audience gave a resounding applause.

"We took (the applause) as a thank you for us, but it was for Jason," Deb said. "At that point, Dan and I were missing Jason a lot."

Addressing Dunham's parents, Bush said, "We remember that the Marine who so freely gave his life was your beloved son. We ask a loving God to comfort you for a loss that can never be replaced.

"As long as we have Marines like Cpl. Dunham, America will never fear for her liberty."

Before Dunham, the last Marine actions to earn the medal happened May 8, 1970, in Vietnam, according to Marine Corps History Division records. A Medal of Honor citation details Lance Cpl. Miguel Keith's machine-gun charge that inspired a platoon facing nearly overwhelming odds: Wounded, Keith ran into "fire-swept terrain." Wounded again by a grenade, he still attacked, taking out enemies in the forward rush. Keith

fought until mortally wounded; his platoon came out on top despite being heavily outnumbered.

The last Marine to receive the Medal of Honor was Maj. Gen. James L. Day, who distinguished himself as a corporal in the Battle of Okinawa in 1945. On Jan. 20, 1998, more than half a century later, President Bill Clinton presented the medal to Day, who passed away that year.

Since the Long War began, the president has presented one Medal of Honor. On April 4, 2003, during Operation Iraqi Freedom, Army Sgt. 1st Class Paul R. Smith posthumously earned the medal for organizing a defense that held off a company-sized attack on more than 100 vulnerable coalition soldiers. In the defense, Smith manned a .50 caliber machine gun in an exposed position until he was mortally wounded.
