

10 November 1775: Continental Congress authorizes two battalions of American Marines; the birthday of the Corps.

10 November 1918: 5Th Marines make night crossing of the Meuse River against German resistance.

10 November 1948: First eight enlisted women are sworn in as Regular Marines. The following summer, first black women Marines enlist.

10 November 1954: Marine Corps War Memorial dedicated next to Arlington National Cemetery.

10 November 1975: Marine Corps celebrates its 200th birthday.

4 November 1979: Mob overruns embassy in Teheran, Iran; thirteen Marines are among sixty-five American taken hostage; fifty-two are held captive fore 444 days.

9 November 1989: Berlin Wall is torn down.

There appears to be disagreement regarding three pending veteran benefit bills in the congress. The Veterans Affairs Department disagrees with elements of Senate Bill 2162, Mental Health Improvements Act of 2007, sponsored by Sen. Daniel Akaka (D-HI) and Senate Bill 38, Veterans Mental Health Outreach and Access Act, sponsored by Sen. Pete Domenici (R-NM). The VA and administration support Senate Bill 2142, Veterans Emergency Care Fairness Act. One of the elements in contention is whether mental health assistance should or should not be "outsourced" to the private sector as stated in Bills 2162 and 38.

Rep. Bob Filner (D-CA), House Veterans Affairs Committee Chairman, is hopeful that the congress will do more to improve the government's disability health care and benefits systems. The backlog of disability claims (400,000), GI Bill benefits and overhauling the disability ratings process are of major concern.

The Department of Veterans Affairs, Department of Defense and National Institutes of Health are planning to participate in a "consensus conference" in order to improve the designs and methodologies used by the agencies as applied to future research studies regarding Post Traumatic Stress Disorder (PTSD).

2007 Military Mail Christmas Mailing Dates

To ensure delivery of holiday cards and packages by December 25 to military APO/FPO addresses overseas, we suggest mailing by the recommended dates shown below.

All mail addressed to military post offices overseas is subject to certain conditions or restrictions regarding content, preparation, and handling. APO/FPO addresses generally require Customs Forms. To see a table of active APO and FPO addresses and mailing restrictions by individual APO/FPO ZIP Codes, go to <u>pe.usps.com</u> and click "*Postal Bulletins*." Go to the current issue and see the heading "Overseas Military Mail."

1/ EMMS – Express Mail Military Service is available to selected military post offices. Check with your local Post Office to determine if this service is available to your APO/FPO of address.

2/ PAL – PAL is a service that provides air transportation for parcels on a space-available basis. It is available for Parcel Post items not exceeding 30 pounds in weight or 60 inches in length and girth combined. The applicable PAL fee must be paid in addition to the regular surface rate of postage for each addressed piece sent by PAL service.

3/SAM - SAM parcels are paid at Parcel Post postage rate of postage with maximum weight and size limits of 15 pounds and 60 inches in length and girth combined. SAM parcels are first transported domestically by surface and then to overseas destinations by air on a space-available basis.

An independent federal agency, the U.S. Postal Service is the only delivery service that visits every address in the nation, 146 million homes and businesses, six days a week. It has 37,000 retail locations and relies on the sale of postage, products, and services to pay for operating expenses, not tax dollars. The

Postal Service has annual revenues of \$75 billion and delivers nearly half the world's mail.

Retiree Cola Set

Military and federal civilian retirees, veterans receiving disability compensation and Social Security recipients will get a 2.3 percent cost-of-living adjustment in January. The increase also will boost annuities under the military's survivor benefits plan.

The increase is tied to inflation as measured by the government's Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W). The increase is based on the average change in prices for a market basket of goods and service from the third quarter of 2006 to the third quarter of 2007

"From the Halls of Montezuma To the Shores of Tripoli; We fight our country's battles In the air. on land. and sea: First to fight for right and freedom And to keep our honor clean; We are proud to claim the title Of United States Marine. Our flag's unfurled to every breeze From dawn to setting sun; We have fought in every clime and place Where we could take a gun; In the snow of far-off Northern lands And in sunny tropic scenes. You will find us always on the job The United States Marines. Here's health to you and to our Corps Which we are proud to serve In many a strife we've fought for life And never lost our nerve: If the Army and the Navy Ever look on Heaven's scenes; They will find the streets are guarded By United States Marines"

History of the Marines' Hymn

"From the Halls of Montezuma to the Shores of Tripoli"

America declared war on the Barbary Pirates of northern Africa in 1805 because they had been raiding our ships in the Mediterranean Sea. During that conflict, Lieutenant Presley N. O'Bannon, USMC, and his small force of Marines participated in the capture of the city of Derne in Tripoli (which is today part of the country of Libya). As this was the first time that the American flag had been hoisted over a fortress in the Old World, the Colors (ceremonial flag) of the Marine Corps were inscribed with the words: "To the Shores of Tripoli." During the hardest fighting of the Mexican War, U.S. Marines were the first to breach the otherwise impregnable walls of Mexico City by capturing the Castle of Chapultapec, which was the palace of the great Aztec emperor, Montezuma. The Colors of the Corps were then changed to read "From the Shores of Tripoli to the Halls of Montezuma." Following the close of the Mexican War came the first great verse of the Marines' Hymn, written according to tradition by a Marine on duty in Mexico. For the sake of euphony, the unknown author transposed the phrases in the motto on the Colors so that the first two lines of the Hymn would read: "From the Halls of Montezuma to the Shores of Tripoli." Many interesting stories have been associated with the Marines' Hymn. One of the best was published in the Stars and Stripes, the official newspaper of the American Expeditionary Force in Europe, under the date of August 16, 1918. "A wounded officer from among the gallant French Lancers had just been carried into a Yankee field hospital to have his dressing changed. He was full of compliments and curiosity about the dashing contingent that fought at his regiment's left. 'A lot of them are mounted troops by this time,' he explained, 'for when our men would be shot from their horses, these youngsters would give one running jump and gallop ahead as cavalry. I believe they are soldiers from Montezuma. At least, when they advanced this morning, they were all singing 'From the Halls of Montezuma to the Shores of Tripoli.' The Marines' Hymn has been sung and played in

all four corners of the earth and today is recognized as one of the foremost service songs.

Burial Flags

Why Does VA Provide a Burial Flag?

A United States flag is provided, at no cost, to drape the casket or accompany the urn of a deceased veteran who served honorably in the U. S. Armed Forces. It is furnished to honor the memory of a veteran's military service to his or her country. VA will furnish a burial flag for memorialization for each other than dishonorable discharged

- veteran who served during wartime
- veteran who died on active duty after May 27, 1941
- veteran who served after January 31, 1955
- peacetime veteran who was discharged or released before June 27, 1950



• certain persons who served in the organized military forces of the Commonwealth of the Philippines while in service of the U.S. Armed Forces and who died on or after April 25, 1951 certain former members of the Selected Reserves

Who Is Eligible to Receive the Burial Flag?

Generally, the flag is given to the next-of-kin, as a keepsake, after its use during the funeral service. When there is no next-of-kin, VA will furnish the flag to a friend making request for it. For those VA national cemeteries with an Avenue of Flags, families of veterans buried in these national cemeteries may donate the burial flags of their loved ones to be flown on patriotic holidays.

How Can You Apply?

You may apply for the flag by completing <u>VA Form 21-2008</u>, <u>Application for United States Flag for Burial Purposes</u>. You may get a flag at any VA regional office or U.S. Post Office. Generally, the funeral director will help you obtain the flag.

Can a Burial Flag Be Replaced?

The law allows us to issue one flag for a veteran's funeral. We cannot replace it if it is lost, destroyed, or stolen. However, some veterans' organizations or other community groups may be able to help you get another flag.

How Should the Burial Flag Be Displayed?

The proper way to display the flag depends upon whether the casket is open or closed. VA Form 21-2008 provides the correct method for displaying and folding the flag. The burial flag is not suitable for outside display because of its size and fabric. It is made of cotton and can easily be damaged by weather.
