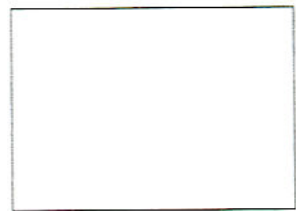

Because of the complaints received by U.S. Representative Roscoe Bartlett (R-MD), he has proposed the Combat Wounded Disability Income Modernization Act of 2007 (HR 1731). This bill, which may be considered this month, would raise the current disability pay, which is shown to be below the declared "poverty" level of income, substantially.

The drawback for many of our members is the benefit(s) from this bill, if enacted, would only be available to veterans injured after September 11, 2001.

Also, on the federal level, a struggle continues between the Department of Defense and the Congress (House of Representatives) to address all the ills related to current military health care finances. The Defense representative has stated everything is under control versus the concerns stated by the House members – Building 18 at Walter Reed Hospital; lack of cost estimates; co-payments for medical benefits by service members through Tricare; underestimation of health care costs; and the incompatibility of the records systems used by the Pentagon and the Department of Veterans Affairs.
