DISABLED VETERANS RECEIVE MILEAGE REIMBURSEMENT INCREASE:

On February 1st eligible veterans will see their mileage reimbursement double for travel to Department of Veterans Affairs medical facilities

The 2008 appropriations act provided funding for VA to increase the beneficiary travel mileage reimbursement rate from 11 cents per mile to 28,.5 cents per mile.

The increase became effective Feb. 1st The VA also equally increased the deductible amounts applied to certain mileage reimbursements. The new deductibles are \$7.77 for a one-way trip and \$15.54 for a round trip, with a maximum of \$46.62 per calendar month; these deductibles can be waived if it is a financial hardship.

This Month in History Selected March Dates of Marine Corps Historical Significance

- **3 March 1776:** Capt. Nicholas and his Marines land at New Providence, Bahamas, seize military stores. And in January fight for Gen. Washington at Princeton.
- **12 March 1824:** Brevet Maj. Robert D. Wainwright and Marines from Boston quell riot in stat prison. Story in Mcguffeys Reader spreads Marines fame.
- **9 March 1847:** Capt. Alivin Edson leads Marine battalion ashore with Army forces at Veracruz, Mexico.
- **16 March 1919:** 4th Marines land at Shanghai to stay 14 years.
- **8 March 1928:** Capt. Merritt A. Edson sets out on Epic Coco River patrol to hunt for Sandino.
- **26 March 1945:** Iwo Jima secured. Marines suffer 25,891 casualties.
- **8 March 1965:** 9th Marine Expeditionary brigade lands at Da Nang, South Viet Nam.
- **3 March 1995:** Marines complete withdrawal of UN forces from Clan war in Somalia.

At present there are four bills to allow, "gaming slot machines" to be placed in eligible nonprofit organizations pending in both houses (House and Senate).

There are six bills pending in both houses that are considering the broadening of the "Income Tax Subtraction" to benefit veterans.

There is a concerted effort on the part of many attorneys, in various states, to furnish free assistance in helping veterans expedite their disability requests with the Veterans Administration. Many of these attorneys, from big law firms, are Viet Nam veterans and are attempting to help speed up the slow claims process. Disability claims had risen to 838,141 in 2007. At the present time there are 407,000 pending cases.

As you might guess the VA is concerned about the resulting involvement of outside attorneys bringing their expertise to bear on the process. More than 400 attorneys around the country have signed up to give assistance to the veterans.

The History of Parris Island

During 1715 an Englishman named Colonel Alexander Parris purchased the island and eight small surrounding island. Until the Civil War, plantation life flourished here. Marines were first stationed on Parris Island in 1891, in the form of a small security detachment headed by First Sergeant Richard Donovan.

His unit was attached to the Naval Station, Port Royal, the forerunner of Parris Island. Donovan's unit was highly commended for preserving life and property during hurricanes and tidal waves that swept over the island in 1891 and 1893.

Military buildings and homes that were constructed between 1891 and World War I form the nucleus of the Parris Island Historic District. At the district center are the commanding general's home, a 19th century wooden dry dock and a turn of the century gazebo - all of which are on the National Register of Historic Places.

On November 1, 1915, Parris Island was officially designated a Marine Corps Recruit Depot and training was continued from then on. Prior to 1929, all transportation to and from the island was by ferry from Port Royal docks to the Recruit Depot docks. In that year the causeway and a bridge over Archer's Creek were completed, thus ending the water transportation era.


The causeway was dedicated as the General E. Pollock Memorial Causeway in April 1984. During the fateful December of 1941, 5,272 recruits arrived here with 9,206 arriving the following month, making it necessary to add the 5th, 6th, 7th and 8th Recruit Training Battalions. As the war influx continued, five battalions, were sent to New River, N.C., to train and the Depot expanded to 13 battalions.

From 1941 through 1945, 204,509 recruits were trained here. At the time of the Japanese surrender, more than 20,000 recruits were aboard the depot. On February 15, 1949, a separate "command" was activated for the sole purpose of training female Marine recruits. This command has since been designated the 4th Recruit Training Battalion and is the only battalion in the Corps to train female recruits.

The Korean conflict began in 1950 when 2,350 recruits were in training. From then until the 1st Marine Division was withdrawn from Korea, Parris Island drill instructors trained more than 138,000 recruits. During March 1952, the peak training load of 24,424 recruits was reached.

The recruit tide again flooded during the years of the Vietnam War. A peak training load of 10,979 was reached during March 1966. Today, about 19,000 recruits are trained at Parris Island each year.


