# Transcontinental Motor Convoy Project

Note – This article is based upon information provided to me by Ray Gonzales, a fellow member of Anne Arundel County Detachment 1049 of the Marine Corps League as well as that obtained from the Military Vehicle Preservation Association website, and other correspondence.

In 1919, the U.S. ARMY decided to plan and execute a motor convoy of various vehicles across the country, on the then newly-formed Lincoln Highway. In general, the route began at the White House, in Washington, DC and ended at Lincoln Park, in San Francisco, CA – some 3,250 miles and 62 days later. This would be the first motor transport convoy ever to have crossed the United States.

The convoy had the following objectives:

- Put the equipment through as grueling a trial as could be devised.
- Study how the varying road conditions would affect each branch of service.
- Serve as a transcontinental recruiting drive for the U.S. Army.
- Demonstrate the need for good roads.
- Say “Thanks” to the American people for their support during WWI.

The 1919 convoy was staffed with 37 officers and 258 enlisted men – including then Lt. Colonel Dwight Eisenhower, and 81 Army vehicles: 46 trucks, 11 passenger cars, 9 motorcycles, 5 ambulances, 2 ambulance trailers, 1 Maxwell caterpillar tractor, 4 kitchen trailers, 1 pontoon trailer, 1 mobile searchlight, and 1 MILITOR (a recovery vehicle).

The convoy left Washington, D.C. on 7 July, 1919 and arrived in San Francisco on 6 September, 1919. At that time, the ‘Lincoln “Highway” was a series of roads with conditions that ranged from poured concrete to tracks across quicksand, tracks across alkali mud, and across bridges that gave way under the weight of these vehicles. The trip was grueling and the daily average was 59 miles per day and about 6 miles per hour!

## Legislative Report

As a part of the consideration of House of Representative's Bill, **HR 1428**, the Department of Veterans Affairs is reviewing the association of **Agent Orange** to a variety of illnesses associated with *herbicide exposure*. Among the illnesses under consideration is Parkinson's disease. The VA will consider reports received from the National Academies' Institute of Medicine and other medical and scientific information. (The Agent Orange Act is dated 1991) Questions about Agent Orange may be directed to the VA at 800-749-8387

The **Service Members' Rights Protection Act (HR 2696)**, which may be voted on this month, would allow service members to sue for violations of their rights protected under the Service-Members' Civil Relief Act.

For the first time in 16 years, certain members of the U.S. Congress will hold hearings and/or introduce legislation to repeal the law which bans service by openly gay persons in the U. S. Military. The current administration is reported to support the repeal of the ban.

## VA Volunteerism

The Secretary of Veterans Affairs made **amyotrophic lateral sclerosis (ALS)** a presumptively compensable illness for all Veterans with 90 days or more of continuous active service in the military. As a result, the VA can now pay disability compensation to Veterans with ALS. Their survivors are also eligible for VA benefits.

In an effort to provide this new and much needed support, the VA sent notification letters to Veterans with ALS advising them of their potential eligibility for disability compensation benefits. Unfortunately, a number of Veterans who should not have received this letter did. The VA is reviewing individual files to identify those who may have mistakenly received the letter.

VA employees are calling Veterans and their survivors to clarify the purpose of the letter, to explain why they mistakenly received the letter, and to express the VA's sincere apologies for any distress caused by their error.

# Corps History

1775

5 October

Meeting in Philadelphia, Pennsylvania, the 2nd Continental Congress used the word "Marines" on one of the earliest known occasions, when it directed **General George Washington** to secure two vessels on "Continental risque and pay", and to give orders for the "proper encouragement to the Marines and seamen" to serve on the two armed ships.

1820

17 October

**Archibald Henderson** appointed Commandant...a position he held until his death, a period of 38 years.

1859

18 October

86 Marines, under 1st Lieutenant **Israel Green**, USMC and Lt. Colonel **Robert E. Lee**, USA, capture abolitionist **John Brown** at Harpers Ferry, Virginia.

1880

1 October

**John Phillip Sousa** appointed 17th leader of the Marine Corps Band.

1899

8 October

A force of 375 Marines under command of future **Commandant George F. Elliott**, attacked and captured the insurgent town of Novaleta, Luzon, Phillipine Islands. There were 11 Marine casualties.

1917

9 October

The 8th Marines activated at Quantico, Virginia. The regiment would not see combat in Europe during World War I; however, the 8th Marines participated in operations against dissidents in Haiti for over five years during the 1920s. During World War II, the regiment was assigned to the 2nd Marine Division and participated in combat operations on Guadalcanal, Tarawa, Saipan, Tinian, and Okinawa, and earned three Presidential Unit Citations.

1918

14 October

Marine flyers, 2nd Lieutenant **Ralph Talbot** and Gunnery Sergeant **Robert G. Robinson**, win Medals of Honor.

1919

31 October

A patrol of Marines and gendarmes, led by **Sergeant Herman H. Hanneken**, disguised themselves as Cacos and entered the headquarters of the Haitian Caco Leader, **Charlemagne Peralte**, killing the bandit chief, and dispersing his followers. **Sergeant Hanneken** and **Corporal William R. Button** were each awarded the Medal of Honor.

## Motor Convoy

Ninety years later, the original event was commemorated by a convoy of restored military vehicles re-enacting the original event over a vastly improved series of interstate highways and roads.

The requirements that needed to be met in order for historic military vehicles (**HMV**) to participate included:

1. Participants could drive any era HMV on the route as long as it had been restored to its original military configuration and color – anything from a Model T to a Humvee and anything in between.
2. The HMV had to be in excellent mechanical condition.
3. The owner/operator had to have personal vehicle liability coverage.
4. Other than official convoy lead/chase/supply vehicles, no non-military vehicles were allowed.

Some significant points about the 2009 reenactment of the 1919 convoy are provided below.

- The convoy covered 3,250 miles per the 1919 mileage charts... traveling through 11 states and the District of Columbia.
- Completion of the trek took 26 days – 20 travel days and 6 rest days.
- A World War I vintage vehicle was on the road for every day of the convoy.
- Convoy stretched for 2 to 3 miles and often had police escorts. Police in Maryland, Pennsylvania, and Indiana accompanied the convoy across the entirety of their states.
- Two people were encountered, who remembered the 1919 convoy!
- The convoy was able to travel over 1.1 miles of the original 1919 route.
- Convoy had to navigate through a herd of cattle just west of Austin, Nevada.
- The convoy also travelled along (over) sections of what were at one time, 'Pony Express' trails.

**Ray Gonzales**, a life member of our detachment and his Korean War era M-38 Jeep were among the participants in the 2009 Transcontinental Motor Convoy.

Unfortunately, personal commitments prevented Ray from participating in the entire convoy; however, he did participate in the first day's events, which took him from the Laurel Race Course, to Constitution Avenue in D.C., and ultimately Chambersburg, Pennsylvania, which was the rally point marking the end of the first day's travels.

## 1945

## 6 October

Major General Keller E. Rockey, Commanding General, III Amphibious Corps, accepted the surrender of 50,000 Japanese troops in North China on behalf of the Chinese Nationalist government.

## 1951

## 11 October

A Marine battalion was flown by transport helicopters to a frontline combat position for the first time, when HMR-161 lifted the 3rd Battalion, 7th Marines, and its equipment, during Operation Bumblebee, northeast of Yanggu, Korea.

## 1955

## 31 October

Lewis B. 'Chesty' Puller, who earned five Navy Crosses (and 1 Army Distinguished Service Cross), retired as a Lt. General.

## 1962

## 27 October

2nd Marine Division and 2nd Marine Aircraft Wing deployed during the Cuban missile crisis.

## 28 October

An 11,000-man 5th Marine Expeditionary Brigade left Camp Pendleton for the Caribbean during the Cuban Missile Crisis. A week earlier, the entire 189,000-man Marine Corps had been put on alert and elements of the 1st and 2nd Marine Divisions were sent to Guantanamo Bay. Other 2nd Division units and squadrons from five Marine Aircraft Groups were deployed at Key West, Florida, or in Caribbean waters during the crisis.

## 1968

## 19 October

Operation Maui Peak, a combined regimental-sized operation which began on 6 October, ended 11 miles northwest of An Hoa, Vietnam. More than 300 enemy were killed in the operation.

## 1983

## 23 October

At 0622 an explosive-laden truck slammed into the BLT headquarters building in Beirut, Lebanon, and took the lives of 241 Americans—including 220 Marines. This was the highest loss of life in a single day for Marines since D-Day on Iwo Jima in 1945.

## 25 October

Marines and Army intervene in Grenada, West Indies.

## 1 October

General Peter Pace becomes first Marine to serve as Vice Chairman of the Joint Chiefs of Staff.

## 2005

## 1 October

Marines from Regimental Combat Team 2, 2nd Marine Division, launch Operation Iron Fist against Iraqi insurgents in Anbar Province.

# Flag Burner Pilloried by Vets

Editors Note – The article, which this piece is based upon, was originally published in the Times Union, Albany, N.Y. on September 28, 2009

Valley Falls, New York

After desecrating an American flag flown by the local VFW, a vandal was given three choices – get turned over to the police, go one-on-one in a fight with a seasoned war veteran, or be duct-taped to a flagpole for six hours with a sign around his neck pronouncing his alleged crime – flag burning.

It was the vandal's selection of the third option, a form of public humiliation with its roots dating to the Middle Ages, that would still have the small town buzzing a week after the 21-year-old was hunted down and taken into custody. The members of the Veterans of Foreign Wars Post 1938 were incensed enough to tie up the man last Sunday after they accused him of setting fire to a flag, which had previously flown over troops in Iraq before adorning the flag-staff in front of their building.

The flag-burner appeared intoxicated when he entered the VFW post on the day of the alleged act, Nick Normile, Post Commander and Vietnam War veteran said. When the man was refused service for not having a proper ID, he ran out of the building in a fit of anger. He cut the rope holding the flag and ignited it with a cigarette lighter.

Normile knew that the offender had to be taught a lesson; so, he went out hunting for him. When he was unable to find the flag-burner, he sought the help of the offender's uncle.

Once located and confronted, Normile stated that the vandal 'manned up' and he knew that he had punishment coming. Normile described the young man, whom he refused to identify, as feeling guilty and ashamed. "I told him to think about those kids in the foxhole, and how they had no one to set them free," Normile said. "It got to him, so I was satisfied. He showed a lot of remorse, and no attitude."

Two days later, Normile said the man was pilloried and forced to sit in the sun for six hours as towns-people gathered across the street for a youth soccer picnic. A sign was hung around his neck detailing what he had done. "He'll never disrespect the flag again, I can tell you that," Normile said on Friday.

Normile said he's been flooded with calls from media outlets since the event received attention from local TV stations and newspapers; however, he has declined appearances and gone on to say that he's not planning to let the story get any more attention. "I'm not trying to be some martyr or hero," Normile said. "I just did what I thought was right."

Patriotism is on open display in this village of about 500, the walls of a defunct railroad bridge near its entrance now brightly colored red, white and blue. Most of the historical homes have American flags of their own hanging from porches, some also adorned with the 'Don't Tread on Me' flag popular with Tea Party activists.

Normile said the flag, whose pieces will be retired in a formal ceremony, had significant meaning. The VFW Auxiliary had been sending toiletries and other goods to soldiers in Iraq, who then sent back a flag that had flown over their bunker in appreciation. It was received with great attention and a ceremony.

State troopers and Rensselaer County sheriffs deputies said no charges had been filed by either the VFW post or the culprit.




