# Legislative Report

As a reminder, active military personnel are able to purchase up to \$400,000 worth of life insurance for \$27 per month (**Service Members Group Life Insurance, SMGLI**). However, there is a major concern that members of our military may be taken advantage of by less than honest insurance agents, who are selling militarily inappropriate policies at much higher premiums. The General Accounting Office has issued a report outlying the above problem and has suggested that the SMGLI work with the National Association of Insurance Commissioners to better control/eliminate the abuse of our military by unscrupulous insurance agents.

Starting on September 1, 2009, certain **TRICARE STANDARD** beneficiaries will be eligible for reimbursement of co-payments...retro-active to October 14, 2008. Going forward, this benefit will continue for certain preventive services. The waiver of the co-payment applies to:

- breast cancer,
- cervical cancer,
- colo-rectal cancer,
- prostate cancer,
- immunizations, and
- certain physical examinations (including well-child visits) for those younger than 6 years of age).

This benefit does not apply to Medicare-eligible beneficiaries. It is anticipated that this benefit will save beneficiaries about \$110 million dollars per year. The cost will be assumed by the Defense Department.



## Uniform Regs... Medals & Ribbons

When it comes to wearing medals and ribbons, two points must be remembered...

**Marine Corps League** and **Department of Defense** medals and/or ribbons should **NEVER** be mixed on any uniform. The wearer only has the choice of wearing authorized medals and/or ribbons awarded by either the Department of Defense or the Marine Corps League.

*Simply stated, medals from both agencies may NEVER be worn together!*

Marine Corps League members are expected to know their individual authority to wear Department of Defense medals, ribbons, badges, devices, and awards and the proper way to wear them.

*Simply stated, wear your awards properly... and never wear what you do not rate!*

## Coast-to-Coast Finale

On June 26th, **Chris Le Gette** completed his 3,450 mile bicycle ride from Los Angeles to Boston by dipping the front wheel of his bike into the Atlantic Ocean off of Revere Beach, Massachusetts. Chris was joined in the event’s ceremonial conclusion by his brother, **Captain Marco Le Gette, USMC** and members of his family. Also participating was **Kirt Rebcello**, who represented the sponsoring agency, the **Injured Marine Semper Fi Fund (IMSFF)**.

Both Chris and Marco wore the uniquely designed jersey, which depicts the IMSFF, Marco’s unit, dog tags, etc. Chris dedicated his ride to Injured Marines and Marco’s unit (1/12).

It should be noted that on this coast-to-coast trek, one rider died of a heart attack; another rider was struck by a motorcycle and remains in the hospital; still another fell and broke her collar-bone; and four other riders contracted food poisoning. Yet another rider sailed over his handle-bars, sustaining injuries to his face and damaging his helmet – the next day he appeared in an on-camera interview (stitches and all) and related how great it was to ride cross-country in support of this fund-raising event. Chris did not go unscathed as he also injured himself, when his bicycle chain came loose and he hit the pavement.

The Le Gette family is very proud of Chris and his accomplishment – especially his effort to advance the recognition of the Injured Marine Semper Fi Fund.

## Maryland Loses Two Marines

July 9th was not a particularly good day in Afghanistan...especially if you consider the fact that two Marines with ties to Maryland – **Sergeant Michael W. Heede Jr** (age 22) from Edgewood and **Staff Sergeant David S. Spicer** (age 33) from Olney – were killed by the same roadside IED (improvised explosive device). They had been on patrol in Helmand, a southern province within Afghanistan.

**Sgt. Heede** joined the Marine Corps in 2005 and was a veteran of the Iraq war. Previously assigned to Camp Pendleton's 1st Combat Engineering Battalion, a 1st Marine Division unit operating under the umbrella of a Marine Expeditionary Force, Sgt. Heede subsequently volunteered for deployment to Afghanistan and was assigned to the 1st Combat Engineer Battalion, 1st Marine Division, I Marine Expeditionary Force. During his military career, he earned the Combat Action Ribbon, the National Defense Service Medal and a Navy Unit Commendation Medal, among other honors.

**SSgt. Spicer** joined the Marine Corps in 1994. He was an explosive ordnance disposal technician, who had served as a bomb technician for the 8th Engineer Support Battalion based at Camp Lejeune, N.C., prior to his assignment to the 8th Engineer Support Battalion, Combat Logistics Regiment 2, 2nd Marine Expeditionary Brigade. SSgt. Spicer, who had been selected for promotion to Gunnery Sergeant, is survived by his wife Kate, who gave birth to their first child, a daughter, one year ago and is now pregnant with a son.

Both Marines will be interred at the Arlington National Cemetery.

### When Old Glory Gets Older...

the etiquette of flag maintenance and disposal. Do you know what to do when the flag outside your facility or home needs cleaning or replacing? If all that your Stars and Stripes needs is a proper refurbishing, check with a dry cleaning establishment in your area...they may even clean your flag without charge.

Flags that are beyond cleaning or repair should be properly destroyed. There's no right or wrong way to dispose of a flag, as long as it's done respectfully and privately. You can destroy a flag yourself if performed with dignity and respect. Traditionally, flags that are beyond repair are burned in a barrel or over a camp fire. If that's not an option, contact local service organizations such as the **Veterans of Foreign Wars**, the **Marine Corps League**, and the **American Legion**, who generally offer flag disposal services. Often, local **Boy Scouts** and **Girl Scout** troops offer flag disposal services as well. Military installations in your area may also be a source of disposal.

Remember, soiled, damaged, and faded flags should never be displayed!



## Cell-Phone Discounts

Military veterans and active-duty personnel are eligible for **significant discounts on cell-phone plans** - if they know to ask. There are over 23 million veterans in the U.S. of which many are unaware of the potential savings on their monthly cell-phone bills. Monthly military discounts range from 15% on **Verizon Wireless** plans to 10% off - and no activation fee - on **T-Mobile** agreements. **Alltel**, **Sprint** and **AT&T** offer similar discounts.

While not everyone knows about the discounts, those who do say that getting the companies to register them for the cheaper plans is no easy task. Phoenix Arizona resident Janis Johnson said she called her cell-phone company to register her husband, an Air Force veteran. At first, a customer service representative said no veteran discount existed. "Then she said we should get the 15 percent discount, but we were supposed to go to the Web site," she said. Johnson eventually gave up when she could find no place online to register.

Kenneth James Madetzke, 60, of Phoenix, had better luck. The Vietnam War veteran was able to sign up for AT&T's discounted plan and saves about \$8 a month. "It makes me feel good to have the money savings and be recognized as a veteran," Madetzke said. "The disappointment was that there was no advertisement. I had to pull it out of them." While waiting for doctor's appointments at the VA hospital, Madetzke often tells fellow veterans about the discount. Most, he said, know nothing about the deals. Bill Messer, president of Vietnam Veterans of America's Arizona State Council, said he used Verizon and hadn't heard of the discount. Verizon spokeswoman Jenny Weaver said the firm makes an effort to inform veterans of the savings, with in-store posters and military-magazine ads. "There aren't any posters up in the Phoenix metro area right now, because of some of the other promotions we have going on," Weaver said. Most services require a military identification card, veteran identification card or military discharge papers as proof of veteran status. Some companies require online registration to get the discount. Many companies, including Verizon, also offer discounted plans for customers 65 and older.



### Editor's Note

I have not personally verified the availability of these discounts but do know first hand that most of these vendors offer discounts; but, only if the consumer asks for them. Hopefully, veterans' discounts are available for residents of our area.

# Corps History

## 1 July 1920

Major General John A. Lejeune became 13th Commandant of the Marine Corps.

## 2 July 1999

Marine Corps bases at El Toro and Tustin closed.

## 4 July 1801

President Thomas Jefferson reviewed the Marines, led by the Commandant of the Marine Corps, LtCol William W. Burrows and the Marine Band, on the White House grounds. The smartly uniformed Marines performed drills and fired various salutes in observance of the new nation's 25th anniversary.

## 5 July 1968

Marines abandon Khe Sanh combat base.

## 6 July 1990

One of the oldest and most versatile attack aircraft in Marine Corps history, the A-4 Skyhawk, retired from the Corps' active aviation structure after over 30 years of service.

## 7 July 1941

1st Provisional Marine Brigade lands at Iceland.

## 7 July 1941

The 1st Marine Aircraft Wing was activated at Quantico, Virginia. Within a year of activation, the Wing would participate in the Marine Corps offensive at Guadalcanal. That bitter campaign would be the first in a series of legendary battles in which the Wing would add luster to its reputation. The 1st MAW would earn five Presidential Unit Citations for gallantry in campaigns spanning World War II, Korea, and Vietnam.

## 11 July 1798

President John Adams approved "An Act for Establishing and Organizing a Marine Corps", and it became law. The following day, the President appointed William Ward Burrows the Major Commandant of the new Corps. In August, Major Burrows opened his headquarters in Philadelphia, which at that time was still the capital of the new nation.

## 14 July 1853

Marines under Major Jacob Zeilin make landing as Commodore Matthew Perry opens Japan.

## 14 July 1993

The USS IWO JIMA was decommissioned after more than 30 years of service in a ceremony at Norfolk Naval Base, Virginia. The ship was named for the World War II battle during which three Marine divisions ousted 20,000 entrenched Japanese troops. The Iwo Jima was commissioned on 26 August 1961, and it was the first ship specifically designed as an amphibious assault ship from the keel up.

## 15 July 1958

2nd Marines land near Beirut and seize the airport at the request of the Lebanese government.

## 18 July 1918

The 4th Brigade of Marines began an attack near Soissons, France, as part of a three-division counter-attack against the Germans. In the first two days of battle, the brigade sustained 1,972 casualties.

## 18 July 1948

Twelve Marines at consulate in Jerusalem (Israel) begin modern day Marine Security Guard program.

## 21 July 1861

A battalion of 365 Marines led by Brevet Major John G. Reynolds fights in the Battle of Bull Run.

## 21 July 1944

3rd Marine Division opens battle for Guam.

## 24 July 1944

The V Amphibious Corps, commanded by Major General Harry Schmidt, landed on Tinian, in the Mariana Islands. The following morning, the 2nd and 4th Marine Divisions began a shoulder-to-shoulder southward sweep of the island and clear the airfield from which the Enola Gay would begin its historic flight to Hiroshima a year later.

## 25 July 1930

Lieutenant Lewis Puller wins first of five Navy Crosses chasing Sandino guerrillas in Nicaragua.

## 26 July 1947

President Harry Truman signs the National Security Act of 1947, reaffirming the status of the Marine Corps as a separate military service within the Department of the Navy. The Act Provided for Fleet Marine Forces, and confirmed the Corps' mission of seizing and defending advanced bases, as well as land operation incident to naval campaigns.

## 26 July 1956

Marine battalion assigned to the Sixth Fleet evacuates civilians from Alexandria, Egypt following the canal's nationalization.

## 27 July 1953

Korean War ended – armistice signed at Panmunjon, Korea.

## 28 July 1779

Captain John Welsh and thirteen Marines killed in an assault on Fort George at Penobscot Bay, Maine.

## 28 July 1918

Brigadier General John A. Lejeune assumed command of the 2nd Division, U.S. Army in France, and remained in that capacity until August 1919 when the unit was demobilized. He was the first Marine officer to hold an Army divisional command, and following the Armistice, he led his division in the march into Germany
