Ask yourself, what detachment exemplifies the best character traits of being a Marine and the true spirit of Semper Fi? 

# Remembering Our Own



On Friday, May 1st, Marine **Gary Neiswecki** was memorialized at VFW Post 160 by members of the **Anne Arundel County Detachment 1049** of the Marine Corps League. Gary was assigned to **HMX-1** (Presidential Helicopter Transport Squadron) and had also served at Camp David during his enlistment in the Corps' during the 1980's.

The memorial service was led by former Commandant **Steve Salanik**, Chaplain **Ken Rollins** and Sergeant-at-Arms **Chris Kalwa**. Military honors were rendered by an honor guard of four Marines, from Baltimore. Approximately fifty people attended to pay their respects – many from the Secret Service, where Marine Neiswecki was assigned to the Counter Sniper Team and the Central Intelligence Agency. Friends of Gary celebrated his life through remarks about the relationships and experiences they had shared with him.

**Jim Le Gette** and **Margaret Ehrlich** contributed significantly to the success of this event by overseeing the activities at the Post that included refreshments for the attendees immediately after the ceremony.

## Legislative Report

*from Jim Le Gette, Legislative Officer*

The Maryland Department of Veterans Affairs announced the launching of a new website, [www.veterans.maryland.gov](http://www.veterans.maryland.gov) which will feature user-friendly navigation, up-to-date features and comprehensive information to serve veterans and their loved ones.

The Maryland VA has also offered website: [www.mdva.state.md.us](http://www.mdva.state.md.us), which offers educational opportunities, veteran memorials information and an online version of their biannual newsletter.

Because of past difficulties, the processing of military retired and annuitant pay will be taken away from Lockheed Martin and will be performed by the Defense Finance and Accounting Service, starting in early 2010. The change was brought about by the "lax oversight of the work" by Lockheed Martin as accused by lawmakers last year.

The U.S. House of Representatives Veterans' Affairs Committee has approved a bill (HR 1377), which will expand situations allowing the Dept. of Veterans Affairs to reimburse emergency treatment for veterans at non-VA hospitals for a condition not related to military service. The VA will pay the costs even if there may be other insurance that could cover the cost. The chief advocates of this bill are hospitals that don't want to discharge or transfer veterans when it is not in the veteran's best interest.

# New York Marines Leave No One Behind

This condensed and edited article was based upon a letter submitted to the Sgt Grit, American Courage Newsletter #199 and reprinted with the permission of Public Relations Officer for the Department of New York, Al Cavallo. Please read the *From the Editor column* on page 2 of this newsletter for a related article.

The day started out with a raw, misty rain; however, this was the day that many of us Marines had waited for. The weather would not be a factor for us, as we were Marines. Marines, who had previously assembled for missions on the hot sands of Iwo Jima, on the frozen terrain of Korea's Chosin Reservoir, engulfed by the steamy jungles of Viet Nam, and surrounded by the stifling deserts of Iraq.

This was the day that Private Henry Landry was to be buried with full military honors after languishing in the city morgue for 10 months, waiting to be identified.

Marine Landry passed away in a single-room-only (SRO) apartment, in New York City last June, without having any known family or next of kin. In most cases, the Medical Examiner would have sent the Private's remains to "Potters Field" for burial; however, our New York State Commandant, John Rymer was called by NYPD Detective Lee who had responded to the initial call. The ME was contacted and told to hold onto Pvt. Landry's remains.

At the time of his death, the only ID that Pvt. Landry possessed was a card from the VA, which claimed he was a Marine. At this point, both our State Sr. Vice Commandant, Dennis Tobin, and I were contacted to get Pvt. Landry identified and buried in the National Cemetery.

Working with the Kennedy-Roth Funeral Home from Woodside, Queens, the identification process was initiated. The brunt of the assignment was undertaken by Funeral Director Anna Michaelides, who spent many hours working with the NYPD, FBI, Medical Examiner, VA, St. Louis Records, and the New York Mayor's Office of Veterans Affairs. The final piece of the identity puzzle was fit into place, when NYPD Missing Person Detective Ramirez subsequently visited the SRO with a picture of Pvt. Landry, and located a tenant who recognized the deceased Marine.

Soon after, permission was given to bury our brother Marine in Calverton National Cemetery. Word was passed to our membership and to the general public about the pending funeral and memorial ceremony. Private Landry's funeral procession was escorted by the Patriot Guard Riders from Woodside, Queens to Calverton. Once on the Long Island Expressway, five escort vehicles from the Suffolk County Sheriff's Department joined the procession to the cemetery.

Many members of League Detachments from the New York Metro area were in attendance – including our State Commandant, members of the Long Island Veterans Association, and an Honor Guard of active duty Marines from the 6th Communications Battalion.

The memorial ceremony was conducted by State Sr. Vice Commandant, Dennis Tobin; the Firing Detail was provided by the Suffolk County Detachment; while, the Color Guard was supplied by the Staten Island and North Shore Queens Detachments. Taps was played by Marine David Hill of the North Shore Queens Detachment. The casket and hearse were generously supplied to the League by James Dimiceli of the Kennedy-Roth Funeral Home in Woodside, Queens.

The flag, previously draping Private Landry's coffin, was presented to Funeral Director Anna Michaelides as a symbol of appreciation for all of the work she performed to make this mission a success.

The misty, raw, rain stopped as we laid our brother to rest.

# Corps History

*from Vic Halme, Historian*

## 2 May 1946

Marines from Treasure Island Marine Barracks, under the command of Warrant Officer Charles L. Buckner, helped suppress the three-day prison riot at Alcatraz Penitentiary in San Francisco Bay. WO Buckner, a veteran of the Bougainville and Guam campaigns, ably led his force of Marines without suffering a single casualty.

## 3 May 1898

Lt. Williams leads Marines from the U.S.S. Baltimore and raises the Stars and Stripes over the Cavite Naval Station.

## 5 May 1983

In Beirut, Lebanon, a UH-1N helicopter carrying the commander of the American peace-keeping force, Colonel James Mead, was hit by machine gun fire. Colonel Mead and his crew had taken off in the helicopter to investigate artillery and rocket duels between rival Syrian-backed Druze Moslem militiamen and Christian Phalangists that endangered French members of the multinational force. The six Marines aboard escaped injury.

## 6 May 1937

Marines at NAS Lakehurst helped rescue Hindenburg survivors.

## 6 May 1946

Commandant Archibald Vandergrift tells Senate Naval Affairs Committee that 'the bended knee is not a tradition of our Corps.'

## 8 May 1995

In the wake of the most devastating storm to hit the New Orleans area in more than 200 years, a group of Marines and sailors from Marine Forces Reserve demonstrated the quick response synonymous with the Navy/Marine Corps team. Within 24 hours of being called, Marines assisted in the evacuation of 2,500 civilians, and Navy Corpsmen treated scores of flood victims.

## 10 May 1945

The 22nd Marines, 6th Marine Division, executed a pre-dawn attack south across the Asa River Estuary and seized a bridgehead from which to continue the attack toward Naha, the capital of Okinawa.

## 14 May 1917

The first Marine detachment transferred from Annapolis to a new Marine post at Quantico, VA.

## 15 May 1862

Corporal John Mackie, the first Marine to earn the Medal of Honor, was commended for service on the USS GALENA during action against Confederate shore batteries at Drewry's Bluff which blocked the James River approaches to Richmond.

## 15 May 1916

Marine Battalion begins occupation of the Dominican Republic.

## 16 May 1945

The 22nd and 29th Marines continued the attack against Half Moon Hill, a day characterized by the 6th Marine Division as the "bitterest" of the Okinawa campaign. By the 18th, the famed "Shuri line" had been broached.

## 20 May 1906

Major John A. Lejeune embarked his battalion for duty in Panama.

## 22 May 1912

First Lieutenant Alfred A. Cunningham, the first Marine officer to be assigned to "duty in connection with aviation" by Major General Commandant William P. Biddle, reported for aviation training at the Naval Aviation Camp at Annapolis, Maryland. Marine aviation had its official beginning.

## 23 May 1948

First Marines brought ashore by helicopter for amphibious exercise at New River, North Carolina.

## 23 May 1988

The V-22 Osprey, the world's first production tilt-rotor aircraft, made its debut during rollout ceremonies at Bell Helicopter Textron's Arlington, Texas, facility. More than 1,000 representatives from the military, industry, and media, gathered to hear various speakers, including Gen Alfred Gray, Commandant of the Marine Corps, praise the versatile rotor craft designed to meet the needs of 21st Century battlefields.

## 26 May 1969

Operation Pipestone Canyon began when the 1st Battalion, 26th Marines and 3rd Battalion, 5th Marines began sweeps in the Dodge City/Go Noi areas southwest of Da Nang. It terminated at the end of June with 610 enemy killed in action at a cost of 34 Marines killed.

## 29 May 1991

Elements of a joint task force that included the 5th Marine Expeditionary Brigade departed the Bay of Bengal off the coast of Bangladesh after nearly two weeks of disaster relief operations following a devastating cyclone. The joint task force delivered tons of relief supplies using helicopters, C-130s, and landing craft in Operation Sea Angel.

## 30 May 1997

Marines help evacuate 2,500 from Kinshasa, Zaire.

## 31 May 1900

Marines reach Chinese capital to defend Legation Quarter from Boxer rebellion.



## Appropriate Attire

Recently, I was asked if the detachment could publicize the appropriate dress for our detachment functions. Consultation with a cross-section of detachment officers has resulted in the publication (restatement) of the following uniform requirement.

The only required attire for meetings and most detachment functions is the Marine Corps League red cover.

Appropriate dress for individual social functions is generally well advertised in advance of the event and stated on the associated announcements. For that reason, no additional actions will be taken with regard to disseminating specific dress requirements.

Detachment officers will receive word from the Commandant, on an as necessary basis, should there be a need for a specific uniform.



## New VA Official

The Department of Veterans Affairs has a new, high-profile chief messenger: disabled Iraq war veteran Tammy Duckworth. Duckworth, who lost both legs in 2004 in Iraq when her helicopter was struck by a rocket-propelled grenade, was confirmed by the Senate as VA's assistant secretary for Public and Inter-governmental Affairs. She will deal with Congress, veterans and their families, the news media, and the public.

Duckworth will report to VA Secretary Eric Shinseki, a retired four-star general and former Army chief of staff who is a disabled Vietnam veteran. Veterans' Affairs Committee chairman said Duckworth "can begin the long and hard work of improving the department's reputation and relations across the country." Iraq veteran Jon Soltz, who heads the group VoteVets.org, called the appointment a milestone: "We now have one of our own – a veteran of the wars we are now in – in a top administration position.


