

Legislative Report

Since the most common disability for veterans is hearing damage, the **Office of the Deaf and Hard of Hearing** (ODHH), established in 2001, offers assistance to our veterans in Maryland. An overview of available assistance offered by ODHH can be obtained on the Internet (www.odhh.maryland.gov) or by telephone (410-767-7793).

The quality of **Women Veterans' health care** by the **Department of Veterans Affairs** is being reviewed through a forum and other conferences with the intent of improving and meeting the unique health care needs of our Women Veterans. More information is available by telephone (202-461-6193) or on the Internet (www.OOW@va.gov).

According to the **Maryland General Assembly**, each state agency will establish a **Procurement Preference Program** by which they will try to award **0.5%** of the value of its' procurement contracts to *veteran-owned businesses*. Applicants must be verified as a veteran-owned small business by the **Center for Veterans Enterprise** (U.S. Department of Veterans Affairs). The center can be reached via the Internet (www.acq.osd.mil/osbp) or by telephone (703-604-0157).

Corps History

1 July 1920

Major General John A. Lejeune became 13th Commandant of the Marine Corps.

4 July 1800

Marine Corps Band makes its first public appearance at Tun Tavern (Philadelphia, PA).

4 July 1801

President Thomas Jefferson reviewed the Marines, led by the Commandant of the Marine Corps, LtCol William W. Burrows and the Marine Band, on the White House grounds. The smartly uniformed Marines performed drills and fired various salutes in observance of the new nation's 25th anniversary.

5 July 1968

Marines abandon Khe Sanh combat base.

6 July 1905

Marines escort the body of John Paul Jones during its relocation from France to Annapolis, MD.

6 July 1990

One of the most versatile attack aircraft in Corps history, the A-4 Skyhawk, retired from the Corps' active inventory.

7 July 1941

The 1st Marine Aircraft Wing activated at Quantico, Virginia. Within a year, the Wing would participate in the Marine Corps offensive at Guadalcanal.

9 July 1846

During the Mexican War, Marines and Sailors occupy Sonora, CA after California is proclaimed to be part of the United States.

10 July 1941

The 2nd Marine Aircraft Wing commissioned in San Diego, CA.

15 July 1958

2nd Marines land near Beirut and seize the airport at the request of the Lebanese government.

18 July 1918

The 4th Marine Brigade began an attack near Soissons, France, as part of a three-division counter-attack against the Germans. In the first two days of battle, the brigade sustained 1,972 casualties.

18 July 1948

Twelve Marines at consulate in Jerusalem (Israel) begin modern day Marine Security Guard program.

21 July 1861

A battalion of 365 Marines led by Brevet Major John G. Reynolds fights in the Battle of Bull Run.

21 July 1944

3rd Marine Division opens battle for Guam.

24 July 1944

The V Amphibious Corps, landed on Tinian, in the Mariana Islands. The following morning, the 2nd and 4th Marine Divisions began a shoulder-to-shoulder sweep of the island and clear the airfield from which the Enola Gay would begin its historic flight to Hiroshima a year later.

25 July 1930

Lieutenant Lewis Puller wins first of five Navy Crosses chasing Sandino guerrillas in Nicaragua.

26 July 1947

President Harry Truman signs the National Security Act of 1947, reaffirming the status of the Marine Corps as a separate military service within the Department of the Navy.

26 July 1956

Marine battalion assigned to the Sixth Fleet evacuates civilians from Alexandria, Egypt following the canal's nationalization.

27 July 1953

Korean War ended – armistice signed at Panmunjon, Korea.

28 July 1779

Captain John Welsh and thirteen Marines killed in an assault on Fort George at Penobscot Bay, Maine.

28 July 1918

Brigadier General John A. Lejeune assumed command of the 2nd Division, U.S. Army in France, and remained in that capacity until August 1919 when the unit was demobilized. He was the first Marine officer to hold an Army divisional command, and following the Armistice, he led his division in the march into Germany.

Pentagon Nixes Name Change

NOTE – Following article appeared in the online version of the Washington Post's Federal Eye column by Ed O'Keefe, which was published on June 8, 2010

Citing costs and a potential impact on morale, the Defense Department has once again declined to support legislation that would change the name of the **Department of the Navy to the Department of the Navy and Marine Corps.**



A bipartisan band of lawmakers have tried for years to get the title “**Marine Corps**” added to the official name of the Department of the Navy, arguing among other reasons that the families of Marines killed in action deserve to see the name of their son or daughter's military branch on letters of condolence from the Pentagon. As in previous years, the bill is included in the House's version of this year's defense spending bill, but not in the Senate version – and probably won't get in the final version yet again.

In a letter released Monday, Defense Department General Counsel **Jeh Johnson** told the Senate Armed Services Committee that the Marine Corps is a “fully integrated, equal part of a great Navy and Marine Corps team,” but that renaming the department would add several hundred thousands of dollars a year in extra expenses and “would not enhance the standing or reputation of the Marine Corps.”

“A re-designation could be viewed as more than symbolic, and could easily be misinterpreted as a step away from the heritage and tradition of a strong Navy and Marine Corps team,” Johnson wrote in a letter to Armed Services Chairman **Carl Levin** (D-Mich.), who does not support the name change.

The cost argument seems the strongest, considering the Obama administration's renewed push to slash 5 percent from agency budgets, a plan modeled on the Pentagon's new budget cut program.

Corps Moves Forward with F-35

NOTE – Following article appeared in the online version of the Marine Corps Times on July 3, 2010 and was written by staff writer Amy McCullough.

Amid community concerns over the future location of **F-35B Joint Strike Fighter** squadrons, the Marine Corps is pushing forward with its basing plans. In May and June the Marine Corps released two environmental studies and continues to hold public meetings to address concerns.

There will be 22 operational squadrons spread among Marine Corps Air Stations Beaufort, SC, and Cherry Point, NC, on the East Coast, and Miramar, CA, and Yuma, AZ, on the West Coast, said Captain Craig Thomas, a Marine spokesman at the Pentagon. Seven of the 22 squadrons will have 16 aircraft, and the rest will have 10, although where they will be assigned has not yet been determined.

The East Coast also will have a pilot training center, and the West Coast will have an operational training and evaluation squadron.

The first operational squadron is planned for Yuma in 2012, although final approval to base the squadron there is not likely until December, Thomas said. The Corps also will begin phasing out its legacy aircraft in 2012.

But even as plans proceed, the troubled program continues to face scrutiny in Washington. At an estimated \$382 billion, the Joint Strike Fighter is by far the Pentagon’s most expensive acquisition program – a fact not lost on Defense Secretary Robert Gates, who is continuing his crusade to cut defense spending.

The Corps, though, is counting on the fifth-generation fighter to replace its EA-6B Prowlers, AV-8B Harriers, and F/A-18 Hornets.

Aviation Marines Repulse Taliban Attack

NOTE – The following article is about a Marine Corps Aviation Squadron of which your current detachment Commandant was once part. It is based upon an online Marine Corps Times article by staff writer Amy McCullough that was published on June 16, 2010.



Every Marine is trained first and foremost as a rifleman, but many who work in fields like aviation will never find themselves locked in close-quarters combat with the enemy.

But one Marine aviation unit, **Marine Tactical Electronic Warfare Squadron 2 (VMAQ-2)** out of Cherry

Point, NC, now deployed to Camp McCool, Afghanistan, recently found themselves pitted in a fight to the death with Taliban insurgents.

It was about an hour before sunrise on May 19, 2010 when **Pfc. Michael Craddock** – standing guard at the camp – thought he saw a shape moving over the top of the exterior perimeter.

Craddock, an aviation mechanic assigned to VMAQ-2, raised his M16 service rifle and zoned in.

With no direct line of communication from the camp to the rest of Bagram Air Base's security, he had no way of knowing that 45 minutes earlier, the two main entrances had been attacked.

When the five-hour firefight was over, at least nine U.S. service members, including two Marines from the EA-6B Prowler squadron, were wounded. One U.S. contractor and more than a dozen insurgents were killed in what is among the most intense ground fights involving a Marine Corps aviation squadron.

“You’d never expect VMAQ-2 to be engaged in close combat with the enemy, but the Marines performed amazingly well,” said **Lt. Colonel Todd Caruso**, the squadron’s commanding officer.

Surprise Attack...

It was about 4:00 AM (0400), and **Gunnery Sergeant Milledge Wilson** was on his way to take a shower when he noticed the Marines on sentry duty looked “distracted.” **Lance Corporal Ben Stellick** told him someone had just climbed over the exterior wall and was hiding in the brush.

Wilson and Stellick had walked about 10 paces when Wilson saw the spoon of a grenade fly into the air. In an instant, he heard an explosion, realized he had been hit in the stomach and then felt blood trickling down his forehead.

“I fired five or six times, then I fell back to the guard shack,” said Wilson, an EA-6B electrician who was working in the Quality Assurance Shop in Afghanistan.

Someone pulled the alarm, and the horn blasted, warning the other Marines in the squadron that the camp was under attack.

Outside the bunkers, several insurgents had climbed the 6-foot exterior barrier and dropped out of sight into the tall grass on the other side, Wilson said. They unleashed hand-tossed grenades, their AK47 assault rifles and rocket-propelled grenades on the camp.

Wilson was hit by shrapnel from a second grenade – this time in his right side – as he fired his M4. Before he could think about the wound, he heard a scream and saw Stellick lying on the ground “with blood coming out of his belt line,” he said. Wilson grabbed Stellick and started to drag him back to the center of camp where someone could provide first-aid, he said.

Meanwhile, Craddock, who was on his first combat deployment, stood alone outside the guard shack where he continued to return fire.

“I just fell back on my [training] at that point,” Craddock said by phone from Afghanistan.

Before Wilson and Stellick made it to safety, a third grenade exploded and shrapnel struck Wilson in the left leg. He was too weak to drag Stellick so he hid him behind a bunker, he said. Then he ran 30 feet to the center of the camp for help. “I finally heard small-arms fire coming from two airport guard towers guarding the perimeters. I felt comfortable that our gates were covered so I went to the bunker to get more help. I just stayed seated there because ... I was losing strength,” Wilson said.

Despite a hole in his abdomen the size of a penny, a small wound on his forehead, two gashes on his left tricep, wounds to his right leg and inner left calf, a big gash on his left inner thigh, another shrapnel wound to his back, two gashes on his left side and two holes in his left butt cheek, Wilson managed to brief Caruso.

“Within five to 10 minutes of the fireworks beginning, some helicopters also started laying down some fire,” Caruso said. “It’s really hard to say what bullets went where, but there were a lot of them.”

In a letter to families on the squadron's website, Caruso said, "All insurgents who attempted to breach our fence line were killed."

"After a thorough review of the events of the 19th, I can state with great pride that our two wounded Marines... through their brave and decisive actions, disrupted the enemy's planned attack and undoubtedly saved the lives of others," he wrote May 25.

Picking Up the Pieces...

Shortly after the sun rose, Wilson and Stellick were loaded onto the back of a pickup truck and evacuated to the hospital at Bagram. There, doctors performed surgery on Wilson's abdomen. Marine Corps Times could not reach Stellick, so it's unclear what injuries he sustained.

Both Marines were eventually evacuated to the National Naval Medical Center in Bethesda, Md., Caruso said. As of June 3, Stellick was not listed as a patient, and a hospital spokesman said the health information privacy act prevented him from saying whether he had been treated there.

Wilson said Stellick was released and is now recovering at home. After four surgeries on his leg, Wilson said he was hoping to be released June 4.

The F-35B is touted for its stealth and short-takeoff and vertical-landing capabilities. The Corps' jump jet variant broke the sound barrier June 10, flying 727 mph and into military aviation history books. It was the first time a STOVL aircraft reached supersonic speed, although the Air Force's conventional take-off and landing variant had already broken the sound barrier.

Eglin Air Force Base, FA, which serves as a joint F-35 training pipeline, will get the first Marine variants this year. The first students to funnel through the school will become the Corps' operational test and evaluation pilots in 2011, leaving Eglin for Edwards Air Force Base, CA, where they will continue operational tests of the aircraft.

Extensive environmental impact studies for both coasts, conducted by the Navy, cover topics such as noise and safety. Thomas said basing plans cannot be completed until the public review of the studies is complete. 
