Arlington Abuses Unearthed

At least 211 graves at Arlington National Cemetery — including two in the section where fallen troops from the Iraq and Afghanistan wars are buried — were mismarked, missing headstones or burial cards, or were not recorded at all, according to a new internal investigation.

The investigation of operations at the nation’s most hallowed military burial ground found no criminal misconduct, but much evidence of “improper internment, trans-

-internment of remains (including the loss of accountability of remains), remains in graves listed as empty, unmarked gravesites, improperly marked graves, and improper handling of remains,” Army Secretary John McHugh told reporters at the Pentagon on Thursday.

The Army Inspector General also concluded in its seven-month investigation that “mistakes continue to be made.”

The IG also found that rank-and-file employees, who handle an average of 27 funerals daily, were burdened in their day-to-day work by “**dysfunctional management, lack of established policy and procedures, and an overall unhealthy organizational climate.**”

“That all ends today,” McHugh said, offering an apology to those whose loved ones are resting at Arlington.

The errors affected graves in **Sections 55, 59, 60 and 66.**

“There is simply no excuse,” McHugh said. “On behalf of the United States Army, and on behalf of myself, I deeply apologize to the families of the honored resting in that hallowed ground, who may now question the care for their loved ones.”





Arlington Unearthed

McHugh said the Army, as the executive agent for Arlington, will "initiate those steps necessary to best correct yesterday's oversights, and meet tomorrow's requirement."

McHugh said he has demoted John Metzler, the long-time Arlington superintendent who is slated to retire July 2, given him a letter of reprimand, and directed a review of his annual performance evaluation award, which had been placed on hold pending the completion of the IG report, "in contemplation of a downward adjustment."

Metzler will now report to Kathryn Condon, who will fill the newly created position of executive director of the Army National Cemeteries Program and will, among other duties, implement "corrective measures outlined in the investigation and inspection reports."

McHugh also has placed Deputy Superintendent Thurman Higginbotham on immediate administrative leave "pending the completion of other personnel actions."

McHugh has told the assistant Army secretary for reserve affairs to review the IG reports, "and decide whether any further disciplinary action should be performed."

The report cites 76 findings and 101 recommendations, most of which, McHugh said, "are both deeply troubling, and simply unacceptable."

He said he was disturbed to learn that some of the findings are repeated deficiencies that were detailed in a 1997 inspection report by the Military District of Washington Inspector General — "**deficiencies which apparently have gone largely unaddressed for the past 12 years,**" he said.

The Army IG also found that a supervisor whose name was blacked out of the report "failed to conserve government resources," in particular by failing to properly implement a plan to automate all Arlington administrative operations.

In one instance, the supervisor paid a contractor at least \$200,000 for work that was not completed.

The IG recommended that all cemetery contracts, contracting procedures and budget execution procedures be audited, a step McHugh approved.

Legislative Report

There is activity in Washington involving the Department of Defense, the administration and Congress to consider the lifting of the ban on the **Don't Ask... Don't Tell** policy regarding military service by openly gay members. A provision, to eliminate the ban (allow service by openly gay individuals) has been folded into the 2011 Defense Policy bill.

The **Chiropractic Care For All Veterans Act, HR 1017**, is in the works to expand and offer chiropractic care at **all** VA facilities. At the present time, this type of care is only available at 25 locations.

It appears that it will be difficult to pass any provision of the Defense budget to authorize **Combat-Zone Pay and Benefits** to troops killed or injured in a domestic terrorist attack, such as that which occurred at Ft. Hood, Texas. For the near future, compensation for such domestic death or injury would have to be made available through approved special compensation. A more definitive program, outlining the circumstances, is needed to avoid misinterpretation and unfairness regarding the judgment made about the suggested benefit, incident by incident.

Lest We Forget...

John Dewey Kovacevich Jr., 60, a resident of Crofton, and retired United States Marine Corps Major, died May 17 at his home in Crofton, Maryland.

Major Kovacevich was born on July 7, 1949, in Rome, GA., and was raised in Lookout Mountain, TN. He graduated from Baylor School in Lookout Mountain in 1968, received his B.A. from the University of Virginia in 1972, where he was a member of the Eli Banana Society, and his M.B.A. from Averett College in 1993.



Major Kovacevich served in the U.S. Marine Corps from 1973 until his retirement in 1993. He was a Communications Officer, who served with the 10th Marines in Okinawa, Japan; as a Series Commander at MCRD Parris Island, S.C.; as Communications Officer for Marine Barracks, Guantanamo Bay, Cuba; as Commander, Communications Company, 2nd Force Service Support Group, Camp Lejeune, N.C.; as Executive Officer, Marine Corps Communications Squadron 18, Okinawa, Japan; as a Test Officer, Marine Corps Operational Test and Evaluation Activity, Quantico, VA.; as Detachment Commander, Detachment B, Marine Wing Communications Squadron 28, MCAS New River, N.C., and as Information Systems Security Coordinator, Headquarters Marine Corps, Arlington, VA. His awards include the Meritorious Service Medal, Navy Commendation Medal, and the Navy Achievement Medal.

After his retirement, he worked as a stockbroker at Bank of America in Orange County, CA.; Bank of Bowie in Bowie, MD.; and Harbor Investments in Annapolis, MD.

He is preceded in death by his father, **John Dewey Kovacevich Sr.** who died in 2002.

He is survived by his wife, **Sharon Pfeiffer**, whom he married in 1988; daughter, **Marcy Kovacevich** of Fullerton, CA.; son, **Sam Kovacevich** of Boston, MA.; grandsons, **Aidan** and **Alasdair Staggs** of Fullerton, CA.; sister, **Ellen Hanna** of St. Louis, MO.; and his mother, **Margaret McMillin Kovacevich** of Chattanooga, TN.

Major Kovacevich will be interred with Full Military Honors at Arlington National Cemetery at 1:00 PM, on Wednesday, September 8, 2010. Please arrive at the chapel by 12:30 PM.

Corps History

1 June 1918

"Retreat Hell! We just got here," said the 5th Marine Regiment in France.

1 June 1942

First black Marine enlists in the Corps. A total of 19,168 will join the Corps during World War II.

2 June 1918

German *28th Division* attacks the American *2nd Division*, including the 4th Marine Brigade. The Marines open with deadly rifle fire and help hand the German troops a setback which set the stage for Marine victory at Belleau Wood.

5 June 1944

Lieutenant General H. M. (Howlin' Mad) Smith is designated the first FMFPac Commander.

6 June 1853

Marines escort Commodore Matthew C. Perry ashore at Naha Okinawa.

6 June 1918

Marines advance into Belleau Wood against German machine guns.

8 June 1880

Captain W. B. Remy becomes first Marine appointed as Judge Advocate of the Navy.

8 June 1995

Team of 40 Marines rescues downed USAF pilot, Captain Scott O'Grady, who had been shot down over Bosnia-Herzegovina six days earlier.

10 June 1871

Captain McLane Tilton leads 109 Marines in naval attack on Han River forts in Korea.

10 June 1898

1st Marine Battalion led by Lieutenant Colonel Robert W. Huntington lands at Guantanamo Bay, Cuba.

12 June 1948

President Truman authorizes first women Marines in the regular Marine Corps.

12 June 1961

President John F. Kennedy signs a Presidential Proclamation calling for the American flag to be flown at the Marine Corps War Memorial in Arlington, Virginia, "at all times... day and night."

14 June 1898

Sgt. John Quick exposes himself to hostile fire in order to signal the USS *Dolphin* (a gun-fire support vessel) to cease fire; thereby saving his Marine unit and earning the Medal of Honor.

15 June 1944

The V Amphibious Corps assaults the west coast of Saipan, Marianas Islands. By nightfall, the 2nd and 4th Marine Divisions, moving against heavy opposition, *establish a beachhead 10,000 yards wide and 1,500 yards deep.*

18 June 1945

Major General Roy S. Geiger, USMC, assumes command of the 10th Army during the battle for Okinawa after Army Lieutenant General Simon Buckner is killed.

20 June 1993

The 24th Marine Expeditionary Unit returns to Mogadishu, Somalia, to stand ready to assist United Nations forces in maintaining peace in the war-torn country.

21 June 1945

The battle for Okinawa ends with the raising of the American flag by Lieutenant General Roy S. Geiger, USMC.

22 June 1954

President Eisenhower authorizes the use of the first official Marine Corps Seal.

23 June 1812

Marine Lieutenant John Heath becomes first casualty of the War of 1812.

23 June 1836

Colonel-Commandant Archibald Henderson and 462 Marines report for duty in the Second Seminole War.

23 June 1980

Marines land in Lebanon to evacuate civilians.

25 June 1950

Korean War begins when North Korean forces invade South Korea.

25 June 1971

Last Marine ground troops depart Vietnam.

26 June 1918

Brigadier General James G. Harbord, the Commanding General of the 4th Marine Brigade, notifies American Expeditionary Force Headquarters that Belleau Wood was "now U.S. Marine Corps entirely." After 20 days of combat, and at a cost of over 4,000 casualties, the 4th Brigade of Marines had proven its fighting heart. The grateful Commander of the French Sixth Army would soon decree that in all official correspondence, Belleau Wood would henceforth bear the name, "Bois de la Brigade de Marine."



DoD Against Change

WASHINGTON (Reuters) – The Defense Department said, it opposed as potentially divisive, a push in Congress to give the Marine Corps equal billing in the Department of the Navy.

A Senate bill would rename it the Department of the Navy and Marine Corps.

"A re-designation could be viewed as more than symbolic, and could easily be misinterpreted as a step away from the heritage and tradition of a strong Navy and Marine Corps team," said **Jeh Johnson**, the Pentagon's general counsel.

Renaming is "*unnecessary, would incur additional expense of several hundred thousand dollars a year over the next several years ... and would not enhance the standing or reputation of the Marine Corps,*" he said.

The Navy and Marine Corps, which calls itself "*The Few, The Proud,*" have functioned as "*one team led by one Secretary*" since Benjamin Stoddert was named the first Navy secretary by President John Adams in 1798, Johnson wrote.

He made his comments in a May 26 letter to Senate Armed Services Committee Chairman Carl Levin, whose office released the letter Monday. Levin agrees with the Pentagon and opposes re-designating, said his spokeswoman, **Tara Andringa**.

Government Contests Ruling

NOTE – The following Associated Press article was published in the online version of the Marine Corps Times on June 7, 2010.

SAN DIEGO — The government is appealing the overturning of a Camp Pendleton Marine's murder conviction in a major Iraqi war crimes case.

Representatives of the Navy Judge Advocate General's Corps announced Monday that the case of **Sergeant Lawrence Hutchins III** will be sent to the U.S. Court of Appeals of the Armed Forces.




That court can either affirm or reverse the April ruling of the U.S. Navy-Marine Corps Court of Criminal Appeals. The criminal appeals court overturned Hutchins' conviction, saying he was not given a fair trial because a judge allowed his lead defense attorney to leave shortly before his 2007 trial.

Prosecutors say Hutchins led a squad of seven Marines, who killed an unarmed man in Hamdania – a small village west of Baghdad near Abu Ghraib – in 2006. The 26-year-old Marine had previously been sentenced to serve 11 years of confinement.

States Against Funeral Protests

WASHINGTON — Forty-eight states and the District of Columbia have submitted a brief to the Supreme Court in support of a father who sued anti-gay protesters over their demonstration at the 2006 funeral of his son, a Marine killed in Iraq.

Only Virginia and Maine declined to sign the brief by the Kansas Attorney General.

Albert Snyder sued over protests by the Kansas-based **Westboro Baptist Church** at his son's funeral in Maryland. The church pickets funerals because they believe war deaths are punishment for U.S. tolerance of homosexuality.

The Supreme Court has agreed to consider whether the protesters' message is protected by the First Amendment.

In the brief filed Tuesday, the states argued they have a compelling interest in protecting the sanctity of funerals.

General Amos Next Commandant ?

NOTE – The following is based upon a Marine Corps Times article posted on the Internet on July 15th, which was written by staff writer, Christopher P. Cavalas.

General James Amos is expected to be named the **35th Commandant** of the **U.S. Marine Corps**, sources told Defense News on Monday. If nominated, Amos could become the first Marine jet aviator named to the top post, and he would alter recent custom by becoming the first assistant commandant in several decades to succeed his immediate boss.

A source confirmed that the White House has received the nomination from **Navy Secretary Ray Mabus**, who made the choice with the blessing of **Defense Secretary Robert Gates**. An announcement of the nomination will come from the White House, and could come as soon as this Thursday, the day the executive branch habitually releases personnel statements.

Speculation has been building about the successor to **General James Conway**, who retires in September. In addition to Amos, other leading candidates were thought to be: **Lt. Gen. Joe Dunford**, commanding general of I Marine Expeditionary Force and commander of Marine forces in U.S. Central Command; **Lt. Gen. John Allen**, deputy commander of Central Command; **Lt. Gen. Richard Natonski**, commander of Marine Corps Forces Command; and **Gen. James Mattis**, commander of Joint Forces Command.

Some sources are pointing to Dunford as the nominee for assistant commandant, but that move has not been confirmed.

Amos commanded the 3rd Marine Aircraft Wing from 2002 to 2004 during Operating Iraqi Freedom and subsequently led II MEF. He also commanded the Marine Corps Combat Development Command and served as the deputy commandant for Combat Development and Integration. He has been assistant commandant since July 2008.

The choice of Marine Corps commandant is the first service chief pick made by Mabus, who reportedly talked to every three- and four-star general in the Corps about the leadership choices. Mabus, should he remain in office, could also have the chance next year to name the next chief of naval operations, as current CNO Adm. Gary Roughead's term expires in September 2011.

Symbolism of Our Flag

The U.S. flag is the most widely used symbol of America, representing the many freedoms and rights guaranteed to us by the U.S. Constitution and Bill of Rights. Additionally, the flag symbolizes the patriotism, honor and courage of all of you, our U.S. Veterans and military personnel, along with our individual liberties stated in the Declaration of Independence. Many other powerful meanings that define America are represented in our flag as well.

“We take the stars from Heaven, the red from our mother country, separating it by white stripes, thus showing that we have separated from her, and the white stripes shall go down to posterity representing Liberty.” – George Washington


On June 14, 1777, the Flag Resolution was passed by the Second Continental Congress, which stated: *“Resolved that the flag of the United States be made of thirteen stripes, alternate red and white; that the union be thirteen stars, white in a blue field, representing a new Constellation.”* Each year thereafter, June 14 has been known as Flag Day.

The U.S. flag consists of thirteen equal horizontal stripes of red (top and bottom) alternating with white, representing the thirteen original colonies, with a blue rectangle in the upper hoist-side corner bearing 50 small, white, five-pointed stars, representing our 50 states. Common names of the flag include: *“the Stars and Stripes”* and *“Old Glory.”*

Even to this day, the origin of the U.S. flag design is still uncertain. One story credits **Betsy Ross** for sewing the first flag from a pencil sketch by **George Washington**. However, no evidence exists beyond the recollections of what she told her family, which have been reported by her descendents.

When design changes occur, the change always takes place on July 4th in Philadelphia, Pa., stated by the Flag Act of April 4, 1818. The most recent change – from forty-nine stars to fifty – was the design of **Robert G. Heft** and occurred in 1960, after Hawaii gained statehood in August 1959.

Last Iwo Jima Chaplain Dies

NOTE – This article is based upon emails that I have received and an article from the online edition of the Boston Herald article written by Benjamin Bell (posted on May 21, 2010).

In the bloodiest days of Iwo Jima, he spoke the last words over fallen Marines and Navy Corpsmen as they were buried in the island's black sand. On Sunday, 16 May 2010, Reverend E. Gage Hotaling died, 65 years after the iconic battle for that Pacific island. On 20 May 2010, Marines, sailors and soldiers returned the favor, sending the old Navy chaplain on to join his comrades with military honors.

Hotaling was the last surviving chaplain, who served ashore with the Marines on Iwo Jima. He joined the Chaplain Corps at age 28 in 1944 because he didn't feel he could preach to the WW II generation unless he knew what they had endured, so he found himself with the 4th Marine Division on Iwo Jima. Some of his experiences on Iwo Jima are included in the book, *Flags of Our Fathers*, which tells the stories of the men who raised the American flag during the battle, which took place in February 1945. Of the 6,821 Americans killed, Reverend Hotaling believed he buried about 1,800.

In a 2007 documentary, he talked about the grim task he faced as Marines fell in bitter combat against the dug-in Japanese enemy. "We would have four Marines with a flag over each grave. And while they were kneeling with the flag, I would stand up and I would give the committal words for each one," he told the filmmakers. He also said that he took up smoking to overcome the ever-present stench of decay. "I did it not as a Protestant, Catholic or a Jew, but as a Marine," the Baptist minister said. "Every man was buried as a Marine. And so I gave the same committal to each one."

A Marine Corps honor guard stood by as family members and other veterans paid their respects at the Veterans' Memorial Cemetery in Agawam, Massachusetts.
