

## A Member Lost... A Friend to Remember!



**Denny Bynum**

November 28, 1933 – April 17, 2010

It is with extreme sadness, that we report the passing of a valued detachment member and dear friend, **Denny Bynum**. Denny was born on November 28, 1933 and passed-away on April 17, 2010, at 9:40 PM. He was 76 years of age.

Denny was a loving husband, father, and brother. He was also a treasured friend to those of us who served our nation as members of its armed forces and those who were members of those social and philanthropic organizations to which Denny devoted so much of his indefatigable energy and dedication.

A native of Oklahoma, Denny enlisted in the Marine Corps and served honorably from 1954 through 1957. He subsequently entered the U.S. Army where he served honorably from 1957 through 1979. A Vietnam Veteran, Denny earned the highly prized *Combat Infantryman's Badge* plus numerous other medals.

A valued member of Anne Arundel County Detachment 1049 of the Marine Corps League, Denny was a Pedigreed Devil Dog and the 2009 Dog of the Year for Hound Dog Pound 204. He also served as Junior Vice Commandant of the detachment in 2005, and was an integral part of our detachment's Rifle and Pistol Team.

His other affiliations included membership in American Legion Post 276; VFW Post 160; Military Order of the Cooties, Pup Tent 3; International Order of Old Bastards; Fleet Reserve Association, Fort Meade Branch 212; Garrison Rifle and Revolver Club; VAVS Hospital Volunteer Service; Masons (Odenton Lodge 209, York Rite Lodge); Sojourners, Odenton; and the Tall Cedars of Lebanon.

Denny is survived by his wife, Kazuko; sons, Michael and Denny Jr.; daughter, Michele; and his sister Vera.

Viewing and memorial services were held on Saturday, 24 April 2010 at the Donaldson Funeral Home & Crematory in Odenton, MD. Plans are currently being finalized for Denny's interment on Wednesday (April 28th) at the Crownsville Veterans Cemetery.

His attitude on life, living, work, family, and friends always astounded me as he was always upbeat and positive. I just wish that at times I could be as positive.

His passing – or as they say “his preparing the way, for those of us who will follow” – really brings home the message that it is not for the dead that we should mourn but those of us who remain behind. The challenges of the future will be far more difficult to endure without having Denny Bynum around to help us through life’s journey.

I am truly sorry that I did not meet Denny Bynum sooner in my life; however, I am definitely a richer man for meeting him when I did.

# Another Sad Loss

NOTE – The following is a minimally edited version of Wyman Bailey's obituary, which was provided by his daughter Karman Green.

**Wyman Nathaniel Bailey** died on Monday, March 22, 2010 at John Hopkins Hospital in Baltimore, MD. He was 59.

Born on August 20, 1950 in Newport, Rhode Island, he was the son of Laura Rose Bailey. He grew up in Rhode Island and enlisted in the Marines during Vietnam. After being honorably discharged, he re-enlisted in the U.S. Army.



In June of 1972, while stationed at Ft. Devens, Massachusetts, he met Karen Abbott whom he married on February 16, 1974 at Fort Sill, Oklahoma.

Mr. Bailey had military service overseas in Europe as an active duty service member, earning an Overseas Service Ribbon, National Defense Service Medal, Basic Recruiter Badge, and Vietnam Campaign Medal during his military career. After retiring from the Army at Ft. Meade in 1986, he worked for the Department of Defense as an archives specialist until his retirement in 2009.

He was a member of MCL Detachment 1049; American Legion Post 196; VFW Post 160, where he was a past Commander; and most recently, VFW Post 7464, where

he was a past chaplain. He enjoyed karaoke and cooking.

Mr. Bailey is survived by his wife, Chen Feng Bailey; his loving daughter, Karman Bailey Green; four grandchildren, Mikada Rose Green, Mokennon Bailey Green, Willow Ann Eslin, and Riley Ann Eslin. In addition to his family he is survived by the people closest to him since he's been in Maryland; Jimmy and Terri Carter, their children and his godchildren, Jason Michael Carter, Matthew Jeremy Carter and Alannah Taylor Carter. He was preceded in death by his previous wife, Karen Ann Abbott Bailey in 2004.

The family held a celebration of Wyman's life on Friday, April 9, 2010 at Fellows, Helfenbein and Newman Funeral Home in Chester, MD and continued at the VFW Post in Grasonville later that evening. Interment will take place in Arlington National Cemetery at a later date.

## Marine's Dad Gets Help With Court Costs

NOTE – The following is a reprint of an Associated Press article, which appeared in the April 1, 2010 online edition of the *Marine Corps Times*.

BALTIMORE — People around the country are chipping in to help the father of a Marine killed in Iraq after a court ordered him to pay the anti-gay church he's been battling in court.

**Albert Snyder** of York, Pa., is suing the **Westboro Baptist Church**, whose members picketed the funeral of Snyder's son, **Lance Corporal Matthew Snyder**. The Topeka, Kansas-based church contends that U.S. military deaths are God's punishment for tolerance of homosexuality.

The U.S. Supreme Court has agreed to hear arguments on the case.

Meanwhile, an appeals court has ordered Snyder to pay \$16,510 in appeal costs to Westboro founder Fred Phelps. Snyder tells The Baltimore Sun he's received about 3,000 emails from people, who planned to contribute to the payment. The American Legion is also asking people to donate.

NOTE – Fox News commentator Bill O'Reilly has pledged to pay Mr. Snyder's court costs and the American Legion is also soliciting donations on behalf of Mr. Snyder.

# Special Extra Earnings for Military Service

NOTE – The following Article appeared in the 1st Quarter, January-March 2010, edition of Semper Fidelis – Memorandum for Retired Marines.

Since 1957, if you had military service earnings for active duty (including active duty for training), you paid Social Security taxes on those earnings. Since 1988, inactive duty service in the Armed Forces reserves (such as weekend drills) has also been covered by Social Security.

Under certain circumstances, special extra earnings for your military service from 1957 through 2001 can be credited to your record for Social Security purposes. These extra earnings credits may help you qualify for Social Security or increase the amount of your Social Security benefit. Special extra earnings credits are granted for periods of active duty or active duty for training. Special extra earnings credits are not granted for inactive duty training.

## If your active military service occurred:

**From 1957 through 1967**, we will add the extra credits to your record when you apply for Social Security benefits.

**From 1968 through 2001**, you do not need to do anything to receive these extra credits. The credits were automatically added to your record.

**After 2001**, there are no special extra earnings credits for military service.

## How You Get Credit For Special Extra Earnings

The information that follows applies **only** to active duty military service earnings from 1957 through 2001. Here's how the special **extra** earnings are credited on your record:

### Service in 1957 Through 1977

You are credited with \$300 in additional earnings for each calendar quarter in which you received active duty basic pay.

### Service in 1978 through 2001

For every \$300 in active duty basic pay, you are credited with an additional \$100 in earnings up to a maximum of \$1,200 a year. If you enlisted after September 7, 1980 and did not complete at least 24 months of active duty or your full tour, you may not be able to receive the additional earnings. ## Action Needed to Fix TRICARE

NOTE – The following article appeared online in the Benefits section of Military.com published on April 12, 2010.

As of April 1, 2010, **Medicare and TRICARE payments to physicians were cut by 21 percent**. The reduced payment rate may result in fewer doctors being willing to accept TRICARE, which could leave millions of seniors and military beneficiaries without a primary care provider. Organizations like the Military Officers Association of America are urging the Senate to pass **HR-4851** which would extend the current payment rate until May 1, 2010. The Senate is considering taking action on H.R. 4851 but it is being delayed over technical budget details.



## Ermey Behind Name Change

Retired Gunnery Sgt. R. Lee Ermey, widely known for his performance as the sadistic drill instructor in the 1987 film *Full Metal Jacket*, headlined a news conference in Washington, D.C., and called for the renaming of the *Department of the Navy* to the *Department of the Navy and Marine Corps*.

"We're not asking for a promotion. We're not asking for more money. We don't want a uniform change," Ermey said. "The only thing we want is for future Marines who shed blood for their country to at least get respect and receive honorable mention in the department they fall under."

The Marine Corps operates under the Department of the Navy. Families of Marines who die in combat receive condolence letters on Navy letterhead – with no mention of the Marine Corps.

Ermey said a major reason for his involvement with the campaign was to properly honor Marines who have fought and died in battle.

"When the family of a fallen Marine receives a condolence letter, the Marine Corps name should be proudly mentioned."

The **Marine Corps Identity Cause** is a grassroots campaign founded in 2009 to give Marines equal status with the Navy. The campaign, sponsored by the Marine Corps League, has one simple, but important, goal: To get Congress to change the organizational name from *Department of the Navy* to *Department of the Navy and Marine Corps*.

## VA Health Care in Your Community

You may have noticed representatives from the VA Maryland Health Care System at your local senior expos, community fairs, and even at your local mall. That's because the health care system has been actively attending community outreach events throughout the state to help inform and educate veterans about their eligibility for VA health care.

In addition, the VA Maryland Health Care System recently hosted four open houses and information fairs for veterans and their family members at the Perry Point VA Medical Center and the Cambridge, Fort Howard and Loch Raven VA Outpatient Clinics. These open houses and information fairs brought in more than 200 new veterans to enroll for VA health care, with an additional 80 veterans who are already active in the VA attending to update their VA means test, schedule a clinic appointment or subscribe to the **My HealthVet** website (<http://www.myhealth.va.gov>). Marines locate seven American soldiers held prisoner by the Iraqis near Samarra.

### 14 April 1865

Marines guard the body of John Wilkes Booth after Abraham Lincoln's assassination.

### 15 April 1962 (Palm Sunday)

# Young Marines

## General Assembly Update

Based on the closing activities of the politicians in Annapolis, there was not much accomplished regarding two major areas that we have been following: *slot machines in Veteran's organizations* and an *increase in the income tax deduction under the Subtraction Modification allowance*.

**Results:** Nothing!

Two bills, **HB 203** and **SB 237** – *Sales and Use Tax – Exemptions – Veteran's Organizations* did pass.

Apparently there was an attempt to aid/support our veterans with bills dealing with military retirement income tax and military health care, but they were not passed.

A total of 82 bills were considered, all dealing with veteran's interests, 23 were passed.

On a different note: the **US Veterans Affairs Department** is anticipating over *185,000 new disability claims* as a result of new rules that presume a service connection for certain illnesses related to *Agent Orange exposure in Viet Nam*. The VA Secretary and Congress have established the hiring of 1,800 new processors to speed up the claim procedure. The VA anticipates receiving a total of 1.3 million claims during 2011, for all types of disability.

# Any Marine Would Have...

NOTE – Article by James K. Sanborn, staff writer for the *Marine Corps Times*, which appeared in the Sunday, April 11, 2010 online edition of the publication.

Hippopotamus attacks aren't covered during standard Marine training, but that didn't stop one Corporal from rushing to the aid of a married couple while on safari in Zimbabwe after their inflatable canoe was flipped and the husband mauled.

**Corporal Justin Trinidad**, 24, a Marine security guard at the U.S. embassy in Zimbabwe, was with his girlfriend, **Kaylynn Hankey**, when a hippo attacked their tour group on the Zambezi River in mid-March. About 30 minutes into the trip, the group – which included four canoes – asked for a break. As they headed for shore, tour guides spotted the hippo and yelled for the canoes to move away, but **Javier** and **Patricia Franco** didn't hear the warning.

"I look back and all I see is Mr. and Mrs. Franco thrown up in the air a few meters," Trinidad told the *Marine Corps Times* in a telephone interview from Africa.

Patricia Franco was thrown clear of the hippo, but her husband came down almost on top of it. That's when the animal chomped down on his leg, nearly severing his foot, Trinidad said.

"She was screaming 'Help us; he has no leg,'" he said.

Despite his girlfriend's initial reluctance, Trinidad started to paddle toward the couple.

"All I could think of was just, 'God watch over us, help us.' We were expecting any time for the hippo to come under us and just launch us into the air," he said.

Eventually, they reached the distraught couple, who clung to the canoe as Trinidad began rowing for land. However, a swift current threatened to carry them downstream into rapids.


Hankey tried to stop them by grabbing a tree branch, but she was pulled from the canoe. Fortunately, with the help of a guide, she made it safely to shore.

Trinidad continued to fight the current and found a shallow spot where Patricia Franco was able wade to shore, but her husband was unable to stand and the canoe again spun out of control. It finally snagged on a rock, and Trinidad was able to pull Javier Franco into the craft and get him to shore.

"That's when I realized his foot was hanging by a piece of skin. He started bleeding a lot and I could see bone. It was pretty gruesome," he said.

Using a makeshift tourniquet, Trinidad stemmed the bleeding, but Franco was screaming in pain.

"I was talking to him, trying to keep him from going into shock," he said. "...then, I remembered from the safety brief that the guides had told us to not make loud crying noises because wildlife might think you are wounded prey and come over and eat you."

A family, who had been fishing nearby, transported them by truck to a nearby hospital where conditions were crude at best. Knowing that Franco's wounds required better medical attention, Trinidad called the U.S. embassy and arranged for air transport to Johannesburg, South Africa, more than 500 miles away.

"He is still undergoing many surgeries," Trinidad said. "Doctors weren't able to save his foot, but his kids and wife are grateful that he is still alive, because he could have bled to death. They said he is very positive, and that he is going to get an artificial limb."

Trinidad, whose father died when he was young, said he was happy to save somebody's mom and dad.

"I was just in the right place at the right time," he said. "I'm no hero. Any Marine would have done the same thing."

## A Night with Honor Flight



Recently, on the evening of April 14th, three members of our detachment's Color Guard and one supernumerary had the privilege of being part of an **Honor Flight** ceremony at the BWI Airport Hilton. **Woody Bowman**, **Charlie Young**, and **Chris Kalwa** presented the colors at this event while **Mac McNeir** took photos of the occasion.

After dinner, Marines of the era being honored and their escorts, many of whom were members of the **Marine Corps League's Lake Havasu Detachment 757**, invited us to accompany them to the hotel's 'slop-chute' where sea-stories and spirited beverages were served in great abundance. As the evening grew late, our assemblage received a free round of drinks from some anonymous donor(s), whose identity we pried from our waitress. Our benefactors were a couple of retired Marine Corps pilots, who took notice of our gathering as they entered the bar. The camaraderie experienced during and after the ceremony were responsible for a truly memorable experience.
