# Cherished Member Lost

At approximately 10:00 pm, on the evening of April 27th, **Kenneth R. Rollins** – known to many of us as Kenny – passed away after having been discharged from Harbor Hospital. Kenny had just been discharged from his most recent hospitalization of nine days and was transported by ambulance to the home of one of his

daughters in Dallastown, PA. He had been under hospice care since Monday, April 25th.

Kenny was a member of various organizations, Marine Corps League, Anne Arundel County Detachment 1049; Military Order of Devil Dogs, Pound 204; 1st Marine Division Association; Marine Corps Heritage Foundation; VFW Post 160; Military Order of the Cooties, Pup-Tent 3; Masonic Lodge 209; Tall Cedars of Lebanon of North America, Annapolis Forest 126; Sojourners; American Legion Post 276; and Cherry River Navy of West Virginia.

Kenny is survived by his two daughters, Karen of Dallastown, PA; Kathleen of Pasadena, MD; and two sons, Karl currently residing in California and Kevin currently residing in Florida. Karl and Kevin are twin brothers and both served four years in the Marine Corps during the same period of time.

Kenny served as a Master Sergeant with the Maryland National Guard after his discharge from the Marine Corps. Kenny was a very well experienced carpenter and metal worker with a keen eye for detail and a drive for perfection in the work he performed aboard a roving working tender repairing damaged ships and piers along the eastern seaboard. He was later employed as a supervisor responsible for the maintenance of all state owned buildings within the state of Maryland until his retirement. Among his service decorations were the Korean Service and United Nations Medals.

Per his request he was returned to Anne Arundel County, MD and cremated. His ashes were subsequently interred at the Crownsville Veterans' Cemetery.





## Legislative Report

The *military retirement system* is under scrutiny by a review board that may have recommendations to assist the Secretary of Defense's plan to combat future budget deficits. One advisor suggests that the military will have to choose between the current pension system and major weapons programs. Various elements under consideration are: Delay pension checks until a later age after retirement (could be several years); End the 20-year vesting, to be extended; offer postponement of pension check in order to gain a larger payback after age of 62 and offer of military to contribute up to 5% matching funds of member's pay towards a retirement fund under the control of the service member. These are ideas effecting future retirees.

The sad news, regarding the processing of VA disability claims, is the numbers continue to climb as to numbers of claims; processing time and final award decisions. There are several complaints stated as to why the delay of processing has increased from four months to eight or nine months. One obvious concern is the inability of the VA to anticipate the number of claims as the result of our two major wars and Viet Nam. The VA continues to attempt to lessen the delay time for the benefit of the veteran.

The Young Adult Tricare insurance coverage has been extended to under the age of 26 for dependents. The cost will be approximately \$200 per month for those young people, who are not married and do not have access to health insurance through their employer or school.

# Remembering Our Dad...

*The following comments were made by Karl R. Rollins during memorial services for his father, Kenneth R. Rollins, at the Crownsville Veterans Cemetery.*

Our dad, **Kenneth R. Rollins** was born the oldest of five siblings in Greenville, Tennessee. His mother died at the age of twenty-five, when he was eight years old. When he was fourteen, his dad moved them to Odenton, Maryland. His father went into the Army during World War II.

Kenneth (my dad) worked at the United States Naval Academy Farm in Gambrills, Maryland. In 1949, at the age of nineteen, he joined the United States Marine Corps Reserve. On 25 August of 1950, he was called to active duty and fought in the Korean War. He attained the rank of Sergeant before being honorably discharged on 12 April 1952. Subsequently, he joined the Army National Guard, where he attained the rank of Master Sergeant. He worked for the federal government's General Services Agency (GSA) until his retirement.

Our dad was the master of many trades... skilled in carpentry, plumbing, electrical projects, masonry, lock-smithing, automotive maintenance/repair, etc. He helped many people by fixing or building things for them. Dad belonged to many organizations, which kept him busy throughout his retirement.

I know that all of us who knew him will miss him very much.

## Veteran's Affairs

by Ed Dahling

The Department of Defense (DoD) plans to ask Congress to enact a law to permanently peg the rate of increase for **Tricare Prime** premiums to the **National Healthcare Expenditure (NHE) Index**. This increase targets military retirees under age 65.

A DoD official told the press that the decision to use the NHE Index was made because it was transparent, easy to understand, and fair. But, the NHE Index was 3.1 per-cent in 2009; and over the past 25 years, the average annual increase has been 6.4 percent.

This 6.4 per-cent average increase is huge when compared to the cost-of-living-adjustment for military retiree pay.

Many veterans' organizations have been pushing to peg the TRICARE Prime premium increase to the annual COLA, which is tied to the Consumer Price Index. **Jimmie L. Foster**, national commander of The American Legion said that the *"DoD plan is unacceptable. Many of our military retirees live on fixed incomes and their COLA just doesn't keep up with the National Health Expenditure Index."*

Over the last 25 years, the COLA increase has averaged 2.8 percent; 3.6 per-cent less than the rise in national health expenditures. This will mean more out-of-pocket expenses for military retirees and their families.

Is this a "fair" increase for retirees who have not seen a COLA increase since 2008? Let your elected officials know how you feel about this issue.

## Corps History

### **2 May 1946**

Marines from Treasure Island Marine Barracks, under the command of Warrant Officer Charles L. Buckner, helped suppress the three-day prison riot at Alcatraz Penitentiary in San Francisco Bay.

### **3 May 1898**

Marines from the U.S.S. Baltimore raise the Stars and Stripes over the Cavite Naval Station.

### **6 May 1937**

Marines at NAS Lakehurst helped rescue Hindenburg survivors.

### **6 May 1946**

Commandant Archibald Vandergrift tells Senate Naval Affairs Committee that 'the bended knee is not a tradition of our Corps.'

### **10 May 1945**

The 22nd Marines, 6th Marine Division, executed a pre-dawn attack south across the Asa River Estuary and continued the attack toward Naha, the capital of Okinawa.

### **15 May 1862**

Corporal John Mackie, the first Marine to earn the Medal of Honor, was commended for service on the USS GALENA during action against Confederate shore batteries at Drewry's Bluff, which blocked the James River approaches to Richmond.

### **16 May 1945**

The 22nd and 29th Marines continued the attack against Half Moon Hill, a day characterized by the 6th Marine Division as the 'bitterest' of the Okinawa campaign. By the 18th, the famed 'Shuri line' had been breached.

### **22 May 1912**

First Lieutenant Alfred A. Cunningham, the first Marine officer to be assigned to 'duty in connection with aviation' reported for aviation training at the Naval Aviation Camp at Annapolis, MD.

### **23 May 1988**

The V-22 Osprey, the world's first production tilt-rotor aircraft, made its debut during rollout ceremonies at Bell Helicopter facilities in Arlington, Texas.

### **26 May 1969**

Operation Pipestone Canyon began when the 1st Battalion, 26th Marines and 3rd Battalion, 5th Marines began sweeps in the Dodge City/Go Noi areas southwest of Da Nang. It terminated at the end of June with 610 enemy killed in action at a cost of 34 Marines killed.

### **31 May 1900**

Marines reach Chinese capital to defend Legation Quarter from Boxer rebellion.



# About the Education Center at the Wall

For many, the Vietnam War is from the distant past. Some 40 percent of the 4 million people who visit **The Wall** today are too young to remember. To them the long list of names cut in the smooth black granite are faceless; they have no context, no connection.

- By sharing the faces and stories behind every name, officers and infantry alike, the Education Center at The Wall will help future generations understand the courage, sacrifice and devotion of those who fell, those who returned, and those who waited.
- The Education Center project is headed by Jan C. Scruggs, founder of the Vietnam Veterans Memorial.
- And like The Wall itself, the second most visited site in Washington, DC, the Center will be built entirely with private funds donated by the American people.



To preserve the hallowed nature of The Wall and all the memorials gracing the National Mall, the two-story learning facility will be built entirely below ground.

Exhibits will include a wall of photographs of those whose names are on The Wall, a selection of the over 100,000 items that have been left at the Vietnam Veterans Memorial, a timeline of key military events of the Vietnam War and a history of The Wall. The Center will celebrate the values embodied by all of America's service members—loyalty, duty, respect, service, honor, integrity and courage—and an exit exhibit will show images of those who served in all of America's conflicts, from the Revolutionary War to Iraq.

Over \$20 million has been raised for The Education Center, including the lead gift of \$10 million from Time Warner. It is estimated that the Center will cost \$85 million to build.

## Help All Americans Think about Memorial Day...

Memorial Day is one month away. Below are six instructions to help you make sure that every American who sees you or your home thinks about the significance and importance of Memorial Day.

1. If you are a veteran, please wear one of your military ribbons on your collar or lapel.
2. If any member of your family died in any war, please hang a Gold Star in your living room window, or wear a Gold Star pin on your collar.
3. If you did not serve in the military, please wear an American flag pin on your collar.
4. Send a letter, not an email, to your local newspaper asking them to publish the names of all known local military personnel who died during wartime.
5. Send a letter, not an email, to both of your federal Senators, asking them to publish a list of all known military personnel in the Congressional Record or other Memorial archive.
6. Send a letter, not an email, to the Directors of all Cemeteries in your city asking them to publish a listing of all known military personnel gravesites in their custody.

You are strongly encouraged to also send a copy of your letters to The War Library for confirmation archive.

You are encouraged to ensure that your name and the names of all of your military family members – past and present – are listed in The International Military and Veteran Database. The International Database was established on July 4th, 1988. It remains the oldest and largest online international listing of former and current military and military-related names, information and personal military photos from all Service Branches and all Nations.



# World War I Memorial

NOTE – The following is based upon a Washington Post article by John Kelly published on 31 March 2011.



It all started when **Edwin Fountain** jogged past a small but oddly moving structure hidden by trees on the south side of the Mall, not far from the Tidal Basin. The Arlington lawyer discovered that the domed marble temple was a memorial honoring the 499 D.C. residents killed in World War I. Edwin thinks the memorial, dedicated in 1931, should honor more than just those 499 people. He is the founding director of the **World War I Memorial Foundation**, which has as its aim, the *rededication of the monument as a national World War I memorial*.

No less a figure than **Frank Buckles**, the last surviving U.S. World War I veteran, who recently passed away, lent his name to the effort. **Joe Grano**, president of the **Rhodes Tavern – D.C. Heritage Society** says he has a better idea. Make a national World War I memorial out of Pershing Park at 15th and Pennsylvania NW. After all, **General John J. Pershing** was the head of U.S. expeditionary forces in Europe. Add a doughboy statue (modeled, perhaps, on Buckles), maybe a Navy sailor statue and some signage, and you'd have a dandy World War I monument. – “He makes some interesting arguments that I am not unsympathetic to,” Edwin said. “The odd position we find ourselves in is there is no perfect solution to this. Every proposal has its pros and cons.”

Chief among Edwin's cons for Pershing Park is the location. He thinks the streets around it are too busy and difficult to cross. Besides, everyone wants to be on the Mall. Only there would it be near memorials to our other major 20th-century conflicts: World War II, Korea, Vietnam. Said Edwin: “When you put World War I someplace else – whether in Kansas City or Pershing Park – you are diminishing it somehow, saying it was not as profound an event.” Grano thinks there's nothing shabby about being a block from the White House. But here's what's really going on: Just as Edwin wants the D.C. World War I memorial to symbolize more than the District, Grano wants it to symbolize more than World War I. The monument has become a rallying place for some supporters of D.C. voting rights. As Grano wrote in a letter to the foundation: “The D.C. memorial now represents to District of Columbia citizens not only what we have given to our beloved country, but also what our country has not given to us.”

Edwin's response? “I think they're reaching to use that memorial for that purpose in the first place,” he said. Even so, he wants the National Park Service to include wording that the memorial is also a local one. And he's all for D.C. voting rights advocates lobbying to get something on there about their issue, too.

Edwin predicts that if this bill goes through, there is zero chance the renamed memorial will include anything about the District's lack of representation. One of the main proponents of the bill in the House has been **Representative Ted Poe** (R-TX). Edwin called for his opinion on D.C. voting rights. A spokeswoman e-mailed back: “Rep. Poe is not going to comment on this issue at this time.” In 2007, he voted against a bill to give the District a vote in Congress. In 2009, the D.C. Council issued a resolution in favor of the name change. There were no public hearings. Both **Jack Evans** and **Eleanor Holmes Norton** are honorary trustees of the foundation. I guess in the grand scheme of things, recarving some marble isn't a big deal. But it grates, just as it grates that a petulant Congress won't let the District have statues in the U.S. Capitol. As Grano put it: “You deny us any equality with the 50 states, and you just come in and take over our war memorial?” Edwin is adamant the memorial won't be *'federalized.'* He said the new name would be the District of Columbia and National World War I Memorial. To me that *'and'* makes it sound as if the District is something separate, something not quite national, not quite American.

# Next Top Enlisted Marine

**Sergeant Major Micheal Barrett**, the top enlisted Marine in Afghanistan for the last year, will serve as the **17th Sergeant Major of the Marine Corps**, Commandant General Jim Amos told Marine Corps Times on Monday.

Barrett, Sergeant Major of 1st Marine Division, out of Camp Pendleton, CA, was chosen to serve as Amos' senior enlisted adviser. He also was the Sergeant Major of Pendleton's I Marine Expeditionary Force (Forward), which oversaw more than 20,000 Marines in southern Afghanistan until it was replaced with II MEF (Fwd.), out of Camp Lejeune, NC, last month.


"He's the best of the best, it's as simple as that," Amos told Marine Corps Times in a brief, exclusive interview. The Commandant said he interviewed seven other finalists for the position, and characterized them as "superstars" serving under two- and three-star generals.

"Sergeant Major Barrett, through his long and distinguished service to our nation, has demonstrated that he is particularly well-suited to serve as my senior enlisted adviser through the challenges ahead," Amos said. "My wife Bonnie and I welcome him and his wife Susan, and look forward to serving with them."

Barrett, a 30-year Marine, is expected to replace Sergeant Major Carlton Kent in a ceremony to be conducted on June 9 in Washington. He will bring extensive infantry experience to the position, including a stint as platoon sergeant and scout sniper during the Gulf War with 3rd Battalion, 9th Marines, out of Lejeune

More recently, Barrett served as the top enlisted adviser for 2nd Battalion, 7th Marines, out of Twenty-Nine Palms, CA, during two combat tours in Iraq. He became the Sergeant Major for the 1ST Marine Division in June 2009, and served as the top enlisted adviser to Major General Richard Mills, commander of Marine forces in Afghanistan. Mills, who was later succeeded by Major General John Toolan.

Barrett also has a wide range of experience outside the combat zone. Notably, he served as the Company Gunnery Sergeant and Marine liaison to the U.S. Secret Service at the presidential retreat at Camp David, MD, from September 1996 to August 1998. He also has served as a drill instructor at Marine Corps Recruit Depot San Diego, a chief instructor at the Scout Sniper Instructor School at Marine Corps Base Quantico, VA, and as the top enlisted Marine at Recruiting Station Cleveland.


