No One Left Behind!

Note – The following is an edited version of an article by Gina Harkins, a Marine Corps Times staff writer.

On the morning 11-year-old **Ben Baltz** was preparing to race in a triathlon, his dad gave him a piece of dark chocolate. When he opened it, the inside of the foil wrapper contained a message for the young athlete – “You’re exactly where you need to be.”

A few hours later, a photo was snapped of Baltz being carried across the finish line on the back of **PFC Matthew Morgan**, 19, a communications signals collection operator/analyst with Marine Detachment Corry Station in Pensacola, Fla. The two were surrounded by a pack of Marines as they completed the race in solidarity.



The photo, taken by a spectator, went viral and it’s motivating Americans. That’s because Baltz isn’t a typical athlete. If he wants to run or play baseball, he has to strap a leg on to do so.

Baltz’s parents had to make the tough choice to amputate their son’s leg when he was just 6 years old and battling bone cancer. Now he wears a prosthetic walking leg with a mechanical knee or a running leg for strenuous activities like triathlons.

Twenty-two Marines with the detachment, including Morgan, were volunteering at the Sea Turtle Tri kids’ triathlon on Sunday. They helped set up and then encouraged the kids, who were making a 150-yard swim, a 4-mile bike ride and a 1-mile run to get to the finish line.



New Corps Mandate...

Talk the Talk

Note – The following is an edited/condensed version of an article by Gina Harkins that appeared in the online Marine Corps Times column Battle Rattle on October 15th.

Newly promoted Sergeants, get ready for new education requirements to make it to Staff Sergeant – or any rank beyond.

The Corps is rolling out a new professional education requirement for enlisted Marines that will need to be completed before making it to any new rank, all the way up to Master Gunnery Sergeant. The program is called **Regional, Culture and Language Familiarization**, or RCLF for short. It takes the globe, carves it up into 17 different sections, and assigns to Marines the cultures and languages associated with each.

New Lieutenants have been doing this since 2008 and new Warrant Officers since 2010. The goal is to get officers and enlisted personnel throughout the Corps up to speed on different parts of the world so no matter where Marines are sent, they are ready. They can teach their comrades about what to do – or not to do – when they get in-country.

Commandant Speaks at Christening

Note – The following is an Associated Press article, which appeared in the online version of the Marine Corps Times on October 21, 2012.

Pascagoula, Mississippi – America, a “mighty warship,” will represent “American resolve and commitment throughout the world,” Marine Corps Commandant, **General James Amos** said during the ship's christening at Ingalls Shipbuilding on Saturday.



Ship sponsor **Lynne Holden Pace**, wife of retired Marine Corps **General Peter Pace**, christened the ship with one swift swing, reports the Mississippi Press.

Saturday's christening festivities opened with a performance by the **USO Liberty Bells**, whose songs brought about 2,000 attendees to their feet.

The 844-foot-long ship will one day hold a more than 1,000-person crew and up to about 1,800 Marines. It is the largest of all amphibious warfare ships, includes a 2-acre flight deck and will support the most advanced Marine Corps aircraft.

The enlarged hangar deck will be capable of holding planes and helicopters.

Highlights of the October 22nd Meeting...

The meeting was brought to order by **Commandant Joe Wright**, who acknowledged the presence of **Department of Maryland Adjutant Paul Taylor**, and **Past Detachment Commandants Guy Hall, Manny Airey, Pete Pervi, and Mac McNeir**.

NOTE – The subsequent arrival of 'cover-less' Department Commandant Ed Ross was noted by Commandant Wright.

New Member...

Marine **Chris Wise**, whose application for membership had been approved by members at a previous detachment meeting, was formally sworn in by **Commandant Wright**. A three minute recess was declared to allow those in attendance to welcome our new member into the detachment.

Employer Identification Number (EIN)...

Commandant Wright announced that the questions about the existence/validity of our detachment's **EIN** have been laid to rest. We in fact have a valid EIN issued by the **Internal Revenue Service (IRS)**.

Correspondence

Adjutant Ben Wells read the following three pieces of detachment correspondence...

- A **Thank You** card from the **Toys for Tots** national organization expressing appreciation for our donations
- A letter from the **Governor's Commission on Maryland's Military Monuments** soliciting donations
- A letter from the **United States Marines Youth Foundation** soliciting donations for its annual **Tree of Lights Campaign**

Each year, tree lights in various colors are sponsored by *Marine Corps League Detachments and Auxiliary Units, individual Marines, members of the greater Marine Corps family, and friends of the United States Marines Youth Foundation*. At the tree lighting ceremony, held on **Marine Corps Base Quantico**, the lights are illuminated while **General Alfred M. Gray**, 29th Commandant of the Marine Corps and Chairman of the Board reads the *'Scroll of Honor'*. The scroll lists all donors to the campaign and is displayed at Marine Corps League National Headquarters throughout the coming year.

Last MHM Cook-out of the Year...

Commandant Wright reported on the successful conduct of the last of the league sponsored cook-outs at the **Walter Reed National Military Medical Center in Bethesda**. Accompanying Commandant Wright to this event were Past Detachment Commandant **Mac McNeir**,

Norm Huffman, Detachment Auxiliary Vice President **Chasity Wright**, as well as Department of Maryland Commandant **Ed Ross**.

Detachment members were also encouraged to be part of next year's series of cook-outs as volunteers are always needed. **Mac McNeir** offered to provide transportation to members who either do not like to drive in the District of Columbia or on the Capital Beltway.

Toys for Tots...

Members were reminded that this year's **Toys for Tots Campaign** was underway and that **Dawn Parker** – our campaign coordinator – could really use some help from now through Christmas. The efforts of Dawn and her volunteers will make this a joyful Christmas for many area children, who would otherwise not personally experience the joy of Christmas! Members should also be aware of the following...

- A collection event will take place on **November 1st & 2nd** (from **10:00 AM to 8:00 PM**) at the **Toys 'R' Us** store located in the **Glen Burnie Mall**. Volunteers (*dressed in appropriate league attire*) are needed at the event on both days.
- **November 18th** is the date of our detachment's official kick-off event (party), which will take place at **American Legion Post 40** on 5th Avenue (in Glen Burnie). Catering is being provided by **Mission BBQ**. Admission is **\$12 per person plus one unwrapped toy** in its original packaging.
- A *storage pod* has been staged in the **VFW Post 160** parking lot for temporary storage of toys collected that need to be subsequently transported to the warehouse.

Bull & Oyster Roast...

Senior Vice Commandant **Ed Dahling** thanked everyone involved in the running of this year's **Bull & Oyster Roast** and announced that a profit of just over **\$1619** has been placed in the detachment's general fund.

Re-Instatement of Members...

Judge Advocate **Charles Luthardt Jr.** discussed a change to the national by-laws regarding the elimination of the previously required **\$5 reinstatement fee**. As a result of a floor vote at the **National Convention in Mobile**, this fee has been eliminated. Delinquent members seeking re-instatement may now choose one of the following two options.

- Payment of only a **single year's membership** fee to be returned to the associated detachment's membership roster as a **new member**.
- Payment of the current membership fee **for each year of delinquency** in order to be returned to the associated detachment's membership roster as a **continuous member** in good standing.

New Business...

Past Commandant **Pete Pervi** made a motion that the detachment contribute \$200 to help pay for the food served at the **Toys for Tots** kick-off event being held on **November 18th**. The motion was approved by voice vote of the detachment members in attendance.

Young Marines Commander **George Martin** sought support for a raffle being held in December to benefit the Young Marines. He requested that the detachment buy ten raffle tickets (at a cost of \$5 each). A motion to purchase ten tickets at a total cost of \$50 was approved by voice vote of the detachment members in attendance.

Good of the League...

Burt Helmka, 2013 Marines Helping Marines Golf Tournament Chairman, asked for a volunteer to assume the role as his assistant.

Mac McNeir, stated that an appointment was set with the management of the **Compass Pointe Golf Course** to determine the advisability of changing the site of the **2013 Marines Helping Marines Tournament**. Lest We Forget...



Le Gette, Rita Frances, 74, wife of detachment member **James ‘Jim’ Le Gette** and resident of Severna Park, died on October 4, 2012 at home surrounded by her family.

She was born on June 24, 1938 in *Brooklyn, NY* and raised in *Huntington Station, NY* and *Woodland, CA*. After

graduating valedictorian of her high school, *St. Joseph Academy* in *Sacramento, CA*, she went on to earn her *Bachelor of Science, in Education*, at *California State University, Sacramento*. Past residences include *San Francisco, CA*; *Springfield, VA*; *Stockton, CA*; *Scottsdale, AZ*; and *Severna Park, MD* since 1980.

Upon graduation, she seriously considered an offer to join the *Peace Corps*, in *Sri Lanka*; but decided instead to follow her other passion and teach 3rd and 4th graders at *St. Bernard* and the *Marina School* – both in California. In the summer of 1963, she and Jim were wed, and eventually relocated to *San Francisco, CA*, when Jim became a *Special Agent* with the *United States Secret Service*.

She was a homemaker, first and foremost, with a love of antiquing, music, genealogy, volunteer service, and, of course, spending time with family, friends and her parish community. Rita touched many people's lives with her bottomless empathy and instant connection with everyone she met. She was an active member of *St. John the Evangelist Roman Catholic Church*, where she sang in a lovely soprano, in the *St. John's* choir, for more than 25 years.

She is survived by her husband of 49 years, **James E. Le Gette** of *Severna Park*; three sons, **Christopher J. Le Gette** of *Leesburg, VA*, **Brian E. Le Gette** of *Baltimore, MD*, **Marco F. Le Gette** of *Severna Park, MD*; one daughter, **Michele V. Dierking** of *Severna Park, MD*; brother, **Bruno F. Fabbri** of *Woodland, CA*; and three grandchildren, **Vittoria Dierking**, **Gianna Dierking**, and **Simone Le Gette**.

Visitations took place on Tuesday, October 9, 2012 at the *Barranco & Sons, P.A. Funeral Home* in *Severna Park*. Marine Humvees Get 2nd Life

Note – The following is an edited/condensed version of an article by Michael Hoffman that recently appeared on the DoD Buzz website.

QUANTICO, VA – Many wrote off the Humvee when Army and Marine Corps officials chose to double down on the *Joint Light Tactical Vehicle (JLTV)* program and scrap Humvee recapitalization plans. However, budget realities have led the Marine Corps back to the Humvee as leaders realize they don't have the funding to buy enough JLTVs to replace their Humvee fleet of 24,000 trucks.



To make up for the gulf between current Humvee numbers and the planned JLTV buy, the Marine Corps will launch a Humvee improvement program. The upgrade program will have a clearly defined price limitation to ensure it doesn't meet the same fate, although that price ceiling has not been specified yet, a Marine official stated. What the Marine Corps wants to do is return the Humvee's performance back to when it was not loaded down with so much armor.

A Marine representative said "We're trying to recapture capability that was already resident in the vehicle before we upgraded with armor. That's the critical node in which we started to lose performance, payload and reliability when we up armored them to go into theater. Industry has already worked on upgrades for the Humvee to include the suspensions, drive shafts, and lightening the vehicles. The Corps hopes to pick and choose which ones they can afford. The next phase essentially tries to price those out in logical packages to see what gives us an optimum solution in terms of recapturing lost performance, lost pay load, lost reliability. This work will not affect the amount invested into the JLTV program."

You Might Be 'Old Corps' If...

Note – The following is an edited and shortened version of an email that I received from our Sergeant-At-Arms, George Martin.

When we were young Marines, some among us would inevitably speak of “*The Old Corps*.” Now, some of us have joined the ranks of the latest iteration of the “*Old Corps*” and remember when...

- The barracks meant a *squad bay*.
- Barracks violence was a fight between two buddies, who were still buddies when it was over.
- Floors were *decks*. doors were *hatches*. walls were *bulkheads*, water fountains were *scuttlebutts*, and halls were *passageways*.
- You aired your bedding.
- You *policed the grounds* daily despite the fact that they were always clean.
- Parking was not a problem because troops couldn't afford cars.
- You always *field-stripped* your cigarette butts.
- Everyone helped with *field-days*.
- We had live bugle calls and everyone got up at reveille.
- We kept our packs made up and hanging on the ends of our racks.
- Your 782 gear did not wear out (even though it came from WW II).
- You kept your rifle in the barracks and cleaned it weekly.
- You were fed in a *mess hall NOT a dining facility*.
- You were required to be in the *Uniform of the Day* in order to go to evening chow.
- We wore the short green *battle jacket* with our winter uniform. [ONLY MEMBERS OF THE U.S. ARMY CALLED IT AN 'IKE JACKET!']
- We wore *leggings* and *herringbone utilities*.
- We wore *boon-dockers*.
- Marines wore *dog tags* all the time.
- We starched our *khakis* and looked like hell after sitting down for the first time.
- We starched our *field scarves*.
- We *spit-shined shoes* and *brush-shined boots* and our leather gear was brown not black!
- The tips of our index and middle fingers – on our dominant hand – were usually discolored with Kiwi shoe polish.
- Marines had more uniforms than civilian clothes.
- Everyone was issued dress blues.
- *Skivvies* had *tie-ties*.
- You did your own laundry and ironing.
- We carried *swagger-sticks*.
- Generals cussed and paid more attention to needs of the Marine Corps rather than to politics.
- UA meant being a few minutes late returning from a great liberty, and it only happened once per career.
- Brigs were truly '*correctional facilities*.'
- Sergeants were Gods.
- Privates made significantly less than \$100.00 a month
- Larceny was a civilian crime.
- Support units supported... the *supply tail* did not wag the *maintenance dog*.
- PX items were bargains.
- You weren't married unless you could afford it.
- We had "*Rocks and Shoals*."
- Courts-martials were a rarity; however, when they did occur, the findings were read at battalion formations.
- A bum didn't have a BCD awarded more than once before he actually got it.
- People receiving BCDs were drummed out the gate.
- Non-judicial punishment was non-judicial.
- The mission was the most important thing.
- Marines could shoot and had a decent rifle.
- The BAR was the mainstay of the fire team.
- Machine gunnery was an art.
- *Maggie's drawers* meant a miss and was considered demeaning as hell to the dignity of the shooter.
- Carbide lamps blackened the sights of our rifle.
- We had to take and pass promotion tests to get promoted, plus have the required *cutting score*.

2 November 1950

Marines engage Chinese in North Korea near the Chosin Reservoir.

3 November 2003

Presidential Unit Citation awarded to 1st Marine Expeditionary Force for its service in **Operation Iraqi Freedom**. It becomes the first unit to earn the award since the end of the Vietnam War.

4 November 1948

Colonel Katherine Towle became the first Director of Women Marines as regulars and not reservists.

4 November 1979

Mob overruns U.S. Embassy in Teheran, Iran; 13 Marines among 65 American hostages; 52 of whom were held captive for 444 days.

10 November 1775

Continental Congress authorizes creation of two battalions of Marines.

10 November 1948

First eight enlisted women are sworn in as regular Marines. First black women Marines enlist the following summer.

10 November 1921

The first formal commemoration of the Marine Corps Birthday.

10 November 1954

Marine Corps War Memorial site dedicated near Arlington National Cemetery.

12 November 1946

Gerald C. Thomas, the first Marine to rise from Private to General, rank by rank, received his second Legion of Merit.

13 November 1982

Vietnam Veterans Memorial, containing the names of more than 13,000 Marines, who lost their lives in Vietnam, is dedicated.

18 November 1915

Major Smedley D. Butler leads Marine attack on Fort Riviere, Haiti and is awarded 2nd Medal of Honor.

20 November 1947 (date approximate)

Toys For Tots program founded.

23 November 1950

7th Marines take Yudam-ni. Thanksgiving was celebrated in Korea with temperatures hovering about 20 degrees below zero.

27 November 1950

Eight Chinese Communist divisions launch a massive attack in Korea, with the express purpose of destroying the 1st Marine Division. This action leads to the successful Marine Corps attack out of the Chosin Reservoir and its relocation to the coastal port of Hungnam.

28 November 1775

Samuel Nicholas commissioned as Captain of Marines, becoming the first Marine officer.

29 November 1804

Lt. Presley O'Bannon and seven Marines land in Alexandria, Egypt.

Proposed Detachment By-Law Change

Note – Please read the proposed amendment to the current by-law governing the Selection of the Detachment Marine of the Year, which is provided below. The amendment, as presented here, contains changes to the original amendment, which was introduced and read at our October detachment meeting – those changes appear as red/underlined text. This proposed amendment will be reintroduced at our November detachment meeting.

Since our by-laws state that a vote cannot be held until 30 days have passed, the vote to either accept or reject this amendment will be conducted at our December detachment meeting.

SECTION 300 – STANDING COMMITTEES AND DUTIES

d. Detachment Marine of the Year (DMOY)

1. Committee Composition

The Detachment Marine of the Year Committee shall be comprised of all past recipients of the Marine of the Year, with a minimum of three members required to meet. In the event at least three members are not available, the Detachment Commandant shall name one or more Past Detachment Commandants to serve on the DMOY Committee. The Chairman of the DMOY Committee shall be the most recent Detachment Marine of the Year. If unavailable, the next most current DMOY shall server as chairman. Each member must be a member in good standing.

2. Duties

(a) The DMOY Committee shall

- aa. Determine all nominees are in good standing.
- bb. Ensure the nominees are not the subject of a grievance.
- cc. Review, select, and submit at least two, but not more than three qualified nominees to the Detachment Commandant no later than two calendar weeks prior to the scheduled March detachment meeting.

dd. Should the Detachment MOY Committee determine that no nominee is qualified, they may with the concurrence of the Detachment Commandant, make no recommendation.

(b) The Detachment Commandant shall

- aa. Prior to the detachment meeting in March, publish the qualified list of nominees and their supporting recommendations.
- bb. At the March meeting, present the list of qualified nominees for vote by the assembled members of the detachment.

(c) The Detachment Judge Advocate shall prepare the ballots.

(d) The Detachment Quartermaster shall obtain the appropriate award plaque and medal. The medal should be available for presentation at the March meeting. The plaque with appropriate inscription may be presented at a later meeting.

3. Nominations

- (a) The DMOY Committee may begin accepting nominations after the January Detachment meeting.
- (b) Nominations may be made by any detachment member in good standing.
- (c) Nominees must be a detachment member in good standing.
- (d) Nominations should consist of a written recommendation, with a statement of justification as to why this member should be selected as Detachment Marine of the Year.

4. Voting Process

- (a) Members must be present and in good standing to vote. There are no proxy votes or absentee ballots.
- (b) The Detachment Senior Vice Commandant, with assistance from the Judge Advocate, shall conduct a secret written vote. The names of all qualified nominees shall appear alphabetically on a ballot. In the event either officer is a nominee, the Detachment Commandant shall select a replacement officer. This replacement may be an elected or appointed officer.
- (c) A majority vote of all members present shall be necessary to decide the Detachment Marine of the Year. A majority vote is defined as fifty percent plus one vote.
- (d) In the event no nominee receives a majority on the first round of balloting, the top 2 voter earners shall run in a runoff election, with a simple majority (50% +1) being necessary to win.
- (e) The Senior Vice Commandant, with assistance from the Judge Advocate shall tally the votes and present the results of the voting to the Detachment Commandant.
- (f) The Detachment Commandant will announce the Marine of the Year or declare no winner and the need for a second round of voting. If the winner of the DMOY is present, the award may be presented immediately. In the event the winner is not present, an appropriate ceremony shall take place at the next scheduled detachment meeting. The previous recipient of the DMOY shall present the award.

Morgan said Baltz was the only contestant he saw with a prosthetic and – for most of the race – he was passing other kids. But about halfway through the running portion, something went wrong.

“I saw Ben fall to the ground,” Morgan said. “I made it there first and he had already regained his composure and was trying to fix his leg. I asked if he needed help and he said, ‘No, I just want to finish the race.’”

But a screw had come out of the prosthetic, and Baltz couldn’t fix it himself. So Morgan said he told him to hop on, and gave him a piggy-back ride to the finish.

Morgan said he was surprised by what happened next. The announcer saw him carrying Baltz to the finish and told everyone to turn to watch what was happening on the course. The crowd cheered, some moved to tears, as the group made their way to the finish line, according to a *CNN iReport*.

Morgan said he was just there to do the right thing. His commanding officer, **Captain Frank Anderson**, said he wasn’t at all surprised by Morgan’s reaction. He said his Marine has the mindset of excellence in everything he does.

“We are selfless as an institution in the Marine Corps,” Anderson said. “Putting others before ourselves is second nature. I’m very pleased with the fact that a young man who is younger than my youngest brother gets the big picture.”

Anderson said Morgan is nursing his own leg injuries, but he still didn’t hesitate to put Baltz on his back and run him into the finish line.

Baltz’s dad, J.C., a former Air Force pilot turned commercial pilot, said the Marines who were there that morning showed the spirit of the Corps.

“For the Marines to come out there that early in the morning on a Sunday to volunteer their time by helping set up and police the whole area, it just shows how darn caring they are,” he said.

He said his son was a little miffed that he couldn’t finish the race on his own. But Morgan said he knows if his leg hadn’t broken, Baltz would’ve completed the run.

“As far as I’m concerned, he finished that race,” Morgan said. “As long as he knows he could’ve finished it and wanted to finish it, that’s all that matters.”

Anderson said Baltz should know that even America’s toughest warriors get carried from the battlefield sometimes, and Marines don’t leave anyone behind.

J.C. Baltz said Marines reflect the resiliency of the country, just as his son reflects the resiliency of children.

“It’s damn hard to make the decision to amputate your child,” he said. “He was 6 and never really knew any different. We just want him to be a kid and have fun, which is why I encourage him to be an athlete. Now Ben is speaking to people through that photo – it’s amazing what one picture can do.”

They have taken John Kennedy’s words too seriously and are overly concerned with what they can do for their country instead of what this country can do for them.


They take the Pledge of Allegiance to heart and believe that their oath is to be honored.
