Lest We Forget...

Note – The following is based upon information obtained from an online obituary published in The Capital on July 14th, 2012.

Lieutenant Colonel Daniel A. Hitzelberger (USMC, Retired), of Annapolis, MD, died suddenly at the **Good Samaritan Hospital** near Dayton, Ohio on July 10th while travelling to the **Optimist's International Convention**.

Born April 11, 1939 in Pittman, NJ to the late **Charles and Helen Hitzelberger**, he is survived by his wife of 49 years, **Yvonne "Bonnie" Hitzelberger**, children **Deborah Cronin**, and **Major Timothy Hitzelberger** (USMC), son-in-law **Jason Cronin**, daughter-in-law **Holly Hitzelberger** and 6 adoring grandchildren.



Dan lived a life of service and dedication to both our country and his community. After graduating from the **U.S. Naval Academy** (Class of 1963), he went on to serve 27 years in the Marine Corps, including two tours in Vietnam with **1/7** and **2/9** where he earned the **Silver Star** for valor displayed in combat against communist forces during **Operation Dewey Cannon**. After retiring from the Marine Corps, Dan became a program manager while employed by Westinghouse Corporation for 13 years. He subsequently went into practice as a personal financial planner. At the time of his death, Dan was serving the second of two terms as **Governor of the Maryland and Southern Delaware District of Optimists International**.

Dan will be forever remembered as a loving husband, father, and grandfather who will be missed by all who were privileged enough to have known him.

Viewing was held at the **Hardesty Funeral Home** on Ridgely Avenue in Annapolis on Monday, July 16th. Services were held on Tuesday, July 17th at **St. Anne's Episcopal Church** in Annapolis.

The family requests that any donations be made to either the **American Heart Association** or **Saint Anne's Episcopal Church** of Annapolis.

Note – Lt. Colonel Hitzelberger was a long time friend of our detachment's Color Guard Commander Woody Bowman and his wife Jean.

The unit would later become known as the Ugly Angels and provide support for operations Desert Storm, Iraqi Freedom, Enduring Freedom and the Global War on Terror.

*The 1st Battalion 9th Marines (1/9) is an infantry battalion formed during World War I. During WWII, 1/9 participated in the **Bougainville** and **Northern Solomons** campaigns and the Battles for **Guam** and **Iwo Jima**.*

*During the Vietnam War, 1/9 sustained the **highest casualty rate** in Marine Corps history earning the nick-name 'The Walking Dead' as it endured the **longest sustained period of combat** and suffered the **highest killed in action (KIA) rate** in Marine Corps history.*

*The battalion was deactivated in the mid-1990s to make room for a light armor reconnaissance battalion. In late 2005, the battalion was reactivated and took part in operations in **Somalia** in the early 1990's and **Operations Iraqi Freedom**, and **Enduring Freedom** at various periods from 2006 – 2011.*

Highlights of the July Meeting...

The meeting was brought to order by **Commandant Joe Wright**, who recognized the **Department of Maryland Adjutant Paul Taylor** and past **Detachment Commandants Manny Airey, Guy Hall, Mac McNeir, and Steve Salanik**.

New Members...

Junior Vice Commandant Ray Sturm presented the credentials of two applicants for detachment membership. After a brief discussion, **Mark East** – (a *Vietnam Veteran and rifleman*) and **Brian Fallon** (an *Iraq Veteran and combat engineer*) were found to be worthy of membership and were sworn-in by our **Detachment Commandant Joe Wright** in accordance with Marine Corps League by-laws.

Correspondence...

- A *thank-you* message from the **National Director of the Marines Helping Marines Program, Ron Short** acknowledging the detachment's recent contribution of **\$9,856** was read.
- A *thank-you* message (and certificate) from the **Marine Corps Heritage Foundation** acknowledging our detachment's purchase of an inscribed brick, which will be part of the **Chesty Puller Memorial** (overlook) at the **National Museum of the Marine Corps** was read. A copy of the certificate is reproduced below.



Detachment Budget for 2012–2013...

Copies of the proposed budget for this fiscal year were distributed and discussed by the membership. The proposed budget was subsequently voted on and passed with one caveat – the allocation earmarked for the **Department Convention** needs to be clarified.

EIN & States Sales Tax Exemption...

Detachment Adjutant Ed Wells asked for clarification about our detachment's **EIN** (*IRS employee identification number*) and **Maryland state sales tax exemption** status. Since a consensus was not achievable about the status of either, **Jim Brady** was *voluntold* (euphemism for being appointed) to meet with the detachment staff in order to properly research the EIN issue and take appropriate action(s). **Burton Helka** will look into the status of our Maryland sales tax exemption.

Official Detachment Letterhead...

Detachment Adjutant Ed Wells stated that the absence of 'official' detachment letterhead is causing problems when interacting with potential sponsors and other local organizations. **Mac McNeir** volunteered to produce digital stationery (letterhead and envelope) and provide it to detachment staff members within twenty-four hours.

2013 MHM Golf Tournament...

Burton Helka, a charter member of the detachment volunteered to be the chairman of our **8th Annual Marines Helping Marines Golf Tournament**.

Ed Dahling Part of Hall of Fame Week ...

Paralleling the role once played by our out-going **National Commandant Vic Voltaggio**, that of baseball umpire, **Senior Vice Commandant and Paymaster Ed Dahling** was invited by the **Baseball Hall of Fame Committee** to be an umpire for their **American Youth Baseball National Invitational Tournament**. The tournament is held annually and coincides with **Hall of Fame** induction ceremonies which honor the most recent Major League inductees. (See *Through An Umpire's Eyes* on page 12).

MHM Challenge Coins...

Motion was made and seconded to purchase six challenge coins to present to the major sponsors/supporters of our **2012 MHM Golf Tournament**. An allocation of **\$90** was approved by voice vote.

Motion was made and seconded to purchase a tee-box sign for the **VFW Post 160 Golf Tournament** scheduled for **September 21st**. An allocation of **\$100** was approved by voice vote.

Corps History

1 August 1960

The Corps' *Enlisted Rank & Pay Structure Board* revised existing rank structure by incorporating the rank of Lance Corporal and the E-8 and E-9 Pay grades.

2 August 1950

1st Marine Provisional Brigade lands at Pusan, South Korea.

3 August 1950

Eight Corsairs of VMF-214, the famed "Black Sheep" squadron of World War II, executed the first Marine aviation mission in the Korean War in a raid against enemy installations near Inchon.

6 August 1847

Marines commenced their march on the "Halls of Montezuma" in Mexico.

7 August 1942

1st Marine Division lands on Guadalcanal.

7 August 1990

President Bush ordered U.S. military aircraft and troops to Saudi Arabia as part of a multi-national force. One week later the Marine Corps announced the commitment of 45,000 troops to **Operation Desert Shield** – largest deployment of U.S. forces since Vietnam.

August 13, 1918

Opha Mae Johnson became the first female Marine when she enlisted in the Marine Corps Reserve.

14 August 1945

President Truman announced Japan's unconditional surrender.

14 August 1990

Advance elements of the 1st MEF and 7th MEB arrived in Saudi Arabia, joining other U.N. forces to defend against possible Iraqi aggression.

17 August 1942

2nd Marine Raider Bn. under Lt. Colonel Evans F. Carlson landed on Makin Island and destroyed a seaplane base, two radio stations, a supply warehouse, and killed about 100 Japanese troops.

19 August 1919

Marines Hymn registered with the U.S. Copyright Office.

21 August 1968

PFC James Anderson, Jr. becomes first African-American Marine to receive the Medal of Honor for heroism in Vietnam (posthumous award).

24 August 1814

Captain Samuel Miller's 114-man detachment from Marine Barracks, Washington, fought in the Battle of Bladensburg in defense of our nation's capital.

25 August 1948

2nd Lieutenant John E. Rudder became the first black to be commissioned as a regular United States Marine Corps officer.

29 August 1916

The Marine Corps Reserve was founded.



A New Cuban Missile Crisis?

NOTE – The following Reuters article by Nastassia Astrasheuskaya was originally published as an online Yahoo News article on July 27, 2012.

As a Marine, who was poised to be part of a reinforcing force for our Guantanamo Bay installation during the October 1962 Cuban Missile Crisis, this article concerns me...especially since we have no way of knowing the current administration's willingness to enforce the Monroe Doctrine in response to what could become a potentially troubling situation.

Russia hopes to establish its first naval base abroad since the 1991 collapse of the Soviet Union and is looking at Cuba, Vietnam, and the Seychelles [an island country – spanning an archipelago of 115 islands in the Indian Ocean] as possible locations, [the] state-run RIA news agency quoted the [ir] navy chief as saying.

Russia has been increasing the reach of its navy in recent years, sending warships further afield as part of an effort to restore pride [and to] project power in a world dominated by the U.S. military.

“It's true that we are continuing work on providing the navy with basing outside the Russian Federation,” RIA quoted **Vice Admiral Viktor Chirkov** as saying in an interview.

The Soviet Union had a large naval base in Communist ally Vietnam but post-Soviet Russia opted to vacate the Cam Ranh base in 2002, during **President Vladimir Putin's** first Kremlin term, because rent payments were a burden on state coffers.

The fate of Russia's only naval facility outside the former Soviet Union, a maintenance and supply facility in the Syrian port of Tartous, is uncertain because of the conflict in Syria.

Chirkov said Russia was ***“working out the issue of creating sites for material and technical support on the territory of Cuba, the Seychelles and Vietnam,”*** RIA reported.

Chirkov's wording suggested facilities in those countries might be less extensive than full-scale naval bases. Navy officials could not immediately be reached for comment.

Vietnamese President Truong Tan Sang, who was in Russia and was to meet Putin on Friday, was quoted as telling a Russian radio station that Vietnam has ***“no intention of cooperating with any country with the aim of military use of the port of Cam Ranh.”***

However, Sang was quoted as telling **Voice of Russia** radio that a maintenance and service facility at the port would be open to ships from all nations and that, in the interest of furthering a ***‘strategic partnership’*** with Moscow, ***“Vietnam will provide Russia with advantages in Cam Ranh, including with [the?] aim of developing military cooperation.”***



Meet a Marine and Olympic Athlete

Sergeant Jamel Herring almost gave up boxing. He joined the Marine Corps right out of high school in 2003, hoping to go to war. He got his wish.

After a tour in Fallujah, Iraq, he made the all-Marine boxing team for a year but was called back for another deployment to Iraq. That's when a Sergeant he knew was killed in a bomb blast.

“He had a 2-week-old son he'd never get to meet,” Herring says. With his own son on the way at the time, he says, ***“that messed me up pretty good.”***

Back from war, he soon eased back onto the Corps' boxing team and before long was expecting his second child. His daughter was born on Memorial Day in 2009 but died a few months later of sudden infant death syndrome. ***“It hit me hard ... I wanted to quit everything.”***

Encouraged by family and fellow Marines, he soon found the best way to wrestle down his grief was throwing punches back in the ring. ***“When I'm in the gym, I'm focused so much on what I'm doing in here. I leave all my problems outside,”*** he says during a workout break.

Now, he says, he fights for his ***‘little angel.’***

Herring is the first Marine to qualify for the Olympic boxing team in 20 years. His enlistment is up, but he volunteered to extend his contract so he could represent the Corps and his country in London.

July 27, the opening ceremonies for the games, is the third anniversary of his daughter's death.

NOTE – Sadly, Sgt. Herring lost his first and only bout to a talented boxer from Kazakhstan whose aggressiveness never allowed Herring to fully implement his game plan.



Societal Evolution... or Double Standard?

EDITOR'S COMMENT – For many years, the uniform was not allowed to be worn while participating in political events or other promotions! Political correctness now seems to have caused this dictate to be set aside by DoD. I include this article here to enlighten you and am not making a pronouncement either pro or con about DoD's decision.

The following is an edited version of an Associated Press article by Julie Watson, which appeared in the online version of The Marine Corps Times on July 2, 2012.

The Defense Department [recently] announced [that] it is allowing service members to march in uniform in a *gay pride parade* for the first time in U.S. history.

In a memorandum sent to all its branches, the department said it was making the allowance for **San Diego's Gay Pride Parade** on Saturday even though its policy generally bars troops from marching in uniform in parades.

The Defense Department said it did so because organizers had encouraged military personnel to march in their uniform and the event was getting national attention.

The move came only weeks after the Pentagon joined the rest of the U.S. government for the first time in marking June as gay pride month and made an official salute to gay and lesbian service members.

Defense Secretary Leon Panetta vowed in a video message to remove as many barriers as possible to making the military a model of equal opportunity and said **"Gays and lesbians can be proud in uniform with the repeal last year of the 'Don't Ask, Don't Tell' law."**

Last year, San Diego's gay pride parade had the nation's largest contingent of active-duty troops participate before the military lifted its ban on openly gay service members. About 200 service members last year wore T-shirts bearing their [service] branch's name.

Former sailor **Sean Sala**, who organized the military's participation in the parade, said he wanted service members to wear their official uniform this year to show there is no longer anything to hide.

"My soul is on fire," he said after hearing the news Thursday. **"They don't fight in T-shirts. They fight in uniforms. This is about showing who they are."**

The Pentagon said the allowance is only for this year's parade in San Diego and does not extend beyond that. Military personnel wearing civilian clothes do not need permission to march in any parades.

The Defense Department policy says personnel cannot march in parades in uniform unless they receive approval from their commanding officers or other Pentagon-approved authorities.

Sala believes there will be no going back after Saturday. He said he has reached his dream in seeing the U.S. military sanction participation in a gay pride parade, as the armed

forces have done in **Canada** and **Great Britain**.

Uniformed soldiers in those countries have marched down the streets of **Toronto** and **London** next to *scantily clad men, drag queens* and *civil rights activists*.

"I think across the country we will start seeing active-duty members in uniform march in pride parades," Sala said.

San Diego Pride Executive Director **Dwayne Crenshaw** called it an historic moment.

"San Diego Pride is honored to have the privilege of celebrating our country and our service members with dignity and respect," he said. **"The fight for equality is not over, and it is not easy, but this is a giant leap in the right direction."**

Before Thursday, several service members wanting to participate in San Diego's parade were told they could not do so in uniform. Others were granted permission by their commanding officers.

"I think many people thought after 'Don't Ask, Don't Tell' was gone, discriminatory things would be eradicated," Sala said. **"But now these parades have become a very sticky subject as far as commanders using their own discretion because they are showing either a bias toward a pride parade, or the right view, which this is about recognizing who people are."**

Before the repeal, gay troops could serve but could be discharged if they revealed their sexual orientation. At the same time, a commanding officer was prohibited from asking a service member whether he or she was gay.

More than 300 service members have signed up to participate this year in the San Diego parade. It was unclear how many will wear their uniform.

The Defense Department said in its message to the service members that they should adhere to policy regarding behavior while wearing their uniforms.

Service members in uniform cannot appear to endorse or selectively benefit groups or individuals, provide a platform for a political message, or appear to be commercially sponsored. They also must ensure their presence in uniform is not intended to increase sales and business traffic.

Air Force Officer **Joanna Gasca** was among those who risked marching last year in a T-shirt. Her commanding officer had given her permission to do so this year before Thursday's memorandum was issued. **"It was absolutely thrilling last year to walk down the street,"** the 47-year-old Air Force recruiter said. **"But this year – to be able to march in uniform – wow! I'm speechless."**



American Youth Baseball at Cooperstown Through an Umpire's Eyes

EDITOR'S NOTE – The following article is a collection of personal reflections of our Senior Vice Commandant Ed Dahling that were inspired by his recent opportunity to umpire in a week long youth tournament hosted at the American Youth Baseball Hall of Fame facilities in Cooperstown New York. The tournament coincided with Major League Baseball's annual ceremony honoring the latest inductees into its Hall of Fame.

Ed should be commended for being selected to participate in this very special event!



I will never forget umpiring as 'Old Glory' was waving in the breeze down the foul lines. How proud I was to be an American and an umpire in Cooperstown at Dreams Park! What a gorgeous setting, the fields and the mountains in the background, and the summer splendor of the cool New York countryside. This was an awesome and incredible experience!

Living in a barracks brought back memories of my days in boot camp. We had 12 umpires living together and we all had our own foot lockers and bunks. We even had to walk out to the head in order to shower. There was a mess tent, which was set up like a cafeteria, where they served all of our meals.

There were 104 teams composed of 12 year old athletes who, when not playing ball, were running all over the place trading team pins. First games each day started at 8:30 AM and the last game ended about 9:30 PM.

The umpires were assigned a field and tasked with ensuring that all of the games on that field were covered with at least two umpires.

I usually umpired three to four games a day. If I wanted to do more, all I had to do was simply go to one of the 22 fields and help out.

The championship playoffs began on Thursday – progressing through the 'Sweet 16' then the 'Elite 8.' I am proud to have been picked to be the 1st base umpire for these games.

The induction of the newest members to the **Baseball Hall of Fame** took place during the week that I was there and the little town of **Cooperstown** overflowed with more than 250,000 visitors. You could not get near the place that weekend; so, I waited until later to visit the Hall of Fame. If you have never been to the Baseball Hall of Fame and you get the chance to go... it is truly worth seeing!


