# Wounded Marines Continue To Fight

Marines, who want to progress through the ranks of non-commissioned officer and staff non-commissioned officer, frequently have the opportunity to go through leadership courses such as Corporal's and Sergeant's courses. These courses provide the basic fundamentals essential for Marines to lead their subordinates and provide structure and stability both in combat and in garrison. For Wounded Warrior Marines, the possibility of attending leadership courses wasn't previously an option. Today, the Corps is bringing the courses directly to the Marines. A group of Marines, who sustained injuries during deployments, graduated [from] the first **Wounded Warrior Corporals Course** at the **Walter Reed National Military Medical Center at Bethesda, MD** on January 17, 2012.

"The detachment staff wanted something to help these Marines continue their professional development," said **Gunnery Sergeant Boris Peredo**, instructor with the **Staff Non-Commissioned Officer Academy** at Marine Corps Base Quantico, VA. Peredo was one of three instructors who volunteered to teach the two-week course.



## Rumor Control

### Corps To Lose 20,000

*NOTE – The following information is an edited version of an article by Dan Lamothe (staff writer), which appeared in the January 26th on-line edition of the Marine Corps Times. Contrary to misinformation that might have been overheard at our January meeting, our Corps is in fact slated to lose 20,000 Marines in the coming years.*

The Marine Corps will slash 20,000 Marines as part of the Defense Department-wide budget cuts, reducing its end strength to about 182,000, top Pentagon officials announced.

The manpower reductions will leave the Corps smaller than **Commandant Amos** advocated for over the last year, but larger than some defense analysts had projected.

What isn't immediately clear is how the Corps will cut an additional 4,800 Marines to drop below the 186,800 end strength planned for in its recent force structure review. That study, released in March, called for a 13 percent drop in ground combat forces, a 16 percent drop in fixed-wing tactical aviation squadrons, a 9 percent drop in logistics, a 7 percent drop in Marines assigned to non-operational jobs and a 12 percent cut to its civilian work force.

There are still two Pound Growls scheduled prior to the Grand Growl, and some Pups must attend both in order to advance.

## Lest We Forget...

### Six Marines Killed in Helo Crash

*NOTE – The article appeared in the January 21st on-line edition of the Marine Corps Times. The Associated Press contributed to this report.*

The Defense Department, on Saturday, identified the six Marines killed earlier this week in a helicopter crash in Helmand province, Afghanistan.

The Marines were identified as:

- Captain Daniel B. Bartle, 27, of Ferndale, Washington. The *Baltimore Sun* reported Saturday that Bartle was a recent graduate of the U.S. Naval Academy.
- Captain Nathan R. McHone, 29, of Crystal Lake, Illinois.
- Master Sergeant Travis W. Riddick, 40, of Centerville, Iowa.
- Corporal Jesse W. Stites, 23, of North Beach, Maryland.
- Corporal Kevin J. Reinhard, 25, of Colonia, New Jersey.
- Corporal Joseph D. Logan, 22, of Willis, Texas.

The Marines died Thursday when their helicopter went down in Helmand. The Taliban claimed it shot down a helicopter Thursday, but coalition forces said there is no indication the helicopter was hit by enemy fire.

German **Brigadier General Carsten Jacobson**, a spokesman for the NATO coalition in Kabul, said Friday that officials were looking at a 'technical fault' as the possible culprit.

"The helicopter is one of the safest forms of transport," said Jacobson .

The Marines were assigned to **Marine Heavy Helicopter Squadron 363**, Marine Aircraft Group 24, 1st Marine Aircraft Wing, III Marine Expeditionary Force, out of Kaneohe Bay, Hawaii.

**HMH-363's 'Red Lions'** deployed to Afghanistan in August, replacing Hawaii's **HMH-463**. The squadrons have performed medium-lift missions, ferrying troops and equipment around the battlefield.

**Lt. Colonel Mark Revor**, Commanding Officer of Marine Heavy Helicopter Squadron 363, confirmed in a statement Friday that the Marines were from HMH-363.

# Still Fighting... *(continued from page 1)*

“The biggest thing I try and get across to Marines is it's not about them; it's about the Marines they lead,” Peredo said. “It's about putting their needs aside and being able to talk to other Marines and setting them up for success. Being able to say you're down but not out is a big part of leadership.”

For many of the Marines taking the course, it gave them the opportunity to remember why they joined the Marine Corps and motivated them to continue their career in the Corps.

“The course challenged me to get back in the mindset of being an NCO,” said **Corporal Rory Hamill**, who sustained injuries to his right leg while deployed to Afghanistan with 2nd Battalion, 8th Marine Regiment. “We can lose that mindset easily here since the focus is on recovery instead of being a Marine.”

The course was identical to other corporals courses, including periods of instruction on [the] sword and guidon manual, mentoring, counseling, and how to effectively lead junior Marines.

“Obviously some stuff was altered, such as field operations and regular running, lifting weights or other activities our injuries prohibit,” said **Lance Corporal Kyle Carpenter**, who sustained injuries to the right side of his body from an enemy grenade in Marjah, Afghanistan in 2010 [while serving] with 2nd Battalion, 9th Marine Regiment.

Physical training wasn't the only aspect of the course altered for these Marines. Many events such as land navigation and sword manual were discussed in detail as opposed to performed due to the injuries of some of the students. Despite the challenges, the instructors ensured training topics were covered in detail so the Marines would be able to confidently train and mentor their junior Marines.

“They had to adapt a lot of the training schedule to the wounded Marines because, obviously, there are guys missing arms, guys missing legs who can't do everything,” Hamill said. “They adapted but made sure we understood.”

The Marines were thoroughly taught and tested throughout the course. The challenges they faced brought the Marines together and helped them embrace the fact that they remain a band of brothers.

“Not everyone was excited to come to class everyday but I think it makes the guys think about reenlisting and it puts the Marines priorities in order,” Carpenter said. “It lifted morale and increased our motivation these two weeks we were together.”

Although the wounded Marines signed up for the opportunity, many were admittedly apprehensive in the beginning but were appreciative of the experience by graduation day.

“I chose to take the course because I plan on staying in the Corps,” Hamill said. “I love this organization. Being here and all the help I received, even after my injury, has motivated me even more. This is my family and I love it.”

With the course now complete, these Marines can concentrate on their goals and their future in the Corps.

“Getting injured puts things in perspective and makes you grow up in your professional and personal life,” Carpenter said. “I definitely consider reenlisting more now since before I was injured.”

Although the experience was unique for the Wounded Warrior Regiment, it was a learning and growing experience for the students, the staff and everyone involved.

“Teaching these Marines makes you realize who you are as a Marine; I think I needed this more than they did,” Peredo said. “It hits home because Im able to stand; Im able to move around and they're not. These are good Marines and now they realize they have something to offer back.”

Peredo said they got through to most of the class and reminded them [of the] things they forgot while being isolated from the Corps at the medical center.

“A lot of Marines treat this like a petting zoo, they come here because they feel sorry for the wounded Marines,” Peredo said. “They don't need that, they need to be taught and trained like Marines.”

The detachment's goal is to continue corporal's courses and other professional development for wounded warriors with classes at Marine Corps Base Quantico, VA, Camp Pendleton, CA, and Camp Lejeune, NC.

# Book Review

## *Ride the Thunder*

by Richard Botkin

*A former Marine infantry officer with 15 years of service  
(active & reserve, 1980 – 1995).*

This book presents the Vietnam War as seen through the eyes of several U.S. Marine Corps Advisers ('Covans') and the men of the Vietnamese Marine Corps with whom they served during the 'Easter Offensive' of 1972 and the difficult times that followed. In my eyes, it is a complete and far more honest portrayal of the Vietnam War – its heroes, its villains, the political climate which lead to the betrayal of the South Vietnamese by our government – than presented by the *agenda-driven* journalists of the time.



Like many of us who served in this war, I developed relationships with a number of Vietnamese citizens and this book has rekindled memories of them and reawakened my heartfelt concerns for their fate once the communists invaders filled the void created by the departure of U.S. forces.

This book also begs the question of why the *press corps* exacerbated public perceptions through their seemingly never-ending focus on incidents such as *My Lai* while almost totally ignoring countless North Vietnamese atrocities, which were far more egregious...atrocities such as the artillery shelling of thousands of fleeing civilian refugees during their exodus from Dong Ha.

## Corps History

by Historian Vic Halme

### **1 February 1967**

Operation Prairie II began in Quang Tri province by elements of the 3rd Marine Division. During the 46 day search-and-destroy operation, 93 Marines and 693 enemy combatants were killed.

### **2 February 1944**

The 4th Marine Division, as part of the first assault on islands controlled by the Japanese before the start of World War II, captured Namur and eight other islands in the Kwajalein Atoll.

### **2 February 1968**

Operation Hue City, Tet Offensive began in Vietnam.

### **5 February 1918**

1st Marine Replacement Battalion sails for France (WWI).

### **6 February 1968**

The 1st Battalion, 1st Marines with two companies, and the 2nd Battalion, 5th Marines with three companies, recapture Hue's hospital, jail, and provincial headquarters. It would take three more weeks of intense house-to-house fighting, and nearly a thousand Marine casualties, before the imperial city was secured.

### **11 February 1922**

BGen John H. Russell appointed U.S. High Commissioner and personal representative of the President to the government of Haiti. This nine-year assignment placed this future Commandant in supreme command of both the occupying American force and the Haitian Gendarmerie.

### **15 February 1898**

28 Marines and 232 seamen lose their lives when the battleship USS Maine is mysteriously hit by an explosion and sunk in the Havana, Cuba harbor.

### **19 February 1945**

4th and 5th Marine Divisions assault Iwo Jima...raise flag on Mount Suribachi four days later.

### **20 February 1815**

Captain Archibald Henderson leads Marines in the USS Constitution's capture of HMS Cyane and HMS Levant, which occurs 3 days after the end of the War of 1812.

### **20 February 1962**

Lieutenant Colonel John H. Glenn Jr. orbits the earth in first manned American space capsule.

### **23 February 1945**

Men of the 5th Marine Division raise flag on Mount Suribachi.

### **24 February 1991**

The I Marine Expeditionary Force and coalition forces began a ground assault on Iraqi defenses in the final chapter of Operation Desert Storm.

1st and 2nd Marine Divisions breach Iraqi defensive positions.

### **26 February 1991**

A Marine recon unit was the first U.S. force to enter Kuwait City and retake the American Embassy.

### **28 February 1991**

Operation Desert Storm ends. I Marine Expeditionary Force, with a strength of more than 92,000 for the operation, becomes largest Marine Corps operation in history. 24 Marines were killed in action during the Gulf War.

### **28 February 1967**

PFC James Anderson Jr. is first black Marine to win the Medal of Honor.




