## Head of Code Talkers Association Dies

FLAGSTAFF, Arizona – Keith Little envisioned a place that would house the stories of the Navajo Code Talkers and where people could learn more about the famed World War II group who used their native language as a weapon.

His family now hopes to carry out his dream of a museum in Arizona that also will hold wartime memorabilia and serve as a haven for veterans. Little, one of the most recognizable of the remaining Code Talkers, died of melanoma Tuesday night at a Fort Defiance hospital, said his wife, Nellie. He was 87.

Little was 17 when he joined the Marine Corps, becoming one of hundreds of Navajos trained as Code Talkers. They used a code developed by 29 tribal members that was based on the then-unwritten Navajo language. Their code helped confound the Japanese and win the war.

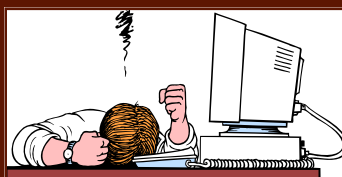

# U.S. Lawmaker Wants Marines Recognized for Libyan Operations

NOTE – The following article by Gidget Fuentes (staff writer) appeared in the December 10th edition of the on-line Marine Corps Times.

Eight months after Marine Corps aviators first flew missions in Libya – including the rescue of a downed Air Force pilot – a California representative wants to know why no Marine has been honored with awards for their combat actions.

**Rep. Duncan Hunter, R-CA**, directed his question to **Navy Secretary Ray Mabus**, who has the primary awarding authority for awards such as the *Distinguished Flying Cross* and *Air Medal*.

“It has come to my attention that no awards or recognition have been approved for Marine aviators who flew combat missions over Libya,” Hunter wrote in a recent letter to Mabus.

The missions included a *tactical recovery of aircraft and personnel operation to rescue the pilot of an F-15E Strike Eagle jet that crashed* on March 21 in a rebel-held area of northeast Libya.

That call went to the **26th Marine Expeditionary Unit**, which sent its **TRAP** (*Tactical Recovery of Aircraft and Personnel*) force – which included two MV-22 Ospreys, two CH-53E Super Stallion helicopters and two AV-8B Harrier jets, along with a KC-130J tanker – from the amphibious assault ship **U.S.S. Kearsarge** for the nighttime mission to recover the pilot and co-pilot who safely ejected from the jet. While the co-pilot got shelter from rebels, the pilot evaded capture and hid until the TRAP platoon assigned to the MEU grabbed him and put him into an Osprey.

Awards could be forthcoming. The Navy’s assistant secretary for manpower and reserve affairs has been considering a request submitted by U.S. Naval Forces Africa to designate the Libya area as authorized for combat awards.

“A decision is expected in the near future,” said **Lt. Matt Allen**, a Navy spokesman at the Pentagon.

In his letter, Hunter, a Marine veteran of Iraq and Afghanistan, highlighted the dangers the rescue force faced.

“Pilots of the Harrier jet provided close-air support by dropping two 500-pound bombs in the area between the downed pilot and a sizable force that was quickly closing in on the F-15 pilot,” Hunter wrote. “There is no doubt that the actions by these Marines during this mission, and throughout the entire U.S.-led operations in Libya, deserve some type of recognition.”

“I am concerned that in the effort to downplay the combat role involved in the U.S. operations in Libya, political sensitivity has trumped American courage and bravery,” Hunter said.

Although Libya wasn’t a designated combat zone, the Defense Department approved Libya and neighboring

Tunisia for imminent danger pay. But service members don’t have to be in a designated combat zone to rate a combat medal, said Doug Sterner, a military historian.



**Norman Huffman** was welcomed as our newest member at our detachment’s December meeting.

Norm married his high school sweetheart **Barbara Dodson** in 1960 and had 2 children – **Norman Edward** and **Laura Marie**. Sadly, his wife Barbara succumbed to cancer in 1977.

Four years later, in 1981, Norm married **Jane Harrington**. They will be celebrating their 31<sup>st</sup> anniversary in February 2012. The Huffman’s have five grandchildren – 3 granddaughters and 2 grandsons.

Prior to his retirement, Norm worked as an automobile mechanic and had been the manager of **Wilson’s Service Station** (Mountain Road in Lake Shore) for twenty years at the time of his retirement in 2004. Norm says that he thoroughly enjoyed working at Wilson’s, a fact which is surely attested to by his almost 48 years of service there.

His hobbies include fishing on the Chesapeake Bay, shooting pool, performing volunteer work in his community and serving with his local fire company.

## Code Talkers... *(continued from page 1)*

“My motivation was to fight the enemy with a gun or whatever,” Little told The Associated Press in a July 2009 interview. “When I went into the Marine Corps ... I knew nothing about the Navajo code. It was really astonishing to me to get to Camp Pendleton and there were a bunch of Navajos there, and they were working with a Navajo code.”

Little, the longtime president of the Navajo Code Talkers Association until his death, traveled the country seeking funding for the museum that is expected to cost up to \$30 million. He preached about the preservation of Navajo traditions, culture and the language that the federal government tried to eradicate before he and others were called on to use it during the war.

It was a story he never tired of telling, association secretary Yvonne Murphy said.

“That was his life. That was the drive behind him,” Murphy said. “It didn’t matter where he was. If there were people who came and wanted to sit and talk with him, he would share with them.”

Nellie Little said her husband hoped the museum would be open by 2014 at its proposed location just outside the Navajo Nation capital of Window Rock. But she said more money is needed.

She is asking people to send museum donations rather than flowers for his memorial.

Keith Little’s health had been deteriorating over the past year, as he went in and out of hospitals between speaking engagements and appearances in parades – the last time in New York in November for Veterans Day, the association said.

A video on the association’s website features Keith Little speaking about the importance of the unbreakable code. Fellow platoon members referred to the Navajos as “walking secret codes,” with each message having to be memorized and destroyed after it was sent or received, Keith Little says.

“That is something that in itself was marvelous,” he said in the AP interview. “It was so proficient and safe.”

A public memorial is planned for Friday in Window Rock, with funeral services scheduled Saturday in nearby Fort Defiance. Navajo President Ben Shelly has ordered flags lowered across the reservation from Thursday through Sunday in Keith Little’s honor.

# Marines Save Afghans in Daring Canal Rescue

A routine combined Afghan-Marine foot patrol was thrown into chaos on December 2, 2011 when a car traveling more than 40 mph struck the point man, plunging both car and soldier violently into a nearby canal.

Fortunately for all involved, the grunts on scene took swift action.

**Sgt. Zaheed**, of the Afghan National Army, was sweeping for improvised explosive devices along a dark road when the fast-moving vehicle approached. He tried to wave the car to stop, but it didn't slow. Caught between this threat and the rest of the patrol, Zaheed went for his weapon as a warning and waited until the last possible moment to step aside. It was too late.

In the dark night, the driver had not seen the troops, who were returning to Patrol Base Barcha in Helmand province after a resupply mission to a nearby outpost. When the driver finally spotted Zaheed's desperate warnings, he panicked, swerved and struck the soldier.

Without pause, **Sgt. Matt Garst**, 23, a squad leader with 2nd Platoon, Lima Company, 3rd Battalion, 3rd Marines, ordered his men to drop their gear and dive into the frigid, fast-moving canal. Meanwhile, three ANA soldiers and another Marine with an IED dog – **LCpl. James Blomstran**, 22 – pulled security on the road.

The rescue was difficult, and there was an entire family in the car. Making matters worse, the December night-time temperature in southern Afghanistan hovers around 35 to 40 degrees, and the canal was about 20 feet across and more than 12 feet deep.

"The current was extremely fast," Garst wrote in an email to Marine Corps Times. "The vehicle was under water in a matter of seconds. Just swimming out you had to fight against it."

With the floodgates open to supply water to fields during wheat season, the Helmand canal was more akin to a swift

river. So swift, in fact, that **LCpl. Nicholas Dumke**, 20, couldn't make it to the car. He had to head back to shore but was able to pull a child and a man to safety with a 4-foot piece of cloth.

**LCpl. Ryan Gerrity**, 21, zeroed in on Zaheed and pulled him to safety.

Garst located two women and an infant drowning. Panicked, they fought him, but he was able to push them above water, wrap his arms around them and get them to shore.

Gerrity, now on shore, worked with Blomstran to pull another woman and child to shore while Garst returned to the car and pulled another man to safety.

All eight members of the Afghan family plus Zaheed had been rescued. The family was shaken but for the most part unharmed. One boy had minor cuts on his head.

"They were scared. Really scared. And I wanted to make sure everybody got out," Garst wrote.

With everyone ashore, Gerrity and Garst treated Zaheed, who, although awake, was slurring his speech, upset and seriously injured. He had head lacerations and swelling, his ankle was shattered and he was hemorrhaging. But the Marines' swift action kept him from going into shock. Gerrity elevated Zaheed's feet and Garst fashioned a splint out of two antennas and gauze. A passing driver accompanied by an ANA soldier took Zaheed back to base. He was airlifted to Camp Dwyer within the hour.

The Marines advised the family to rest at the nearby home of a family friend.

"Talking with the people who live where I sent them to, they were highly grateful," Garst said, "and called us saviors." Garst downplayed the heroics. "We aren't lifesavers," he said. "We're Marines." Garst said he and his men from the Hawaii-based unit did not anticipate a river rescue as part of their deployment but said they were compelled to act. "If we would not have jumped in, that family would've drowned," he said. "Each Marine who went in risked his own life."

Zaheed is reportedly doing well and should be back on his feet in two to three months, Garst said, adding, "He was a good soldier. He was an awesome point man and a friend to the squad."

Garst is no stranger to close calls or freak accidents. Not only has his unit seen its share of firefights since arriving in November, but in the summer of 2010, he stepped on an IED in Helmand and lived to tell about it. Then a corporal leading a patrol, he was flung above an 8-foot wall by the blast but suffered little more than the worst headache of his life.

"My first thought was, 'Oh s---, I just hit an IED,'" he said. "Then I thought, 'Well, I'm standing. That's good.'"

## 1st UAV Cargo Delivery

Resupply missions just got safer for Marines in Afghanistan with the first delivery of goods by an unmanned helicopter.

A detachment from **Marine Unmanned Aerial Vehicle Squadron 1** out of Twentynine Palms, Ca., completed the first combat flight on December 17th using a K-MAX helicopter to deliver 3,500 pounds of food and supplies from Camp Dwyer, Afghanistan, to Combat Outpost Payne in Helmand province, according to a Marine news release.

“We delivered cargo today that was supposed to be delivered by convoy,” said **Major Kyle O’Connor**, the officer-in-charge of the squadron’s unmanned helicopter resupply operations. “Now that convoy has three pallets that it does not have to carry.”

With improvised explosive devices (IEDs) the biggest killer of Marines in Afghanistan, reducing the amount of supplies carried by ground convoys is a priority.

The December 17th flight kicks off a six-month field test. At the end of the test, the Marine Corps could decide to press more of the helicopters into service.

## Corps History

### **4 January 1991**

Marine helicopters evacuate 281 people from U.S. Embassy in Mogadishu, Somalia.

### **7 January 1969**

Medal of Honor awarded posthumously to 1st Marine Division Chaplain, Lt. V.R. Capodanno, U.S. Navy, who was killed in action in Quang Tin Province, Vietnam on 4 September 1967.

### **8 January 1815**

Marines, with Andrew Jackson's help, repulsed British forces at New Orleans.

### **9 January 2002**

All seven Marine crewmen were killed when their KC-130R crashed near a forward operating base at Shamsi, Pakistan. Enemy ground fire was not suspected in the crash. These Marines of VMGR-352 were the first to die in the war on terrorism.

### **10 January 1995**

2,600 U.S. Marines deployed to Somalia (Operation United Shield) to assist in the final withdrawal of UN peace-keeping troops from Somalia.

### **11 January 2007**

President George W. Bush presented the Medal of Honor to Corporal Jason L. Dunham's family during a White House ceremony. Corporal Dunham, who died of wounds sustained in combat in April 2004, was not only the first Marine to receive the nation's highest military award for valor for Operation Iraqi Freedom, but also the first Marine to receive the award for any action since 1970.

### **13 January 2003**

General James L. Jones relinquished duties as the 32nd Commandant of the Marine Corps to General Michael W. Hagee during a ceremony at the U.S. Naval Academy. General Jones was the first commandant in 40 years not to retire from the position as he became the first Marine to assume duties as the head of U.S. European Command on 16 January 2003 and Supreme Allied Commander, Europe on the following day.

### **18 January 1951**

Marines of the 1st Marine Division begin mop-up operations against guerrillas in the Pohang, South Korea region, following their epic battle with Communist Chinese troops at the Chosin (Changjin) Reservoir.

### **20 January 1968**

The second battle for Khe Sanh began when Marines from the 3rd Battalion, 26th Marines attacked a North Vietnamese battalion between Hill 881 South and Hill 881 North.

### **22 January 1969**

Operation Dewey Canyon began with the airlift of the 9th Marines and supporting artillery into the A Shau/Da Krang Valleys.

### **25 January 1856**

Marines and seamen from the U.S.S. DECATUR went ashore at the village of Seattle, Washington, to protect settlers from Indian raids.

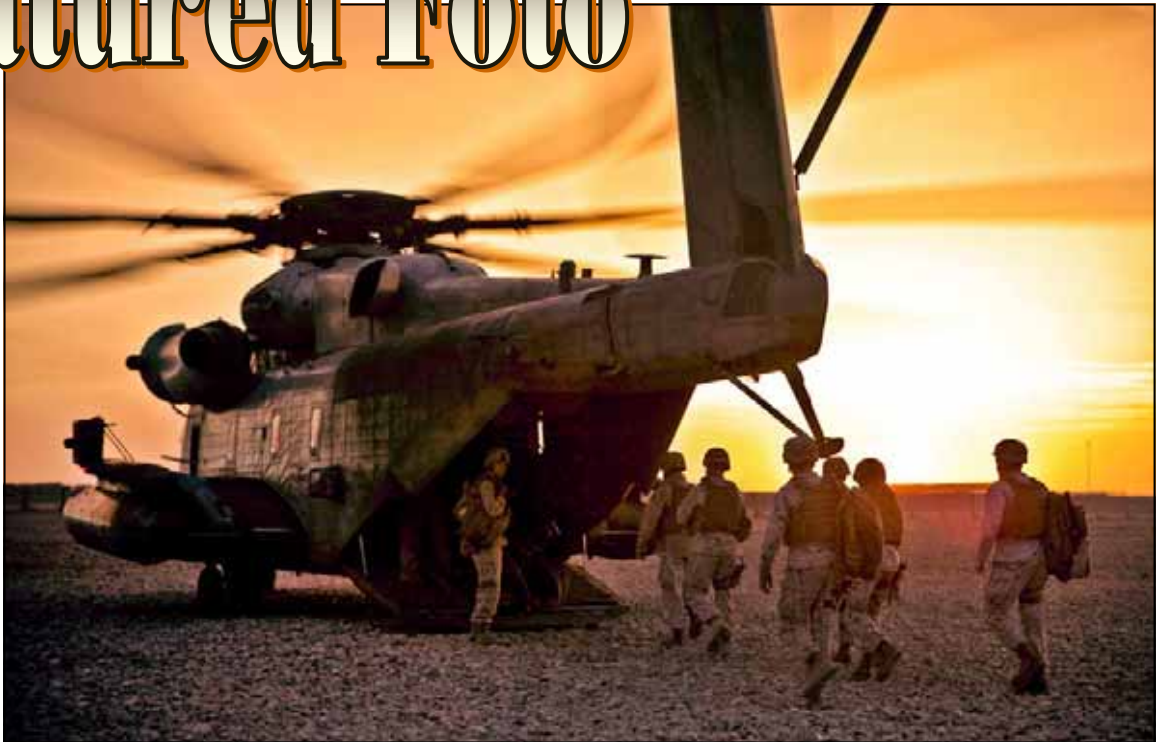
