New Sergeant Major for 8th & I

The Washington, DC command housing the Marines’ most prestigious ceremonial units will receive its first female Sergeant Major later this week.

Sergeant Major Angela Maness will assume the duties of senior enlisted Marine at Marine Barracks Washington, the ‘*oldest post of the Corps*’ during a Thursday morning ceremony, according to news releases from Marine officials.

Maness joined the Marines in 1987 and has previously served as Sergeant Major for *Combat Logistics Battalion 8, Camp Lejeune, NC*, and for *Marine Corps Air Station Cherry Point, NC*. At the barracks, she will replace **Sergeant Major Eric J. Stockton**, who took the post in 2010 and will be retiring at the end of a 30-year career.

“We’re very excited about the possibilities and the leadership potential that Sergeant Major Maness brings to the table,” said **Captain Jack Norton**, a spokesman for 8th and I. “She is the most qualified for the job; she just happens to be a woman.”

Congress Seeks Common Combat Uniform

NOTE – The following story by Rick Maze recently appeared on the Marine Corps Times website.

The days of service-specific combat and camouflage uniforms are clearly numbered as the **Senate Armed Services Committee** has joined its House counterpart in telling the services to quit wasting money on their own unique styles.

The 2014 defense policy bill passed by the Senate committee says that with a few exceptions, the services would be prohibited from adopting new designs for combat and camouflage uniforms as of the day the bill becomes law.

The prohibition would extend to potential new designs using current fabric or camouflage patterns, in the event that the services try to simply move the pockets or change the seams to distinguish their specific uniforms.

The bill establishes as policy the requirement of reducing separate development and fielding of service-specific utility uniforms, saying that to the 'maximum extent practicable,' the **Defense Department** should require the services to collectively adopt and field combat and camouflage uniforms. This would not apply to special operating forces or to personnel supporting those forces.

Similar restrictions were passed by the **House Armed Services Committee** in its version of the defense bill, with one key difference. The House measure, **HR 1960**, sets a deadline of October 1, 2018, for a joint combat uniform to be in use. The Senate bill had no similar deadline, apparently content to let the services continue using their current unique designs but preventing any new uniforms from being developed unless they are shared across the force.

The Senate bill, **S 1197**, includes one camouflage uniform provision not mentioned by the House: It would prohibit any service from preventing another service from using their combat or camouflage uniform. That language may have been added with the Marine Corps in mind; the Corps has been highly protective of its distinctive 'MarPat' design.

Differences between the House and Senate bills will have to be reconciled before a final bill becomes law.

The Senate committee notes that the services generally wore 'the same pattern and family of combat camouflage and utility uniforms' before 2002, but slowly launched their own designs.

The **Government Accountability Office**, the investigative arm of Congress, 'found no performance standards for specific combat environments, no criteria for evaluating the effectiveness of camouflage patterns, and no requirements for the services to test interoperability between their uniforms and other tactical gear, despite the DoD establishing a **Joint Clothing and Textiles Governance Board**,' the Senate report says.

Rifle & Pistol Team

I am pleased to announce that several members have expressed an interest in shooting. I think this is great! There is always room for new shooters... and we can field as many teams as we can. I look forward to seeing you on the range.

I have the results for the **Department of New York Service Rifle Tournament** held near Albany, NY in May. **Ben Wells** and I participated in 2 of the 3 matches that weekend. There were 41 total shooters.

The first match was a *30 round CMP Match* shot at *200 yards*. Shooters fired 10 rounds each in *slow-fire prone, rapid fire prone, and off-hand (standing)* stages. With a rifle fresh out of the box, and NOT sighted in, Ben fired a 159-1x and placed **40th**. My rifle was zeroed and I shot a 294-11x which was high score.

Note – While any service rifle was allowed, this particular match was recorded as vintage. Ben and I fired modern rifles. The 2nd place shooter, 282-7x, was declared the winner.

The second match of the day was a *Four Position Match* using any service rifle. This match was also fired at *200 yards* with 10 rounds each in *prone, sitting, kneeling, and off-hand*. With better dope on his rifle, Ben fired a 305-1x and placed **25th**. I shot a 374-5x and placed **4th**. The winner shot a 380. These matches are just like you remember range week in the Corps... including the always fun time of pulling butts.

Perhaps next month I'll have the results of the **Department of Pennsylvania Pistol Match**.

Life Membership Fees May Be Increasing!

NOTE – The following information was provided by Roger Ware, the Department of West Virginia Commandant and Mideast Division Adjutant.

A proposed 2013 National By-laws change has been proposed that would increase the life member fee for the older members of the league.

The current fees for members who could be affected are...

Ages 51 to 60 \$300
 Age 61 & over \$150

If passed, the new fees would be...

Ages 51 to 64 \$300
 Age 65 & over \$200

Please note the change for ages 61 through 64 is an additional \$150. The increase for members 65 and over would amount to \$50.

Consideration of this by-law change will take place at the 2013 National Convention.





Lest We Forget...

Irene Airey, age 87, a resident of Riviera Beach for 55 years, and previously of Baltimore, died on June 19, 2013 at *Baltimore Washington Medical Center* after a brief illness.

She was born on March 8, 1926, in Baltimore, to the late **Constance and Joseph Sparra**.

After graduating from *Saint Mary's Star of the Sea*, she worked as a net-maker for the *Linen Thread Company* for 17 years. She was a member of the *Marine Corps League's Ladies Auxiliary of Detachment 1049*, as well as the *Poplar Ridge Seniors* and *Stoney Creek Democratic Clubs*. She enjoyed bingo, travelling to the casinos, taking care of her home, especially outdoor work and gardening, and spending time with her family and friends at *Cookies Restaurant*.

Memorial services and viewings were held at the *Gregory J. Gonce Funeral Home* in Pasadena, Maryland on Sunday, June 23rd and Monday June 24th. 

Words of A Marine General, Who Lost A Son In Combat, Resonate

NOTE – The following story by Jim Michaels of USA TODAY recently appeared on the Marine Corps Times website.

At a time when the divide between the military and civilian world has never been greater, the words of **Marine General John Kelly** have helped bridge the gap. He didn't set out to be a spokesman. A former enlisted infantryman, Kelly rose to a four-star rank over a nearly 40-year career leading Marines, including many months in combat.

He had two sons who followed him into the Marine Corps. One, **1st Lt. Robert Michael Kelly**, 29, was killed in Afghanistan in 2010 while leading a patrol in Sangin, at the time a hotly contested piece of terrain in Helmand Province.

Since then, the elder Kelly has resisted media efforts to make the story about him or his loss. But he has made a number of speeches to Marines, families and other groups.

His words have resonated, touching on themes that rarely get a wide airing. His talks have gone viral, earning him a broad following. *“It extends beyond the Marine community,”* says **Marine Colonel Chris Hughes**.

Only days after he learned of his son's death, Kelly kept a commitment to give a speech to the *Semper Fi Society of St. Louis* in November 2010.

“It would become one of the most memorable moments in the lives of everyone in the room,” according to the organization's website. In the speech, Kelly addressed a familiar theme: *How only 1 percent of the nation has shouldered most of the burden of the wars in Iraq and Afghanistan.* But he went on to say voicing support for the troops alone is insufficient, suggesting that those sentiments can sometimes bleed into condescension. *“If anyone thinks you can somehow thank them for their service and not support the cause for which they fight – America's survival – then these people are lying to themselves and rationalizing away something in their own lives, but more importantly they are slighting our warriors and mocking their commitment to this nation,”* Kelly said.

Added Kelly: *“It's not Bush's war. It's not Obama's war. It's our war and we can't run away from it.”* Thousands have been killed or injured in the wars, but they are not victims, Kelly said. *“The chattering class and all those who doubt America's intentions, and resolve, endeavor to make them and their families out to be victims, but they are wrong,”* Kelly wrote in prepared remarks for the speech. *“We who have served and are serving refuse their sympathy.”*

Kelly went on to speak not about his own loss, but about two Marines who were killed while stopping a suicide bomber in Iraq. Instead of running when it raced toward them, the Marines opened fire, saving 150 of their American and Iraqi colleagues inside a base.

For **Cindy Kruger**, whose son **Sergeant Michael Hardegree** died in Iraq, Kelly's ability to make a major speech so soon after learning of his son's death was an inspiration. *“For most of us it would be years before we could do that,”* she said.

Those who know him say the remarks are in keeping with long-held beliefs and he doesn't relish being thrust into the public spotlight. *“Service is a privilege,”* says **Marine Brigadier General Eric Smith**, who has served with Kelly. *“That's what he's talking about. We don't want your sympathy at all. We're not saying that in a negative way. We're just saying you may not understand why we're doing what we're doing.”*

Earlier this month Kelly spoke at the dedication of a memorial to [the] 5th Marines, the unit his son was fighting with when he was killed. Kelly said he struggled with the question of whether any cause was noble enough to justify losing a son.

“I realized the question was not mine to ask or to answer,” he said. *“It didn't matter what I thought. Only what he thought. The answer was his to give. He gave it by his actions that day, by the entire life that brought him to the instant he was lost.”*

“That is the answer to all of my questions,” Kelly said. *“I need nothing else.”*

Maness's history-making assignment follows a series of high-profile sex assault incidents that have given [the] Marine Barracks a black eye. In March 2012, two female officers who had served at 8th and I joined six other female sailors and Marines in filing a federal lawsuit in U.S. District Court in Washington, alleging they had been raped while in the military. The suit named as defendants **Commandant General James Amos** and former Commandants, **Navy Secretary Ray Mabus** and former secretaries and Defense Secretary **Leon Panetta** and former secretaries.

One of the Marines, **1st Lieutenant Ariana Klay**, alleged she was gang-raped at her home a block away from the barracks in 2010, and [was] later shamed and harassed by her peers for the incident. The other, **2nd Lieutenant Elle Helmer**, a public affairs officer, said in the complaint that she was raped by a superior in 2006 after being pressured to drink excessively during a 'pub crawl.'

The lawsuit was dismissed in February 2013 when **U.S. District Judge Amy Berman Jackson** ruled that her court could not provide the kind of remedy the plaintiffs sought; under the *Feres Doctrine*, the federal government cannot be held liable for injuries related to troops' military service.

Most recently, a female bartender, **Karalen Morthole**, told NBC News that she had been raped by **Master Sergeant Ronald Bohlayer** on the premises of 8th and I after a night of drinking with him. Though a Marine investigating officer recommended that rape charges be dismissed, the recommendation was overruled by **Major General James Kessler**, the court-martial's convening authority, and the case will proceed.

Maness was honored in May by the *Congressional Caucus for Women's Issues* for her military achievements, including being slated to assume the role of Sergeant Major at Marine Barracks Washington.

"It is an honor and a privilege to be selected," she said, according to a news release from the event. *"Words of wisdom, not just for female Marines, for every Marine: Do your job, stay in the fight and do the best job you can do for your boss, for the Corps, for America."*

Restaurant Honors Local Marine

The Breakfast Shoppe in Severna Park recently hosted an event – *'Taylor Wild Day'* – and presented a check derived from the proceeds to *Friends of the Fallen* in the name of Severna Park resident and U.S. Marine **Lance Corporal William Taylor Wild IV**.

After Wild was killed during a training exercise in Hawthorne, Nevada, on March 18, the *Breakfast Shoppe* began collecting donations for *Friends of the Fallen*, a support group of volunteers located at **Dover Air Force Base** in Delaware. The group provides assistance to families of the fallen.

The day before LCpl Wild left for training in California, he stopped by *The Breakfast Shoppe* for some *'chicken and waffles'* accompanied by his brother and sister. Restaurant owner **Kyle Algaze** says the dish was not on the menu that day, but he made it especially for Taylor. Algaze went on to relate how Taylor's brother **Griffin** teased that Taylor always got what he wanted. That's just one memory Algaze and *The Breakfast Shoppe* family is left with now that Taylor Wild is gone. Wild, 21, a Severna Park High School graduate, was among seven Marines killed during a training exercise March 18th in Nevada.

The Wild family are regulars at *The Breakfast Shoppe*. Algaze said Taylor's dad **Bill** comes in a few times a week. At Taylor Wild's viewing, Algaze learned that his establishment was one of his favorite restaurants. When Wild joined the Marines the restaurant put a brick up to honor him while he was away. Now, *The Breakfast Shoppe* and the rest of the Severna Park community is left to mourn the loss of Wild, and reflect on the memories of him that they have stashed away like mini-treasures.

"We miss him dearly and our hearts go out to his family and friends at this time," Algaze also stated in a letter to potential donors that, *"Taylor was a brother, son and a friend who held our country in the highest regard. He gave the ultimate sacrifice, and it is our goal to honor him in any way possible. On Behalf of a Grateful Nation, thank you Taylor. We miss you."*

Corps Bracing For Loss of Another 8,000 Marines

The Marine Corps is bracing to lose another 8,000 active-duty Marines on top of what already had been planned as it faces deep, federally mandated budget cuts, the service's commandant said Wednesday.

The additional manpower reduction would drop the service to about 174,000 active-duty personnel, **General Jim Amos** said during a breakfast with reporters in Washington. The Corps is currently drawing down from a peak of more than 202,100 Marines to 182,100 by fall 2016, but must plan to go deeper now as a result of sequestration cuts, the drastic budget reductions triggered March 1 by Congress' inability to reach an agreement on a better way to reduce the federal deficit.

Amos' comments came following a new review of strategic choices conducted this spring. Courses of action have been presented by the services and **Defense Secretary Chuck Hagel's** staff, but the secretary has not yet made any decisions, the commandant said.

"As a result of sequestration, assuming this thing does not change, the Marine Corps is probably going to go down another 8,000," the commandant said. *"That's significant. We know what it is. We know what kind of units it will be. We know where it will come from across the United States. That's the reality of it."*

The general declined to say which specific units will be targeted with the additional cuts, but acknowledged it will effect virtually all components of the Corps, including headquarters, infantry, logistics, and fixed-wing and rotary aviation.

Amos also has made an alternative offer to Hagel, the commandant said: *"Tell me what my bill is, and I'll build you the best Marine Corps I can."*

The Corps announced early in 2012 that the service would draw down from 202,100 to 182,100. At the same time, top Marine officials had been advocating to reduce the Corps to 186,800 Marines, but the Pentagon decided it would be necessary to

reduce end strength further.

The Corps' plan to draw down to 182,100 would leave it with 23 infantry battalions, four less than it had with 202,100 personnel. Cutting to about 174,000 Marines would mean even fewer, but Amos declined to say how many until Hagel decides on the way ahead.

Amos has said previously that shrinking the Corps beyond 23 active-duty infantry battalions would create a tremendous strain on the service and its Marines during any large war in the future. The service would become a *"go-to-war-and-come-home-when-it's-over force,"* Amos said told the House Armed Services Committee in April.

Amos said Tuesday that even with the additional cuts, the Marine Corps Reserve would still have about 39,600 Marines, as it has for several years. For every infantry battalion cut from the active-duty force, there would be a corresponding cut to the other components of the service.

"That's the core unit in the Marine Corps," Amos said of infantry battalions. *"It's like Mr. Potato Head. That's the potato, and everything else is kind of plugged in along it to make it a head."*

The commandant stressed on Wednesday that he is not in favor of the additional cuts, but that the Corps has no choice in light of sequestration staying in place.

"By the way, I want to go on record: I don't want this to happen," he said. *"I don't want anybody here to think that the commandant thinks this is a good idea."*

Amos also said on Tuesday that the Corps' drawdown in Afghanistan is likely to occur ahead of schedule because Afghan forces have asserted themselves well in Helmand province this year, as they take the lead on providing security. The number of Marine adviser teams needed down-range will likely be reduced beginning this summer, and a one-star general overseeing them will return to the U.S. by the fall, the commandant said.

There are currently about 7,000 Marines in Afghanistan, part of the 66,000-plus force of U.S. personnel that are part of the **International Security Assistance Force** commanded by Marine **General Joseph Dunford**. The one-star general overseeing Marine advisers in Helmand is **Brigadier General George Smith**, the deputy commanding general for security assistance for **Regional Command Southwest**.



Women In Special Ops Raise 'Genuine Concerns'

The days of 'Rambo' are over, but the men of *Special Operations* will still get a say on whether they want women on their small teams working in austere conditions, an Army general said Tuesday.

Speaking at a Pentagon briefing on opening up combat roles to women, **Army Major General Bennet Sacolick** said he was less concerned about women meeting the physical standards required for *Special Operations* troops than their ability to adapt to the social and behavioral demands put upon small *A-teams* of 12 or less.

"There's privacy issues" that have to be taken into account when it comes to *"female operators in an austere environment"* for long periods of time, said Sacolick, the Army's *Director of Force Management and Development for Special Operations*. *"We have some genuine concerns."*

"We don't deploy in large formations," Sacolick said. *"I'm actually more concerned with the men and their reaction"* to having women on their teams, he said. Sacolick said the Army would conduct surveys to gauge the reaction of men. *"I need to give them a venue to voice their opinion,"* Sacolick said.

In stating that the *"Days of Rambo are over,"* Sacolick said he meant that special operators in modern warfare are more valued for their language skills and intelligence than their physical prowess.

Sacolick was on a panel of senior officers from all the services who spoke on their plans to open up *military occupational specialties* previously closed to women as ordered last January by former **Defense Secretary Leon Panetta** and **General Martin Dempsey, Chairman of the Joint Chiefs of Staff**. The action by Panetta and Dempsey has since been endorsed by current **Defense Secretary Chuck Hagel**.

Under the planning, each of the services will review the current physical and mental requirements for certain infantry, armor, commando and other front-line positions and come up with a common standard for men and women in each MOS.

Colonel Jon Aytes, head of the **Marines' Military Policy Branch**, said he was looking to adopt standards that *"don't set our female Marines for failure."*

Aytes said that this summer, groups of 400 female and 400 male Marines would be select-ed to run through a series of



common tests to develop a gender-neutral standard.

Members of the panel said that under the current guidelines women could possibly begin training as Army Rangers in mid-2015 and as Navy SEALs in 2016. The assumption from the Defense Department is that all jobs now closed to women would be open unless the services come back with detailed reasons for an exception.

The move to open up positions to women reflected the experience of the wars in Iraq and Afghanistan, where women have fought and died on a scale unprecedented in U.S. military history. More than 150 women have been killed in Iraq and Afghanistan, and more than 300 have received the Purple Heart.

Expanding opportunities for women in the military has generated bipartisan support in Congress. In a statement Tuesday, **Senator John McCain (R-AZ)** said *"I support expanding the eligibility of women to serve in the most elite echelons of our nation's armed forces, including in combat roles, and I look forward to reviewing the details of the Pentagon's announced initiative in this area."*

"The plans submitted by the armed forces allowing military women to compete for select combat positions are a move in the right direction," said **Vania Leveille, Senior Legislative Counsel for the American Civil Liberties Union**. The **ACLU** last year filed a lawsuit to open up more than 200,000 positions that were then closed to women.

Critics warned that opening up ground combat positions to women would result in lower physical standards and possibly cost lives.

"The courage of our military women is not in question, but empirical evidence that is based on actual experience, not what amounts to Amazon Warrior Myths, indicates that women are not interchangeable with men in direct ground combat," said **Elaine Donnelly, President of the Center for Military Readiness**.

"In that environment, women do not have an equal opportunity to survive, or help fellow soldiers survive," Donnelly said.





Corps History

1 July 1920

Major General John A. Lejeune becomes the 13th Commandant of the Marine Corps.

4 July 1800

Marine Corps Band makes its first public appearance at Tun Tavern (Philadelphia, PA).

5 July 1968

Marines abandon Khe Sanh combat base.

6 July 1905

Marines escort the body of John Paul Jones during its relocation from France to Annapolis, MD.

7 July 1941

The 1st Marine Aircraft Wing activated at Quantico, Va. Within a year, the Wing would participate in the Guadalcanal offensive.

18 July 1918

The 4th Marine Brigade began an attack near Soissons, France, as part of a three-division counter-attack against the Germans. In the first two days of battle, the brigade sustained 1,972 casualties.

18 July 1948

Twelve Marines at consulate in Jerusalem (Israel) begin modern day Marine Security Guard program.

23 July 2002

Three Marines – Lt. Colonel James G. Kyser IV, Major Matthew Coon, & Staff Sergeant Robert Wallace – awarded the Navy and Marine Corps Medal for heroism for their rescue efforts following the September 11th terrorist attacks on the Pentagon.

23 July 2004

Six Marines from 1st Reconnaissance Battalion, 1st Marine Division, completed the first combat HALO (high-altitude, high-opening) parachute drop in the history of the Marine Corps. The parachute insertion occurred during Operation Iraqi Freedom as an alternate to the highly visible ground insertions that were drawing a lot of attention and fire.

25 July 1930

Lieutenant Lewis Puller wins first of five Navy Crosses chasing Sandino guerrillas in Nicaragua.

25 July 1944

The 2nd and 4th Marine Divisions began a shoulder-to-shoulder sweep of the island and clear the airfield from which the Enola Gay would begin its historic flight to Hiroshima a year later.

27 July 1953

Korean War ended – armistice signed at Panmunjom, Korea.

28 July 1918

Brigadier General John A. Lejeune assumed command of the 2nd Division, U.S. Army in France, and remained in that capacity until August 1919 when the unit was demobilized. He was the first Marine officer to hold an Army divisional command.


