Lejeune's Water - Toxic Since 1948?

Drinking water contamination at North Carolina's sprawling Camp Lejeune military base could date to 1948, five years earlier than researchers had reported previously, a federal report indicates.

The *Agency for Toxic Substances and Disease Registry* plans to release a report Friday on the contamination that has led to a long-running dispute between former residents and the Marines Corps.

TCE, an *industrial solvent* now known as a human carcinogen, likely first exceeded the maximum contaminant level in August 1953, but evidence shows its presence in the water supply might date as far back as **November 1948**, the report states. A copy of the report was obtained Thursday by **The Associated Press**.

“Basically, it's vindication and confirmation for what I've been saying for nearly 16 years,” said retired Marine **Master Sergeant Jerry Ensminger**, a leader in a protracted fight for information about the contamination. **“The truth is finally coming out.”**

Ensminger blames the contamination for the leukemia that killed his 9-year-old daughter, **Janey**, in 1985. Marines and family members have blamed the contamination for many kinds of cancers, including breast cancer in men and women, bladder cancer and liver cancer.

OEF Casualties Memorialized

Editor's Note – The following is an edited version of an article by Kevin Lilley (Staff Writer) appeared on the Marine Corps Times website.

Ron White once memorized a deck of cards in 87 seconds. That's every card, every suit, in every position in the deck — from 1 through 52 — in less than a minute and a half. It was, at the time, an American record.

White, a former reserve intelligence specialist first class, deployed to Afghanistan in 2007 as an individual augmentee. Back home again, he walked by the **Vietnam Veterans Memorial** and wondered to himself, “What will the Afghanistan monument look like?”

On February 28 in Fort Worth, Texas, he built a temporary one from memory: about 2,200 names, handwritten in white, on a 50-foot-wide, 7-foot-tall wall. **“It took me 11 hours.”** said White, a two-time national memory champion who has made media appearances for his recollecting skills. **“No bathroom breaks.”**

The process began May 1, when he began memorizing the names from a book he carried everywhere. It was the largest memory project he'd ever undertaken; he started the website www.americasmemory.com to outline his effort and solicit donations for the **Wounded Warrior Project**...

...one memory stands out for the memory champ. A spectator arrived and asked when he'd be writing the name of **Army Pfc. Austin Staggs**, who died from small-arms fire in an insurgent attack in Nangarhar province in November 2010. White asked the woman whether she knew Staggs. **“He was my grandson,”** she replied. **“I came out here to watch you write his name.”**

White told the woman it would be at least two more hours. She sat down in a chair and waited. About three hours later, he told her, **“Ma'am, I'm about 10 minutes away,”** and apologized for the delay. She said it was fine; it had given Staggs' mother time to come and watch the name go up.

Budget Cuts Curtail Marine Corps' Ceremonial Units

The Marine Corps' premier ceremonial unit is the latest target of federal budget cuts.

Several upcoming performances by the **Marine Corps Battle Color Detachment** were abruptly canceled Friday on orders from **Defense Secretary Chuck Hagel**, according to an official with knowledge of the situation. The unit is based in Washington and includes the '**Commandant's Own**' **Marine Corps Drum and Bugle Corps**, the service's official Color Guard and its famed **Silent Drill Platoon**.

All of the canceled shows – five total – were scheduled for this week at Marine Corps bases in North Carolina, South Carolina and Georgia. The directive from Hagel's office restricts travel for all musical and ceremonial units, according to Marine officials at Camp Lejeune, N.C., where the Battle Color Detachment was to perform Friday.

Hagel's office could not immediately provide a copy of the directive.

On Monday, officials at **Marine Corps Logistics Base Albany, Ga.**, scrambled to announce cancellation of a performance set for Tuesday. The event was expected to draw a crowd of 5,000. At **Camp Lejeune**, public affairs personnel distributed a brief news release indicating federal budget cuts were to blame.

The Battle Color Detachment just returned to Washington from a weeklong tour of West Coast Marine Corps bases. Cancellation of its East Coast tour raises questions as to whether the unit will face a lengthy hold on such activity.

That's not immediately clear, said **Captain Jack Norton**, a spokesman for Marine Barracks Washington.

"At this time of budgetary uncertainty, all units ... are re-evaluating how money is spent and the Barracks is no different," he said, adding that currently there are no plans to

alter the unit's annual summer schedule, which includes Friday evening parades at the Barracks' headquarters and Tuesday sunset parades at the Marine Corps War Memorial near Arlington National Cemetery.

Also unclear is how much the military will save by curtailing performances of its prestigious show units. The Drum and Bugle Corps comprises 85 Marines, while the elite Silent Drill Platoon has 24 members. The Color Guard includes three teams of four Marines who travel yearly to hundreds of events throughout the country.

Though little has been said about the rationale of cancelling the tour, it may be part of a larger move to crack down on military and government activities considered nonessential. The Navy has cancelled a series of performances by the **Blue Angels**, its famed show squadron, and the **White House** announced Monday that its April 1 **Easter Egg Roll** may also fall victim to spending cuts.



Others stopped by to pay tribute to family members and those they had served with. White finished the list, stepped away from the wall and saluted.

"It was emotionally draining, physically and mentally," he said.

He plans to repeat the performance March 19 in San Antonio. He'd also like to write out the names in other locations around the nation throughout the year. He's considering creating a permanent wall — the one in his Fort Worth hometown is already down — but said plans are in the very early stages.

Right now, it's about finding more places to write the names, which White, 39, said gives him a chance to identify with the fallen and hold a personal connection to the notion of wartime sacrifice.

"Literally," he said, **"they are not forgotten."**



General Mattis Steps Down...

With a short speech, **Marine General James Mattis** stepped down as head of **U.S. Central Command** on Friday and began preparing in earnest for retirement.

Mattis was replaced as the head of CENTCOM, out of Tampa, FL., by **Army General Lloyd Austin**. It's expected he'll retire following a short period of transition behind the scenes.

Mattis, famous for his salty comments, offered another during his change of command ceremony. Addressing **Defense Secretary Chuck Hagel** and **Army General Martin Dempsey**, chairman of the Joint Chiefs, he paid rank-and-file service members in CENTCOM a compliment.

“Mister Secretary, Chairman, I would happily storm hell in the company of these troops, who I haven’t the words sufficient to praise, so I will not try,” Mattis said, according to a transcript of the event. *“They know how strongly I believe in them, how strongly they have demonstrated to the world that free men and women can fight like the dickens.”*

In a March 14th email to *Marine Corps Times*, Mattis said he prefers to end his 41-year career quietly.

“I’ve had some ‘riotous excursions of the human spirit’ alongside the young Sailors and Marines and it’s time to leave the stage to the young leaders who got their rank the old-fashioned way — they earned their stripes in combat,” Mattis said. *“The Corps is in good hands, and it’s been a privilege to serve with the Leathernecks. Now it’s time to go.”*

Just A Few Notable Mattis Quotes

- *“There is nothing better than getting shot at and missed. It’s really great.”*
- *“Marines don’t know how to spell the word defeat.”*

- *“The first time you blow someone away is not an insignificant event. That said, there are some ‘a~~holes’*

in the world that just need to be shot.”

- *“I come in peace. I didn’t bring artillery. But I’m pleading with you, with tears in my eyes: If you ‘~~~~’ with me, I’ll kill you all.”*
- *“The most important six inches on the battlefield is between your ears.”*
- *“You cannot allow any of your people to avoid the brutal facts. If they start living in a dream world, it’s going to be bad.”*
- *“You are part of the world’s most feared and trusted force. Engage your brain before you engage your weapon.”*
- *“I’m going to plead with you, do not cross us. Because if you do, the survivors will write about what we do here for 10,000 years.”*
- *“Demonstrate to the world there is ‘No Better Friend, No Worse Enemy’ than a U.S. Marine.”*



Highlights of the March 25th Meeting...

New Applicants for Membership...

Junior Vice Commandant **Ray Sturm** had no new member applications to present to the detachment. The effort to recruit both new and younger members needs to continue with vigor.

Old Business...

- Past Commandant and current Newsletter Editor, **Mac McNeir** thanked everyone, who came out to support him and **Ed Ross** in their efforts to raise funds for children's cancer research. Lance Corporal William Taylor Wild IV, USMC, 21, a resident of Severna Park died on March 18th while training at Hawthorne Army Depot, Nevada.

Taylor was born December 17, 1991 in Baltimore, MD. He grew up in the Whitehurst Community in Severna Park. Taylor was active in the Green Hornets sports program playing football, baseball, basketball and wrestling. He graduated from Severna Park High

School in June 2010. He was a proud member of the wrestling and baseball team, including the 2009 State Championship team. He earned a Minds in Motion award through his studies.

He joined the Marine Corps in October 2010. After graduating from boot camp, he attended the School of Infantry and was stationed at Camp Lejeune, NC assigned to the 1st Battalion, 9th Marines. He deployed with the 1/9 to Afghanistan in May, 2011 and returned on Christmas Day 2011. Upon returning, he completed Advanced Mortarman Course. In September of 2012, he volunteered to deploy for a mission to Kuwait. Most recently, he was training at the Mountain Warfare School in California and Hawthorne Army Depot in Nevada. During his career, he earned the *Combat Action Ribbon*, *Global War on Terrorism Expeditionary Medal*, *Sea Service Deployment Ribbon*, *Afghanistan Campaign Medal*, *Global War on Terrorism Service Medal*, *National Defense Service Medal* and *NATO ISAF Medal*.

Taylor was an avid Baltimore Ravens and Baltimore Orioles fan. He also enjoyed spending time boating with friends on the Severn and Magothy River and skeet shooting in Maryland and North Carolina. Taylor was known by all for his smile which he shared with everyone.

Taylor is survived by his parents, **William** and **Elizabeth**, brother, **Griffin** and sister, **Libby** all of Severna Park; grandparents **William** and **Patricia Wild** of Glen Burnie and **Jan Sprinkel** and **Judy Graham** of Annapolis; and several aunts, uncles and cousins. Toxic Water (continued from page 1)

Wells at the base were contaminated by fuel leaks and other sources of pollution before being closed three decades ago. Health officials have said they think as many as 1 million people may have been exposed to tainted water. Tests done in the early 1980s showed that water at a base treatment plant was “highly contaminated” with chlorinated hydrocarbons.

The federal agency had initially set 1953 as the date for the earliest known contamination in a letter written in January to the Department of Veterans Affairs. In that letter, the agency said computer modeling showed drinking water in the residential area called **Hadnot Point** was unsafe for human consumption as far back as that year.

That was still four years earlier than Marines and their dependents can secure health care and screening for illnesses related to the water. **President Barack Obama** signed a law last year granting health care and screening to Marines and their dependents on the base between 1957 and 1987. This week, **Senator Richard Burr** filed to extend coverage back to 1953.

The report lays out levels at the **Hadnot Point** and **Holcomb Boulevard** water treatment plants on base for various contaminants, including TCE, PCE, vinyl chloride and benzene. All those chemicals are classified as causing or probably causing cancer. It also includes one other chemical that's not carcinogenic.

For TCE, the maximum level of 783 parts per billion (*ppb*) was reached in November 1983 at Hadnot; at Holcomb it was 66 *ppb* in February 1985, the report says. The highest level allowed in drinking water is 5 *ppb*, set in 1989, meaning the Hadnot Point level was almost 157 times the highest level allowed now.

The Hadnot plant opened in 1942 and the second plant in the early 70s. Until the summer of 1972, the Hadnot treatment plant supplied all finished water distributed to bachelor and family housing units, the report says. It noted that the Holcomb Boulevard plant came online that year and its finished water was not contaminated except when it received water transfers from Hadnot Point.

Marine Corps Spokeswoman **Captain Kendra Motz** said Thursday that tests called for in Navy documents from the 1960s through the 1980s would not have detected chemicals such as TCE and PCE. The Navy instructions did not address such chlorinated hydrocarbon solvents until the **Environmental Protection Agency** began to regulate them in the late 1980s, she added.

The estimated monthly contamination gives researchers the information they need to do human health studies. The agency is working on four studies expected to be released this year and next year: birth defects and childhood cancer; health survey of Marine Corps personnel and civilians; male breast cancer and mortality.

HISTORIC DRINKING WATER



On March 15, 2013 the **Agency for Toxic Substances and Disease Registry (ATSDR)** released its “**Chapter A: Summary and Findings**” water modeling report for the Hadnot Point and Holcomb Boulevard Water Treatment Plants and Vicinities for Marine Corps Base Camp Lejeune, N.C.

This report provides ATSDR's assessment of past exposures to a class of chemicals known as *volatile organic compounds* (VOCs) in the drinking water distributed by these two Camp Lejeune water treatment systems. These VOCs were commonly used as solvents for cleaning machinery and weapons, for dry cleaning, and some are found in fuels.

ATSDR's water modeling estimates that the first month any VOC exceeded the current **Environmental Protection Agency** (EPA) regulatory standards in drinking water in the Hadnot Point system was August 1953, and at least one VOC exceeded the current standard in Hadnot Point drinking water from August 1953 through January 1985.

This release marks a major milestone towards the completion of scientific efforts pertaining to this issue and another step in ongoing efforts to provide comprehensive science-based answers to the health questions that have been raised. ATSDR will use these results and the results of a similar water model developed for the **Tarawa Terrace** area in 2007 to estimate chemical exposures for several of their on-going health studies.

Since 1991, the Marine Corps has supported scientific and public health organizations that are studying these issues. We continue to support these initiatives and are working diligently to identify and notify individuals who, in the past, may have been exposed to the chemicals in drinking water.

3 April 1945

Marines of the III Amphibious Corps effectively cut Okinawa in half in three days rather than the originally projected eleven.

8 April 1956

Six recruits drown in Ribbon Creek at MCRD Parris Island.

9 April 1942

105 Marines among American captives on Bataan Death March.

13 April 2003

Marines locate seven American soldiers held prisoner by the Iraqis near Samarra.

14 April 1865

Marines guard the body of **John Wilkes Booth** after the assassination of **Abraham Lincoln**.

15 April 1962 (Palm Sunday)

Marine Corps operational involvement in the Vietnam War begins, when HMM-362 arrives at Soc Trang in the Delta south of Saigon – as part of **Operaton Shufly** – to air-lift Vietnamese troops into battle.

18 April 1983

A Marine Security Guard is killed and seven wounded when a large car bomb explodes just outside the U.S. Embassy in Beirut, Lebanon.

19 April 1995

Captain Randolph A. Guzman and **Sergeant Benjamin L. Davis** are killed when the Alfred Murrah Federal Office Building is bombed in Oklahoma City, OK.

20 April 1861

Marines burn Norfolk Navy yard to prevent Confederate seizure.

24 April 1980

Three Marines perish in desert accident during effort to rescue American hostages in Teheran.

26 April 1965

Staff Sergeant Josephine (Davis) Gebers becomes first woman Marine to be awarded the Combat Action Ribbon after coming under enemy fire in Santo Domingo, Dominican Republic.

27 April 1805

1st Lieutenant **Presley N. O'Bannon** with several other Marines – part of a force of Greeks and Arabs led by **American Consul William Eaton** – raise the American flag over a conquered fortress of the Old World for the first time at Derne, Tripoli.

30 April 1975

4th Marines under **Colonel Al Gray** complete evacuation of U.S. Embassy in Saigon, RVN and nearby Tan Son Nhut Air Force Base.


