# Toys for Tots Team Goes All Out!

A truck-load of toys and \$3,300 was collected at the event, a fitting start for what was to become a very successful effort.

As many of you know, **Anne Arundel County Detachment 1049** of the Marine Corps League ran successful **Toys for Tots** campaigns for several years. Unfortunately, the detachment's involvement in the annual effort became virtually non-existent, when our previous Toys for Tots coordinator **Pete Pervi** stepped down after the **2009** campaign – the last of several highly successful annual drives. For the next two years, the detachment did not have an organized Toys for Tots effort and the children of **Northern Anne Arundel County** region were the unfortunate casualties.

- Place your recommendation within a sealed envelope, address the envelope to our Detachment Adjutant (David Wells), and place it in the detachment's mailbox at VFW Post 160.

Names will be accepted until **9 February 2013**. After that, the Adjutant, Senior Vice Commandant, and the Judge Advocate will review all nominees and select one candidate for submission to the Department of Maryland. The Department of Maryland Marine of the Year will be announced at the 2013 Department Convention Dinner, which will be held at the Princess Royale Oceanfront Hotel & Conference Center in Ocean City, Maryland on 27 April 2013.

## Detachment 1049 Marine of the Year – 2012

Nominations for the **Anne Arundel County Detachment 1049 Marine of the Year** will be accepted until **18 March 2013**. If you wish to nominate an individual, you will need to do the following:

- Write your nominee's name on a piece of paper along with and a minimum of three (3) reasons as to why that individual deserves the award.
- Sign your recommendation – unsigned recommendations will not be considered!
- Place your recommendation within a sealed envelope, write 'Detachment 1049 Marine of the Year – 2012' on the envelope, and place it in the detachment's mailbox at VFW Post 160.

The Detachment 1049 Marine of the Year will be selected in accordance with Detachment by-laws. The Detachment 1049 Marine of the Year will be announced at the Detachment Meeting scheduled for 22 April 2013.

# Toys... (continued from page 1)

For the next two years, **Dawn Parker** and **Nila Caulder-Rogers** made it their personal responsibility to do what they could as individuals to fill the void. Devoting their time and personal resources, they picked up toys from contributors such as **Elks Lodge 2482, Coldwell Banker, the Ferndale Committee Club, and American Legion Post 34**. All of the toys collected were then delivered to Toys for Tots representatives operating in the Baltimore region.

Early in 2012, the needy children of Northern Anne Arundel County gained a new champion, when **Dawn Parker** decided to become the official Toys for Tots Coordinator for Northern Anne Arundel County. Her immediate goal was to ensure that as many of the local children as possible would have tangible reasons to celebrate Christmas. As the following paragraphs indicate, it's obvious that Dawn – assisted by members of our detachment, the Auxiliary, active duty Marines, members of **VFW Post 160**, and others – was successful in achieving that goal.

The success of this year's Toys for Tots campaign was the cumulative result of several events and fundraising activities. The kick-off event was held on November 18 at **American Legion Post 40**, which was followed by two bike runs – one with **Mission BBQ** and another with **The Office Bar & Grill**. Events at **Aarons** in Riviera Beach and Lake Shore Plaza (which coincided with **American Legion Post 277's** membership drive), **Elks Lodge 2482** in Severna Park, **Toys R Us** in Glen Burnie and Annapolis, the **Greene Turtle Sports Bar & Grille** in Pasadena and Arundel Mills, **Bayside Physical Therapy** in Millersville, **Three Nines Billiards, Bank Shots, Bass Pro Shop, Cinemark**, and a tree lighting ceremony at **Arundel Mills Mall** and **Maryland Live Casino**, and others are illustrative of the extreme effort put into this year's campaign by all of the members of the team.

A number of volunteers, with boundless Christmas spirit, need to be recognized for their selfless dedication to this year's drive.

**Debbie Mondragon, Don Stockton, Patty & Roland Robidoux, John Bassolino, Holly Beach, Buddy George, George Martin, Woody Bowman, Chuck Albo, Chris Stevens, Scott Stevens, Mike Stevens, Nila Caulder, Dawn Parker**, active duty Marines from Fort Meade and a few others maintained the warehouse and picked up toys from all of the widely-distributed drop-off locations. **Lieutenant Peter Smith** (USMC), the coordinator for Fort Meade, played a significant role in the success of the 2012 Northern Anne Arundel County campaign.

Two outstanding Marines, **Lance Corporals Paul Slaver III and Doug Watson**, are specifically identified for their excellent support. They went above and beyond in their support of Toys for Tots and our efforts to help the local children. They could be counted on to assist with any and all activities...activities which ranged from helping with warehouse operations to appearing at public events as stellar examples of the Marine Corps. Thanks are in order for both Marines for a job well done!

Happily, our Toys for Tots Team's initial expectations for both toys and monetary donations were exceeded. Nearly **19,000 toys/books/stocking stuffers** were collected and over **\$18,000** in

donations had been raised when this year's drive concluded. In the words of **Chris Stevens** – a member of the Toys for Tots Team – *“A lot of hard work was involved in this campaign but the rewards were many. With the lessons learned from this year and anticipated changes, we are expecting another great year.”*

Chris went on to state feelings that are reflective of the entire team by saying *“We know from the smiles on children's faces and from the grateful appreciation of their parents, that the simple gift of a shiny, new toy – something that many take for granted – can make a tremendous difference in the life of a child.”*

# Opposing Opinions

This column attempts to summarize a situation that exists between several detachment members, because of their differing perspectives regarding the suitability of the current by-law *governing the selection of our Detachment Marine of the Year (DMOY)*. This column attempts to provide an unbiased summary of both positions. Your opinion of these conflicting opinions and your subsequent actions *should be based solely upon your own assessment of this issue*. Your interpretation of what you believe this reporter believes should not serve as the basis of your decision(s).

## Opinion 1 – Member, Ray Sturm

**Junior Vice Commandant Ray Sturm** has proposed that the existing detachment by-law governing the selection of the Anne Arundel County **Detachment Marine of the Year** be revised. The major change stipulated by this proposal is that *the actual election of the DMOY be placed in the hands of the general membership*. Other procedural issues are addressed; however, the main thrust of the proposed change is that prior DMOYs would screen and determine the eligibility of nominees provided by the general membership. They would then turn over a ballot of suitable nominees, who have met appropriate eligibility requirements to the general membership, who would then vote for the nominee of their choice by secret ballot.

### Synopsis:

- Election of the DMOY would be determined by a majority vote of all detachment members at the March detachment meeting.
- Election of the DMOY would no longer be performed by Past DMOYs.

## Opinion 2 – Member, Mike Hadley

**2009 DMOY, Mike Hadley** believes that *the selection of the DMOY should remain the sole providence of past Detachment Marines of the Year*. Other procedural issues are addressed; however, the main thrust of proposed change is that *the selection process would remain essentially unchanged and the participation of the general membership would be essentially limited to making nominations*.

### Synopsis:

- Election of the DMOY would be performed by Past DMOYs.
- Involvement of the general membership would be limited to making nominations of detachment members judged to be worthy of the honor.



## Opinion Summary

Both opinions (propositions) are presented in this newsletter (pages 12 and 13) and you are encouraged to examine both in detail prior to participating in the vote to either confirm or reject the proposed by-law change (page 12), which will take place at the January 2013 detachment meeting.

- If you believe that the *membership should elect future DMOYs*, you should vote **FOR** the proposed by-law revision authored by **JVC Ray Sturm**.
- If you believe that the *current process should be maintained*, you should vote **AGAINST** the proposed by-law revision.
- If you believe that the *current process should be maintained – but with revisions as proposed by 2012 DMOY Mike Hadley* – you should vote **AGAINST** the proposed by-law revision and then have someone present a proposal for incorporating those revisions stipulated in Mike Hadley's correspondence into the current by-law to the assembled members of the detachment subsequent to the January 2013 vote on the current proposal.

Again, for those detachment members who may have missed the last two regularly scheduled detachment meetings, the proposed amended by-law is scheduled to be voted on at our January 2013 detachment meeting.



## Young Marines

The **Annapolis Young Marines** have begun their new training year. As part of that training, they will be taking part in the **Frozen Chosen** encampment that is being hosted by the **Hamilton Young Marines** in February. Currently, nine of our Young Marines and two adults have committed to the encampment.

Two **Junior Leadership Classes** are scheduled for the month of March.

Finally, I will be turning command of the Annapolis Young Marines over to active duty Marine **Dallas Cooper** in the near future. Details will be provided as soon as they become firm.

# Detachment By-Law Change – Proposed

*Editor's Note – Please read the proposed amendment to the current by-law governing the Selection of the Detachment Marine of the Year, which is provided below. The amendment, as presented here, contains changes to the originally amended proposal, which was introduced and read at our November detachment meeting –those changes appear as red/underlined text.*

*Since our by-laws state that a vote cannot be held until 30 days have passed, the vote to either accept or reject this amendment will be conducted at our first detachment meeting of the new year on January 28, 2013.*

## SECTION 300 – STANDING COMMITTEES AND DUTIES

### d. Detachment Marine of the Year (DMOY)

#### 1. Committee Composition

- (a) The Detachment Marine of the Year Committee shall be comprised of all past recipients of the Marine of the Year, with a minimum of three members required to meet. In the event at least three members are not available, the Detachment Commandant shall name one or more Past Detachment Commandants to serve on the DMOY Committee. The Chairman of the DMOY Committee shall be the most recent Detachment Marine of the Year. If unavailable, the next most current DMOY shall serve as chairman. Each member must be a member in good standing.

#### 2. Duties

- (a) The DMOY Committee shall
  - aa. Determine all nominees are in good standing.
  - bb. Ensure the nominees are not the subject of a grievance.
  - cc. Review, select, and submit at least two, but not more than three qualified nominees to the Detachment Commandant no later than two calendar weeks prior to the scheduled March detachment meeting.
  - dd. Should the Detachment MOY Committee determine that no nominee is qualified, they may with the concurrence of the Detachment Commandant, make no recommendation.
- (b) The Detachment Commandant shall
  - aa. Prior to the detachment meeting in March, publish the qualified list of nominees and their supporting recommendations.
  - bb. At the March meeting, present the list of qualified nominees for vote by the assembled members of the detachment.
- (c) The Detachment Judge Advocate shall prepare the ballots.
- (d) The Detachment Quartermaster shall obtain the appropriate award plaque and medal. The medal should be available for presentation at the March meeting. The plaque with appropriate inscription may be presented at a later meeting.

#### 3. Nominations

- (a) The DMOY Committee may begin accepting nominations after the January Detachment meeting.
- (b) Nominations may be made by any detachment member in good standing.
- (c) Nominees must be a detachment member in good standing.
- (d) Nominations shall consist of a written recommendation, with a statement of justification as to why this member should be selected as Detachment Marine of the Year.

#### 4. Voting Process

- (a) Members must be present and in good standing to vote. There are no proxy votes or absentee ballots.
- (b) The Detachment Senior Vice Commandant, with assistance of the Judge Advocate, shall conduct a secret written vote. The names of all qualified nominees shall appear alphabetically on a ballot. In the event either officer is a nominee, the Detachment Commandant shall select a replacement officer. This replacement may be an elected or appointed officer.
- (c) A majority vote of all members present shall be necessary to decide the Detachment Marine of the Year. A majority vote is defined as fifty percent plus one vote.
- (d) In the event no nominee receives a majority on the first round of balloting, the top 2 voter earners shall run in a runoff election, with a simple majority (50% +1) being necessary to win.
- (e) The Senior Vice Commandant, with assistance from the Judge Advocate shall tally the votes and present the results of the voting to the Detachment Commandant.
- (f) The Detachment Commandant will announce the Marine of the Year or declare no winner and the need for a second round of voting. If the winner of the DMOY is present, the award may be presented immediately. In the event the winner is not present, an appropriate ceremony shall take place at the next scheduled detachment meeting. The previous recipient of the DMOY shall present the award.

**SUBJECT: Open letter to members, Anne Arundel Detachment 1049, Marine Corps League**

I am writing in response to the proposed amendment to the Detachment By-Laws and Administrative Procedures for the Detachment Marine of the Year (MOY) proposed in the November and December Newsletters.

The Junior Vice Commandant makes the statement in the November newsletter that "I have only been a detachment member for a few years, and I felt that other than submitting a nominee, I had no idea what the process entailed." I would like to address the procedures that he is not aware of. The Detachment MOY committee has followed the traditions and customs of the National, Mid-East Division and Department of Maryland MOY committees. The Detachment MOY Award is the highest honor that can be bestowed upon a regular member of the Detachment. The candidates for this award are nominated by the people who know them best; the Marines of our detachment. The recommendations are screened by a panel of judges made up entirely of past Detachment Marines of the Year. In each case, National, Division, Department and Detachment, the MOY Committee has selected the Marine of the Year. To those that are nominated and do not get selected, they should be proud! They have served well and their fellow Marines felt that you deserved to be reviewed for this honor. That alone is a privilege that very few detachment members have shared.

This being said, I agree that we should have a section in the Detachment By-Laws that address the Detachment MOY procedures. However, I STRONGLY recommend and endorse that SECTION 300.d.4 (Voting Process) be amended to continue the traditions and customs of our detachment and parent organizations. Keep the selection of the Detachment MOY in the Detachment MOY committee. If the proposed change cannot or will not be amended, then it should receive a **NO VOTE!** Additional additions to the proposed change would be the responsibilities of the MOY Committee which include:

- Obtain the Detachment Marine of the Year Medallion and Plaque
- Engraving the Medallion
- Present the Detachment Marine of the Year Award at the Department of Maryland Convention Banquet or at the soonest Detachment Meeting following the Department of Maryland Convention.

In closing, I restate my recommendation that we keep our organizations customs and traditions intact and either **amend SECTION 300.d.4 in the proposed By-Law change, as stated above, or a NO VOTE on this amendment.** Furthermore, if a NO VOTE is achieved, then the Detachment By-Laws committee should entertain an addition to our By-Laws that formalize the Detachment MOY process as stated above. The National and Department By-Laws are both excellent examples of the traditions and customs of this prestige's award.

### 4 January 1991

Marine helicopters evacuate 281 people from U.S. Embassy in Mogadishu, Somalia.

### 7 January 1969

Medal of Honor awarded posthumously to 1st Marine Division Chaplain, **Lt. V.R. Capodanno, U.S. Navy**, who was killed in action in Quang Tin Province, Vietnam on 4 September 1967.

### 8 January 1815

Marines, with Andrew Jackson's help, repulsed British forces at New Orleans.

### 9 January 2002

All seven Marine crewmen were killed when their KC-130R crashed near a forward operating base at Shamsi, Pakistan. Enemy ground fire was not suspected in the crash. These Marines of VMGR-352 were the first to die in the war on terrorism.

### 10 January 1995

2,600 U.S. Marines deployed to Somalia (Operation United Shield) to assist in the final withdrawal of UN peace-keeping troops from Somalia.

### 11 January 2007

President George W. Bush presented the Medal of Honor to **Corporal Jason L. Dunham's** family during a White House ceremony. Corporal Dunham, who died of wounds sustained in combat in April 2004, was not only the first Marine to receive the nation's highest military award for valor for Operation Iraqi Freedom, but also the first Marine to receive the award for any action since 1970.

### 13 January 2003

**General James L. Jones** relinquished duties as the 32nd Commandant of the Marine Corps to **General Michael W. Hagee** during a ceremony at the U.S. Naval Academy. General Jones was the first commandant in 40 years not to retire from the position as he became the first Marine to assume duties as the head of U.S. European Command on 16 January 2003 and Supreme Allied Commander, Europe on the following day.

### 18 January 1951

Marines of the 1st Marine Division begin mop-up operations against guerrillas in the Pohang, South Korea region, following their epic battle with Communist Chinese troops at the Chosin (Changjin) Reservoir.

### 20 January 1968

The second battle for Khe Sanh began when Marines from the 3rd Battalion, 26th Marines attacked a North Vietnamese battalion between Hill 881 South and Hill 881 North.

### 22 January 1969

Operation Dewey Canyon began with the airlift of the 9th Marines and supporting artillery into the A Chau/Da Krong Valleys.

### 25 January 1856

Marines and seamen from the **U.S.S. Decatur** went ashore at the village of Seattle, Washington, to protect settlers from Indian raids.





On Memorial Day 2001, the **National Veterans Art Museum** in Chicago added a stirring and spectacular new exhibit to its already highly praised fine art collection. The work of art is an immense 10 x 40 foot sculpture titled **Above and Beyond**, is comprised of imprinted dog tags – one for each of the more than 58,000 service men and women who died in the Vietnam War.
