APPLICATIONS FOR MEMBERSHIP

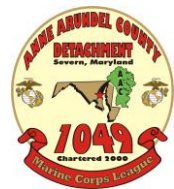
- George Stallings applied for membership... all paper work was in order... dues were paid... a vote was taken and applicant was approved. Member was sworn in.

UNFINISHED BUSINESS

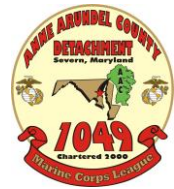
- **Manny Airey** reported that Mission BBQ will be supplying the food again at the MHM Golf Tournament.
