- **Ray Sturm** made a motion to purchase a Marine Corps League Instant Portable Canopy and one red wall with logo from the Marine Corps League store. The cost of the canopy is \$1,020. The canopy is to be used for official MCL functions. The motion was approved via member vote.
- **Ray Sturm** made a motion to award the person selling the winning M1 raffle ticket a \$100 VFW bar tab or \$50 cash. The motion was approved via member vote.
