I apologize for such a late newsletter. Sometimes life gets in the way of things. I'll do my best to be more timely.


As you can imagine, there is a lot to cover in a multi-month edition. I will attempt to keep it relevant.

### Wary of China, American military plans return to Peleliu in Western Pacific

The Pentagon is proposing a new U.S. military site on a Micronesian island where a bloody battle raged during World War II. Department of Defense representatives met Republic of Palau leaders and residents May 13-15 to discuss the proposed facility on the island of Peleliu, according to a May 17 statement from Joint Region Marianas.

Engineers from the Navy, Air Force and Marine Corps shared details of the proposal with the Palauans, including plans to repair and expand the Peleliu Airstrip and South Dock, the statement said.

Efforts by Beijing to gain influence in the region, including a pact with the Solomon Islands that's seen as a precursor to forward basing by the Chinese navy, has the attention of U.S. officials. President Joe Biden signed legislation March 9 that provides \$7.1 billion over two decades and renews compacts with Micronesia, the Marshall Islands and Palau.

The compacts grant the U.S. military exclusive access to the nations' land, airspace and waters, while their citizens are allowed to work and attend school in America, enlist in the U.S. armed services and access veterans' health care.

Palau was the scene of fierce battles during World War II. About 1,800 Marines and soldiers were killed in the three-month Battle of Peleliu in fall 1944. Another 8,000 were wounded.

The U.S. Army began training again in Palau in 2019, after a 37-year hiatus. The following year, a Patriot missile battery deployed there and shot down a target drone during an exercise. In October 2020, then-Palau President Tommy Remengesau Jr. offered to host new military facilities, including ports and air bases.

"Palau's request to the U.S. military remains simple — build joint-use facilities, then come and use them regularly," Remengesau wrote to then-Secretary of Defense Mark Esper, according to a Wall Street Journal report the following month. The Pentagon in December 2022 awarded a \$118 million contract to Gilbane Building Co., a Rhode Island firm, to build reinforced concrete pads and foundations for mobile, over-the-horizon radar in Palau by June 2026.

The site is meant to promote the quality of life for the people in Palau and to enhance the military's capabilities throughout the region to include humanitarian assistance, disaster relief efforts, and power projection, he said.

The project is about partnership, Peleliu State Gov. Emais Roberts said in the statement. "The Republic of Palau and State of Peleliu asked the U.S. government, asked the Department of Defense to help fix the airfield for our benefit, and also for the benefit of the military if they had the use for it," he said.

### Air Force raises maximum amount for retention bonuses to \$180,000

The Air Force is hoping that even greater financial incentives can help it retain personnel.

This fall the U.S. Air Force is raising the maximum payout available for airmen in certain fields. This past week the service announced it was increasing the amount of money service members in certain specialized careers can get in reenlistment bonuses, up to \$180,000 from a previous high of \$100,000.

The new bonuses, which go into effect on Oct. 1, are meant to help the Air Force keep "critical career fields" staffed, with the focus being on areas with low retention rates, the service said. The new rules set a higher career cap for bonuses at \$360,000.

### **VA Adds Option for Commemorative Plaque or Urn**

### May 19, 2024 National Cemetery Administration

Beginning on June 10, 2024, the families of certain cremated veterans may apply to receive a commemorative plaque or urn from VA. Family members are eligible to apply only if they have chosen not to inter a loved one in a VA National Cemetery or receive a government-furnished headstone, marker, or medallion for placement in any cemetery.

Commemorative urns (seen at right) are used to hold the remains of a deceased, cremated Veteran, and commemorative plaques (below, right) are designed to hang on a wall. Both the urns and the plaques honor a Veteran's service and serves as a lasting tribute to the individual's status as a Veteran. Eligible family members can request one or the other, but not both.

It's important to note that, if a family chooses a plaque or an urn to commemorate a Veteran, VA is prohibited by law from interring that Veteran's remains in a VA national cemetery or from providing a headstone, marker or medallion for placement in any cemetery. Families should be certain of their choice. If the family chooses to receive a plaque or an urn to commemorate their Veteran, their decision cannot be undone. The law does not provide a method to restore these benefits.

To be eligible, the Veteran (or service member who died on active duty) must have served in the Armed Forces on or after April 6, 1917; the Veteran must be eligible for a headstone or marker under 38 U.S.C. § 2306(d), and the Veteran's remains must have been cremated—with no portion of the remains interred at any location.

More information about NCA memorial options can be found on the VA website. More details, including an application for commemorative plaques and urns, will be available on June 10. Information about VA burial and memorial benefits is available online, at VA national cemeteries, or by calling toll-free at 1-800-827-1000. To make burial arrangements at any VA national cemetery at the time of need, call the National Cemetery Scheduling Office at 1-800-535-1117. VA also encourages Veterans to apply for Pre-Need Eligibility to establish eligibility for VA burial and memorial benefits in advance of need.



### ~ Our History ~ Customs ~ and Traditions ~

### 5 May 1983

In Beirut, Lebanon, a UH-1N helicopter carrying the commander of the American peace- keeping force, **Colonel James Mead**, was hit by machine gun fire. The six Marines aboard escaped injury. Colonel Mead and his crew had taken off in the helicopter to investigate artillery and rocket duels between rival Syrian-backed Druze Moslem militiamen and Christian Phalangists that endangered French members of the multinational force. [Side note: a fellow MCL member **Frank DiGregorio**, and personal friend of the editor, was one of the six Marines aboard the helicopter. When recently asked about the incident he stated, "They said to me, 'Lieutenant, you're an AO (Aerial Observer). Go up there with Col Mead and shoot the bastards."

### 22 May 1912

**First Lieutenant Alfred A. Cunningham,** the first Marine officer to be assigned to "duty in connection with aviation" by Major General Commandant William P. Biddle, reported for aviation training at the Naval Aviation Camp at Annapolis, Maryland, and Marine aviation had its official beginning.

### 25 June 1950

Shortly before dawn, eight divisions of the North Korean People's Army crossed the 38th Parallel and invaded the Republic of Korea. Within three days, the South Korean capital city of Seoul had been captured. On 30 June, President Harry S. Truman ordered a naval blockade of the Korean coast and authorized the sending of U.S. ground troops to Korea. Two days later, General Douglas MacArthur, the Commander in Chief Far East, formally requested that a Marine regimental combat team be deployed to the Far East.

### 26 June 1918

BGen James G. Harbord, the Commanding General of the 4th Marine Brigade, notified American Expeditionary Force Headquarters that **Belleau Wood** was "now U.S. Marine Corps entirely." After 20 days of combat, and at a cost of over 4,000 casualties, the 4th Brigade of Marines had proven its fighting heart. The grateful Commander of the French Sixth Army would soon decree that in all official correspondence, Belleau Wood would henceforth bear the name, "Bois de la Brigade de Marine."
