**General Liability Release and Assumption of the Risk**

**acknowledge that I have voluntarily applied to participate in activities located at 2797 East Pleasant Valley Rd, Oxnard, CA 93033, the home of Patti Rosemund DBA "Rocking R Ranch."**

**I UNDERSTAND HORSES ARE UNPREDICTABLE AND POTENTIALLY DANGEROUS. ALL PERSONS WHO WISH TO PARTICIPATE IN HORSE-RELATED ACTIVITIES AT ROCKING R RANCH MUST ASSUME ALL RISK OF INJURY OR DEATH FOR MYSELF, MY CHILDREN. I UNDERSTAND THE RISKS I AM TAKING BY BEING IN THE SAME AREA OF HORSES, EVEN IF MY CHILD OR MYSELF MAY NOT BE HANDLING THEM.**

In consideration of the participation by me and/or my family in the equestrian activities of Rocking R Ranch and in order to obtain Rocking R Ranch permission to participate in such activities, and to occupy Rocking R Ranch premises, I hereby assume all risk of injury or death to myself and/or my children during or as a result of our participation in such activities and occupancy of Rocking R Ranch premises. I further assume all legal responsibility for any and all **damages** to or loss of our personal property, including our horses, which may occur during or as a result thereof; and I will bear any and all medical, dental, emergency transportation, and similar expenses and fees that we may incur thereof; and I waive any and all liability of Rocking R Ranch for any and all foregoing risks, responsibilities, and damages whether caused by personal negligence or otherwise.

I, \_\_\_\_\_ understand that activities at the Rocking R Ranch facility are equestrian activities, as such I understand that horses are large, unpredictable creatures with minds and wills of their own. I understand that it is impossible for any human being to exercise total control over any horse to prevent the animal from injuring itself or others. I understand that Rocking R Ranch is physically incapable of exercising complete control over its equestrian center activities to prevent injury or death to any participant, including myself and/or my children and/or my horses. I understand that the activities at Rocking R Ranch facility are inherently hazardous because of the foregoing, and that our participation in horse activities subjects us to an ever-present risk of injury or death.

This release shall remain in effect for any and all further activities at Rocking R Ranch, whenever we may occupy Rocking R Ranch premises, or unless Rocking R Ranch received written notice that I revoke our agreement to these conditions.

I ASSUME ALL RISKS RELATED TO MY PARTICIPATION IN ANY AND ALL ACTIVITIES AT ROCKING R RANCH. I VOLUNTARILY, EVIDENCING MY ACCEPTANCE OF THE ABOVE PROVISIONS BY EXECUTING THIS RELEASE ON BEHALF OF MYSELF AND AS PARENT and/or LEGAL GUARDIAN OF THE CHILDREN**
