April 25, 26, 27, 2025 (Friday, Saturday, & Sunday morning)

Our Court can take (3) delegates and (6) alternates.

As per **CDA Bylaws**, Article X State Conventions, Sec. 5 Local and Campus Court Delegates, 1.c.: If she attends, the highest-ranking officer (in office at the time of the convention) shall automatically be one of the court's delegates. (Bylaws, p. 29)

As your Regent, I plan to attend the State Convention. Sue May and Mary Jo Evers will also be attending and Elaine Boes is currently a "maybe." I hope you will consider joining us. Please let me or another officer know before February 10th if you would like to attend. We will do an online vote before the 15th, so our names can be submitted to State CDA. Due to our Court size, we can have 3 delegates and up to 6 alternates. It would be wonderful to have great representation from our court at the State Convention.

You will find the registration form on p. 21 of the **Winter 2024** issue of **The Voice**. I will also have paper copies of the form at the meeting so you don't have to cut up your publication.

A registration form for each attendee must be completed and are due by March 31, 2025. Registration fees include lunch and dinner. Breakfast for Stoney Creek Hotel guests is complimentary.

Registration fees should be paid by the member attending. The Court will reimburse fees after the event. A vote will also be taken at the May 2025 member meeting on any other expenses to be covered by the Court.

Our Court will be working with several other groups at St. Wenceslaus and Immaculate Conception parishes for this year's soup supper. The focus this year is on spiritual healing for the two parishes and the groups involved.

The event was formerly known as the **Seminarian Soup Supper** as only seminarians from the two parishes benefited.
This year and going forward, the event will be a **Soup Supper Fundraiser** for both seminarians and religious.

Based on past year's numbers, we are preparing for 150-200 people, but there could be more. At our planning meeting on Tuesday, January 28th, it was determined that we would need the following donations:

10-12 crockpots of soup, chili, macaroni & cheese (but more are always welcome)

Bread, Butter, Crackers

(6) each: Vegetable trays/Fruit trays

Desserts (unlimited—variety is great)

We also need volunteer help with set-up, working in the kitchen, carrying trays/clearing tables, and clean-up.







Dues are \$28 per year, payable by February 1.

Medallions Are Coming!!!

As of January 1, 2025, CDA has retired our ceremonial robes. The decision was made to go with medallions for the officers on each level of our order. Also, at any event where officers would have worn robes in the past, officers on all levels will now wear a white top with black slacks or skirt along with the medallion of their office.

Above is the finalized design for the center of each of the medal medallions.

- National Officers & Directors: Gold medallion w/gold ribbon
- State Officers: Silver medallion w/purple ribbon
- Local/Territorial: Bronze medallion w/blue ribbon
- District Deputies: Bronze medallion w/a black/red ribbon
- Flag and Banner bearers will have no change. They will continue the same as previously.
- The rule of nothing to be worn on the head remains, as does the rule of not carrying anything in procession such as purses/handbags, cameras, etc.

The company CDA is working with is working to get all medallions finished in time for 2025 State Conventions.
