London Craft Shows, a division of OPT Holdings Ltd., is pleased to announce the 44th London Christmas Craft Festival. The show, now in its 44th year, has become a tradition and Londoners look forward to the quality workmanship found at the show and do a lot of their Christmas shopping here.

In order to ensure that the show retains its quality reputation, **ALL applicants whose work we have not seen**, must enclose photos or slides. All work for the show must be handcrafted by the persons selling and displaying at the show. Quality of work will be the prime factor in the acceptance of applications. Sales kits or kit work will not be permitted. The Christmas Craft Festival is London's largest indoor craft show with a total of over 200 booths.

Craftspeople will be responsible for the safety of their goods and money for the duration of the show. London Craft Shows, a division of OPT Holdings Ltd., agrees to provide reasonable protection during the show, but assumes no legal responsibility to the Dealer for any loss or damage due to fire, theft, vandalism, explosion, riot or otherwise. Accepted applicants cannot sublet their booth space to other individuals or share without permission.

Details: Booth sizes are 10 x 10ft and 10 x 15ft. All booths are curtained. Corner booths cost extra. Power is available at a cost of \$95 (+HST). Tables are available at a cost of \$35 each (+HST) Chairs not included. Craftspeople are asked to put thought into the set up of their booth and displays. All tables **MUST** be covered and draped. Each display is to be neat, uncluttered and professional looking no hand written signage. Each booth must have the name of the craftsperson visible to the buying public at all times.

Publicity: An active campaign using radio, newspaper, social media, direct mailings and Billboards will be used both prior to and during the show. Posters will be mailed to all craftspeople in the show and we ask that all of you do your share of exhibiting and distributing them in and around the areas in which you live and work and at other shows in which you will be participating.

Deposits must be made by e-transfer to info@optholdings.ca OR by credit card payment. **Deposit must be done on the same date as the contract is submitted.** **Deposits will only be processed if the craftsperson is accepted into the show.** **Deposits can be made via E-Transfer, Mastercard or Visa.**

London Craft Show, a division of OPT Holdings Ltd., agrees to provide booth space, tables / hydro as outlined below & also provide reasonable protection during the show, but assumes no legal responsibility to the Dealer for any loss or damage due to fire, theft, vandalism, explosion, riot or otherwise. The Dealer agrees to exhibit only crafts made by him/herself and to have the exhibit completed and ready for the show by the specified date and time, and further agrees that there will be no packing up of exhibits until closing time of the final day of the show and sale. Upon acceptance of the applicant for the show, **no refunds will be made for any cancellation, regardless of reason.** Accepted applicants are not allowed to sublet their booth space to other individuals. The dealer agrees to allow the promoter the use of photographs and/or the use of his/her name or logo in advertising.
