SUPPLY AND DELIVERY OF AQUA-FEEDS SAN ILDEFONSO, ILOCOS SUR

The Municipality of San Ildefonso, Ilocos Sur, through GF (ANNUAL BUDGET & SUPPLEMENTAL BUDGET 2024-01) intends to apply the sum ONE HUNDRED SEVENTY EIGHT THOUSAND EIGHT HUNDRED PESOS ONLY (P 178,800.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the SUPPLY AND DELIVERY OF AQUAFEEDS SAN ILDEFONSO, ILOCOS SUR;

1. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Municipality of San Ildefonso, Ilocos Sur now invites bids for the SUPPLY AND DELIVERY OF AQUA-FEEDS SAN ILDEFONSO, ILOCOS SUR 1 1. Completion of the Works is required 45 CD. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

 Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

Bid opening shall be on November 15, 2024 at 2:30 PM at Municipal Hall, San Ildefonso, Ilocos Sur. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
