

**PROVISION OF FARM ACHINERIES, EQUIPMENT AND FARM MATERIALS
SAN ILDEFONSO, ILOCOS SUR**

The Municipality of San Ildefonso, Ilocos Sur, through RA 7171 intends to apply the sum **ONE MILLION FIVE HUNDRED TWENTY TWO THOUSAND FIVE HUNDRED PESOS ONLY (P 1,522,500.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **PROVISION OF FARM ACHINERIES, EQUIPMENT AND FARM MATERIALS SAN ILDEFONSO, ILOCOS SUR;**

1. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2.. The Municipality of San Ildefonso, Ilocos Sur now invites bids for the the **PROVISION OF FARM ACHINERIES, EQUIPMENT AND FARM MATERIALS SAN ILDEFONSO, ILOCOS SUR** ¹]. Completion of the Works is required **45 CD**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Municipality of San Ildefonso, Ilocos Sur and inspect the Bidding Documents at the address given below during 8:00Am to 5PM.

5. A complete set of Bidding Documents may be acquired by interested Bidders on **February 06 2025 to March 03, 2025** and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Five Thousand Pesos Only (P 5,000.00)**.

7. Bids must be duly received by the BAC Secretariat at the address below on or before **March 03, 2025, at 3:30 PM at Municipal Hall, San Ildefonso, Ilocos Sur**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **March 03, 2025 at 3:30 PM at Municipal Hall, San Ildefonso, Ilocos Sur**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
