**SUPPLY AND DELIVERY OF MEDICINES FOR DEWORMING, HIV/STI AND OTHER MEDICAL SUPPLIES
SAN ILDEFONSO, ILOCOS SUR**

The Municipality of San Ildefonso, Ilocos Sur, through **GENERAL FUND (ANNUAL AND SUPPLEMENTAL BUDGET)** intends to apply the sum **ONE HUNDRED FIFTY TWO THOUSAND SIX HUNDRED FIVE PESOS ONLY (P 152,605.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **SUPPLY AND DELIVERY OF MEDICINES FOR DEWORMING, HIV/STI AND OTHER MEDICAL SUPPLIES SAN ILDEFONSO, ILOCOS SUR;**

1. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Municipality of San Ildefonso, Ilocos Sur now invites bids for the **SUPPLY AND DELIVERY OF MEDICINES FOR DEWORMING, HIV/STI AND OTHER MEDICAL SUPPLIES SAN ILDEFONSO, ILOCOS SUR**. Completion of the Works is required **30 CD**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Municipality of San Ildefonso, Ilocos Sur and inspect the Bidding Documents at the address given below during 8:00Am to 5PM.

5. A complete set of Bidding Documents may be acquired by interested Bidders on **November 21, 2024 to November 29, 2024** and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Five Hundred Pesos only (P 500.00)**.

Bid opening shall be on **November 29, 2024 at 4:00 PM at Municipal Hall, San Ildefonso, Ilocos Sur**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
