The Municipality of San Ildefonso, Ilocos Sur, through GENERAL FUND (ANNUAL AND SUPPLEMENTAL BUDGET) intends to apply the sum ONE HUNDRED FIFTY TWO THOUSAND SIX HUNDRED FIVE PESOS ONLY (P 152,605.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the SUPPLY AND DELIVERY OF MEDICINES FOR DEWORMING, HIV/STI AND OTHER MEDICAL SUPPLIES SAN ILDEFONSO, ILOCOS SUR;

Completion of the Works is required 30 CD. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

 Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
