**CONSTRUCTION OF FLOOD CONTROL AT GONGOGONG

The Municipality of San Ildefonso, Ilocos Sur, through RA 7171 intends to apply the sum **ONE MILLION ONE HUNDRED FIFTY TWO THOUSAND TWO HUNDRED FORTY TWO PESOS & 64/100 ONLY (P 1,152,242.64)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **CONSTRUCTION OF FLOOD CONTROL AT GONGOGONG SAN ILDEFONSO, ILOCOS SUR;**

1. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2.. The Municipality of San Ildefonso, Ilocos Sur now invites bids for the **CONSTRUCTION OF FLOOD CONTROL AT GONGOGONG SAN ILDEFONSO, ILOCOS SUR;** Completion of the Works is required **75 CD**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Municipality of San Ildefonso, Ilocos Sur and inspect the Bidding Documents at the address given below during 8:00Am to 5PM.

5. A complete set of Bidding Documents may be acquired by interested Bidders on **May 06, 2025 to May 26, 2025** and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Five Thousand Pesos Only (P 5,000.00)**.
