## (EARLY PROCUREMENT ACTIVITY)

The Municipality of San Ildefonso, Ilocos Sur, through RA 7171 intends to apply the sum TWO MILLION SEVEN HUNDRED NINETY NINE THOUSAND FIVE HUNDRED SEVENTEEN PESOS & 88/100 ONLY (P 2,799,517.88) being the Approved Budget for the Contract (ABC) to payments under the contract for the CONCRETING OF FARM TO MARKET ROAD AT KINAMANTIRISAN SAN ILDEFONSO, ILOCOS SUR;

1. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Municipality of San Ildefonso, Ilocos Sur now invites bids for the CONCRETING AND REHABILITATION OF FARM TO MARKET ROAD AT KINAMANTIRISAN SAN ILDEFONSO, ILOCOS SUR 1 J. Completion of the Works is required 41CD. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

 Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
