

### WSOTC Website Member's Only Access

Need help getting access to the Member's Only section of the WSOTC website? First, make sure you subscribe to the website by <u>following this link</u> and entering your email address. Shea will receive a notification when you sign up and send you a link to create your username and password (this may take some time). You will have your own username and password moving forward. The shared wsotc\_members login no longer works.

If you already have an account set up, follow these steps to sign into it and access the member's only materials:

- 1. Click on the user account icon in the top right of the screen, then click Sign In.
- 2. Enter your username and password and click sign in (if you forgot your password use the Reset Password option to get an email with a link to reset it).
- 3. Click on the More drop down menu at the top right of the page and then click on the Member's Only page option.
- 4. You will now see the list of member's only files.


