

It's time for the WSOTC end-of-the-year wrap up!

As usual it was a busy year! Fun match in January, tracking tests (TD/TDX) in February, obedience and rally trials in March, scent work trials in June, agility trials in July, obedience and rally trials in August AND a tracking test (TDU) in November. Whew!

I didn't get to all these events (no agility trials for me!) but enjoyed seeing our club members in the ring/field/search areas competing as well as working to make these events a success for the dog sports community in the Northwest. As you know these events need club members to volunteer to make things happen! Even if you are competing on the day there are still ways to help, just find and ask the chairperson.

- Obedience and rally trials, matches, and ring practice events need people to come early and stay after setting up and taking down the rings. Stewards are needed to help the judges and to keep each ring running smoothly.
- Tracking tests can always use an extra hand or two as drivers or with putting in cross tracks and carrying flags.
- Scent work trials need stewards to help direct exhibitors to the search areas and timekeepers to help the judges.
- Agility needs help with setting up, stewarding, leash running and pole setting.

For most of these jobs no previous experience is necessary, and you get a free lunch!

SO... If you haven't been a part of putting on an event you should definitely do so in 2026. Choose an event that you have experience with or are eager to learn more about. Information about each event and whom to contact is posted in the Canine Post which is emailed to all members as well as being posted on the club website (wsotc.org) each month.

It's Time to Renew Your Membership!

Thank you to all our wonderful WSOTC members for your participation with the club this year! WSOTC membership renewal for 2026 is now available online through Cheddar Up or through a paper form ([see page 17](#)). All membership renewals are due by January 1, 2026.

Remember that you are welcome to switch between associate and full membership. If you are renewing with a full membership, the attendance for meetings in 2025 is available on the website.

Annual Awards

WSOTC members actively participating with the club have an opportunity to earn a name plaque and title bars for AKC performance event titles you earn with your dog(s) during the calendar year! In addition, teams earning specific Obedience and Rally titles are eligible to be added to the club perpetual plaques, and obedience title earners in Novice, Open, and Utility can submit their scores for the Top Dog award.

To earn an Annual Award, club members must submit the Awards Application ([see page 19](#)) and meet the criteria listed below. Awards are celebrated annually at the February or March general membership meeting.

Annual awards rules:

1. Any or all titles must be received while a member of WSOTC.

Annual Awards continued

2. Dogs must be owned or co-owned and handled by the WSOTC member.
3. For individual plaque awards, the member must have acquired 4 points by attending membership meetings, assisting at trials/events, service to the club, the year the titles were earned. No points are required for inclusion on the Perpetual plaques or for Top Dog award.
4. One plaque per dog will be awarded with the first AKC title earned in Agility, Obedience, Rally, Scentwork, or Tracking. Title plates only will be awarded for subsequent titles
5. Completed plaque applications must be submitted to the Club Award Chair by **January 19, 2026.**
6. Dogs earning titles for UD, UDX, OTCH, MX, MXJ MXP, MJP, MACH, PACH, ADCH, CT, TDX, VST, RAE RACH will be inscribed on the WSOTC Perpetual Plaques with no charges.
7. Plaques (\$20.00) and plates (\$8.00) will be available at cost for members not meeting the point requirements, or for non-AKC titles, or for AKC titles not listed above (field, conformation, herding, etc.).

Note: The number of titles that can fit on one plate will be at the discretion of the engraver.

If you earned a title this year, make sure to submit the Awards Application to Nancy Light by January 19 so you can receive your award!

1. The meeting was called to order at 7:01 by President Melissa Knapp. Attendees: Melissa Knapp, Nancy Light, Catherine Shaffer, Rhonda Forman and Neil Evans
2. The minutes from the 10/8/25 meeting were approved.
3. **Report of the President:** No report.
4. **Report of the Secretary:** Rhonda reported that AKC has communicated that they have received the application and judges panel for the spring obedience and rally trials.
5. **Report of the Treasurer:** Catherine presented an updated report which will be posted on the "members only" section of the website. Membership renewals are coming in.
