## By-Laws

## Article I

## Section 1. NAME

The name of the organization shall be Star City Corvettes.

## Section 2. PURPOSE

The general purpose of the organization shall be to promote and plan events, trips, and activities for its members; to encourage the exchange of information as to the operation, maintenance, restoration and use of the Corvette; to encourage careful and skillful driving on public highways and the strict observance of the motor vehicle code of the community and state.

## Article II

## Members

## Section 1. QUALIFICATIONS

Members shall be limited to owners or operators of Chevrolet Corvette motor sports vehicles.
Applicants must be eighteen years of age or older and hold a valid vehicle operator's license.

## Section 2: CLASSIFICATIONS

Members shall be limited to only one NCCC number (with the exception of Honorary members) and be classified as follows:
A. Primary Members. Upon receipt by the Club and VP of Membership and with approval of the application, payment of the required initiation fees and dues the applicant shall become a Primary member. Every member must comply with the requirements set forth in Section 1 to be eligible to continue as a Primary member of this organization.
B. Spouse / Companion Members. The spouse or companion of any Primary member and whose mailing address is the same as the Primary, may apply for membership. Upon receipt by the Club, VP of Membership and with approval of the application, payment of the required dues, the applicant shall become a Spouse / Companion member. Such member shall be entitled to all
privileges of Primary membership. A Primary member may only have one spouse / companion member at a time.
C. Honorary Members. Membership at any duly organized meeting, may elect Honorary members by unanimous vote of the members present. Honorary members shall be exempt from payment of dues and shall be entitled to all the privileges of Primary members, except the right to vote or hold office. Honorary members need not comply with the requirements of membership set forth in Section 1 of this article

## Section 3: OFFICIAL MEMBERSHIP

The Vice President of Membership or a member of the membership committee shall present the application to the organization at its next regularly scheduled meeting. The application must receive approval by $75 \%$ of all members present. The ballots will be counted by the Vice President of Membership or committee member and they shall be notified of the results by email or by mail. Membership shall be contingent on joining NCCC; payment of NCCC and SCC dues and initiation fees. (Spouse/Companion membership may be SCC only)

## Section 4. DUES

The amount required for annual dues shall be recommended by the board and approved by the majority of members in attendance at the business meeting. Any increase in the NCCC dues will be added automatically to the amount due for NCCC membership. All dues are payable before October $31^{\text {st }}$.

New member dues are payable after being accepted as a SCC member. New member dues will be 1/12 of annual SCC dues for each of the remaining months in the due's year. The induction fee for a new member will reflect the dues owed, name badge and any other costs of enrollment. (Rev April 2019)

## Section 5. EXPULSION

Membership will lapse for non-payment of dues by the specified due date. (See Section 2. Dues) Infraction of organization rules or other such causes as determined by the majority of the Board of Directors will be cause for expulsion. However, before such action is taken, the member shall have a chance to remedy said cause for expulsion. (Rev. 87)

## Section 6. RESIGNATION

A letter of resignation shall be effective upon receipt by the Secretary.

## Article III

## Section 1. MEETINGS

Meetings of the organization shall be held twice each month. Either the first and third week or the second and fourth week, as established by a vote of the organization members. The Board of Directors shall meet as deemed necessary.

## Section 2. SPECIAL MEETINGS

In addition to any provision of the By-Laws, special meetings may be called by the President or by a majority of the officers.

## Section 3. QUORUM

At all stated meetings of the members, those members present shall constitute a quorum. (Rev. 21)

## Article IV

## Section 1. BOARD OF DIRECTORS

The Board of Directors shall consist of all elected officers and the recent past President and the Webmaster who will be appointed by the Board of Directors. (Rev 2020) The tax-exempt status will be an automatic agenda item for meetings of the Board of Directors. (Rev 2017)

## Section 2. NOMINATIONS OF OFFICERS

A nominee must be a member who has been a member in good standing for at least six (6) months. All nominations for officers shall be made from the floor or from the nomination committee. Officers shall be nominated at the first meeting in October of each year. (Rev. 87)

The ballot shall be sent to the members before the November business meeting. Nominations from the floor will be accepted prior to the vote.

## Section 3. ELECTION OF OFFICERS

Election of officers shall be held at the first meeting of November of each year. Election of officers will be composed of a majority vote of members present at the meeting. Officers' terms shall commence on the first day of January. (Rev. 87)

## Section 4. VOTING

Voting for election of officers shall be by written ballot or by voice vote if running unopposed. (Rev 90)

## Article V

## Section 1. DUTIES OF THE PRESIDENT

The president shall preside at all meetings of the members and the Board of Directors and shall perform duties pertaining to this office. The president shall verify that all necessary tax forms are filed with state and federal government as prescribed by law. (Rev 2017) The president may call special meetings under the provisions of Article III. The President shall be Chief Executive of the organization.

## Section 2. DUTIES OF THE VICE PRESIDENT OF MEMBERSHIP

The Vice President of Membership shall greet and provide a membership application and related materials to prospective members. The Vice President of Membership shall keep and maintain an up-todate list of current members and shall notify the Vice President of Competition of each new member. The Vice President of membership will send out due's notices to all members by September 15.

Dues will be sent to the Treasurer for deposit. Member's names will be given to the Vice President of Membership to record as paid.

In the absence of the president, resignation, or ability to act, the duties of that office shall be performed by the Vice President of Membership.

## Section 3. DUTIES OF THE VICE PRESIDENT OF COMPETITION

The Vice President of Competition shall maintain competition and participation point standings for all organization members and shall take attendance (by name) at each meeting. A competition point system shall be established by the V.P. Competition and presented by the first meeting of January, then approved by a majority vote of those members present at the last meeting in January. In the absence of the President and the Vice President of Membership, the Vice President of competition shall perform the duties of the office of President.

## Section 4. DUTIES OF THE SECRETARY

The secretary shall attend all meetings and shall record all minutes and votes in a book kept for that purpose. The secretary shall have custody of all minutes of previous meetings. In the absence of the Secretary from any said meeting, a Secretary Pro-tempore shall be chosen by the presiding officer.

## Section 5. DUTIES OF THE TREASURER

The Treasurer shall have custody of all monies, debts, and obligations belonging to the organization. He shall make all payments of debts belonging to the organization. The treasurer will file all necessary tax forms when due to the state and federal government as prescribed by law. The president and Board of Directors will be notified when these forms have been sent to the state and federal governments. (Rev 2017) He shall give bond, at the expense of the organization, if required by the Board of Directors. No debt shall be paid by the Treasurer without specific approval of the President or Board of Directors. The Treasurer shall itemize expenses and receipts and report the status of the treasury at each regularly scheduled meeting. (Rev.90)

## Section 6. DUTIES OF THE GOVERNOR

The Governor of the organization shall handle such duties as are prescribed by the National Council of Corvette Clubs.

## Section 7. DUTIES OF THE SOCIAL DIRECTOR

The Social Director shall solicit hosts for the monthly social events in January. The host shall provide details of the event to the Social Director. The Director will communicate the arrangements of the social events to the membership.

## Section 8. DUTIES SERGEANT OF ARMS

The Sergeant at Arms shall assist in preserving order at all meetings and social affairs or the organization. He shall perform such other functions as the President and Board of Directors may direct from time to time.

## Section 9. DUTIES OF PUBLIC RELATIONS

The Director of Public Relations shall be responsible for promoting, furthering the image, and disseminating information relative to the organization as the President and Board of Directors may direct from time to time.

## Section 10. DUTIES OF THE WEBMASTER

The Webmaster is responsible for the club's online presence. The website should promote Star City Corvettes by providing information to club members and the public. Some items on the club's website may include:

- Calendar of events
- Contact information
- Photo albums
- Club officer information
- Club activities and announcements
- Information about Club
- Constitution, By-Laws, History and Guidelines and other forms as determined by board of directors.


## Section 11. DUTIES OF THE PAST PRESIDENT

The Past President shall serve on the Board of Directors in an advisory position and shall perform other duties as designated by the President and/or Board of Directors. The Past President shall not be allowed to vote at any Board of Directors meeting.

## Article VI

## Section 1. ACTIVITIES

The organization activities shall be subject to approval of the Board of Directors and/or the membership.

## Article VII

## Section 1. PERSONAL LIABILITY

All persons or corporations extending credit to, contracting with, or having any claim against the organization or the Board of Directors, shall look only to the funds and property of the organization for payment of such contract or claim, or for payment of any debt, damage, judgment, or decree, or any other money that may otherwise become due and payable to them from the organization or the Board of Directors, so neither the members of the organization, or the Board of Directors, present or future shall be liable personally thereof.

## Article IV

## Section 1. BOARD OF DIRECTORS

The Board of Directors shall consist of all elected officers, the webmaster (Rev March 2020) and the recent past President. The tax-exempt status will be an automatic agenda item for meetings of the Board of Directors. (Rev 2017)

## Section 1. AMENDMENTS TO THE BY-LAWS

The Board of Directors of the organization, or any (10) ten active members in good standing, by written proposals submitted to the Secretary, may propose an amendment to the By-Laws. Upon such proposal being made, members not present at the reading of such proposal shall be notified of the proposed By Law amendments. Ballot voting shall be controlled by the same rules as set forth in ARTICLE IV, relating to the election of the Board of Directors. If two-thirds of the members vote in favor of the proposal at the meeting, the proposed amendment shall thereby be approved and adopted.

## Article IX

## Section 1. DISSOLUTION, PROPERTY

If for any reason, this corporation is disbanded, or dissolved, any property held in corporate name, shall be liquidated and turned into cash in accordance with the decisions made by the then active members. After all corporation liabilities have been paid, the remaining cash shall be donated to a non-profit charitable organization chosen by the then active members of the organization.

## Section 2. DISSOLUTION

Dissolution of the corporation shall be in accordance with all applicable Federal and State of Indiana Laws.

## STAR CITY OF THE WEST

## Lafayette, IN

The origin of the name "Star City" as applied to the city of Lafayette is more of a legend than documented fact. As of this time, history cannot identify a person or persons responsible for coining the term.

It is known that in 1826, about a year after William Digby founded this town, a small steamboat came up-river and docked at a wharf at the foot of Main Street. This started an era of riverboat traffic that would cause the city to prosper. Lafayette became the principal trade city on the Wabash River. The Wabash and Erie Canal also terminated close to Lafayette. In that era, river towns were inclined to brag about themselves. On the Ohio River, Cincinnati was the undisputed "Queen City of the West". Lafayette was the upper most city on the shipping lanes of the Wabash. Indiana at that time was the west. Cincinnati boats were often docked at the Lafayette wharf and Lafayette boats were often docked at the Cincinnati wharf. As the bragging started, Lafayette was not to be outdone by Cincinnati, so they spread the word that Lafayette was indeed the "Star city of the West." The name "Star City" became a common name for Lafayette. The riverboat era ended sometime in the 1850s, but the Star city name stayed.

In time the name was used by some businesses. A well-known firm was the Star City Bottling Works. The M.J. Schnaible Company also used the name for its chief product, "Star City Soap". The last business using the name was the Star City Building and Loan Association. They closed in the early 1970s.

The name "Star City" was started by a group of people involved in transportation. The steam boats were the best of that era. We feel that the Star City name has a definite place in our organization. Lafayette is a great city, and the Chevrolet Corvette is definitely the best in exciting transportation today.

If we combine the City and the Corvette, we have the BEST!
