Dear Judge Rivera:

I write to advise the Court of a relevant change in status in this Article 78 proceeding regarding a FOIL request for pricing information in a renewable energy contract.

This morning the undersigned disclosed to Petitioner's counsel the pricing information that forms the basis of this entire proceeding. The undersigned asked Petitioner's counsel, who is now in possession of the information Petitioner seeks, to voluntarily discontinue this proceeding, and again offered to commit to writing a promise to release amended pricing, but Petitioner's counsel has not responded. Nor has Petitioner's counsel responded to messages left the previous Friday afternoon advising him that the information was forthcoming.

Petitioner has previously rejected good-faith efforts by Respondent to resolve this matter without the need for further litigation. As set forth in Respondent's Memorandum of Law in Response to the Petition (Dkt. No. 14) and the Affirmation of Helena Lynch (Dkt. No. 16), Respondent notified Petitioner's

counsel on several occasions that the contract pricing at issue in this proceeding would soon be released. *See* Dkt. No. 14 at 9-10 (ECF pages 13-14); Dkt. No. 16 at 2. Respondent further notified Petitioner, through counsel, that soon-to-be finalized amended pricing would also be released, and offered to commit these representations to a written stipulation. Petitioner rejected these efforts to reach an amicable resolution of this matter.

Respondent respectfully requests that the Court take into consideration that Respondent has honored its representation to Petitioner to make the soughtafter information available, and has now released the information at issue in this proceeding. Respondent has acted in good faith and in accordance with its obligations under FOIL. Respondent further requests that the Court schedule a conference to discuss resolving this matter without the need for further litigation.

Thank you for your attention to this matter.

HELENA LYNCH, an attorney duly admitted to practice before this Court,

hereby affirms the following under penalty of perjury:

1. I am an Assistant Attorney General in the Office of Letitia James, the New

York State Attorney General.

2. I submit this Affirmation in support of Respondent's response to the

Verified Petition dated July 9, 2019.

3. Annexed hereto as **Exhibit 1** is a true and correct copy of the Power

Purchase Agreement Between the Long Island Power Authority and Deepwater Wind

South Fork, LLC, dated February 6, 2017 (referred to as the "PPA").

This document was produced to Petitioner in response to the November
28, 2018 FOIL request by Petitioner that is the subject of this proceeding.

5. In email messages dated August 13, 2019 and August 15, 2019, and in a voicemail message dated August 15, 2019, I notified Petitioner's counsel that, based on information provided by LIPA, the pricing he sought would be released once LIPA and Deepwater finalize and amended PPA.

6. In reviewing counsel's response to my message dated August 13, 2019, I realized that I had not made it clear that the pricing in the amended PPA will also be disclosed, in addition to the pricing in the original PPA, once the amended PPA is finalized.

7. For this reason, I left the August 15, 2019 voicemail and on that date sent a second email, making it clear that both the pricing in the original PPA and the pricing in the amended PPA will be disclosed once the amended PPA is finalized.

8. On August 21, 2019, I communicated to Petitioner's counsel an offer to commit to a written stipulation the representation that the pricing information in both the original PPA and amended PPA would be disclosed once the amended PPA is finalized.

9. I proposed that the parties submit this stipulation to the Court to be soordered.

10. Petitioner's counsel rejected this offer
