

## E-BIKE RENTAL AGREEMENT & LIABILITY WAIVER

Cordingley, LLC dba Rapid River Rentals

**PLEASE READ CAREFULLY — THIS IS A LEGAL DOCUMENT THAT AFFECTS YOUR LEGAL RIGHTS**

### 1. PARTIES

This Agreement is between **Cordingley, LLC dba Rapid River Rentals** ("Company") and the undersigned renter ("Renter").

### 2. ACKNOWLEDGMENT OF RISK

Renter understands that riding an electric bicycle (e-bike) involves **inherent risks**, including but not limited to:

- Falls, collisions, and loss of control
- Road hazards, uneven terrain, wildlife, and weather conditions
- Other riders, vehicles, or pedestrians
- Mechanical or equipment failure
- Higher speeds than traditional bicycles

Renter voluntarily assumes **all risks**, known and unknown, including those arising from **Company negligence**.

### 3. RELEASE OF LIABILITY

To the fullest extent allowed under Idaho law, Renter releases and discharges **Cordingley, LLC, Rapid River Rentals, and its owners/employees** from all claims for injury, death, or property damage arising from use of the e-bike, including claims based on negligence.

### 4. INDEMNIFICATION

Renter agrees to **indemnify, defend, and hold harmless** the Company from any claims, damages, losses, or expenses (including attorney fees) resulting from:

- Use or misuse of the e-bike
- Violation of this agreement
- Injury or damage caused by Renter

### 5. RESPONSIBILITY FOR EQUIPMENT

Renter is fully responsible for the e-bike during the rental period and agrees to:

- Return it in the same condition received
- Pay for **all damage, loss, or theft**

### 6. SAFE OPERATION

Renter agrees to:

- Obey all traffic laws
- Ride safely and responsibly
- Not ride under the influence of alcohol or drugs
- Not allow any other person to use the e-bike
- Inspect the e-bike before use

Helmet use is strongly recommended.

### 7. MEDICAL RESPONSIBILITY

Renter is responsible for all medical costs and confirms they have insurance or the ability to pay.

### 8. VALID IDENTIFICATION REQUIRED

Renter must present a valid government-issued photo ID.

### 9. NO WARRANTIES

The e-bike is provided "as is" without warranties of any kind.

## 10. RENTAL TERMS

- No riding under the influence
- Must follow all traffic laws
- No off-road riding in restricted areas

If any part is found invalid, the rest remains in effect.

## 12. GOVERNING LAW

This agreement is governed by the laws of the State of Idaho.

## 13. ACKNOWLEDGMENT

Renter confirms they have read, understood, and voluntarily agree to this waiver and are giving up legal rights.
