

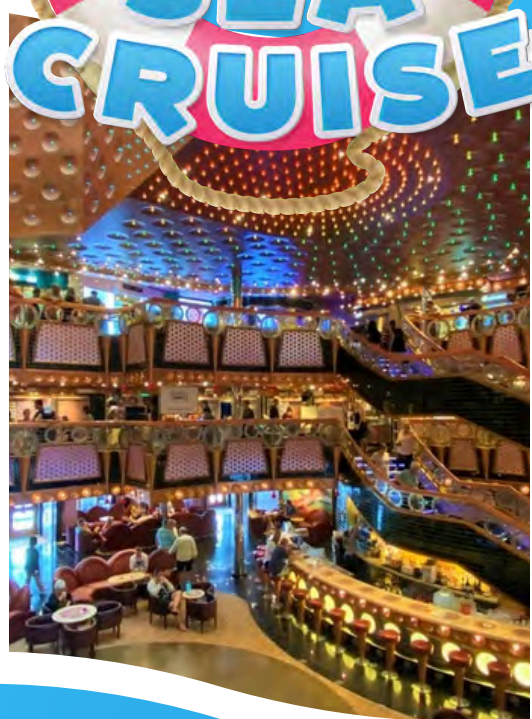
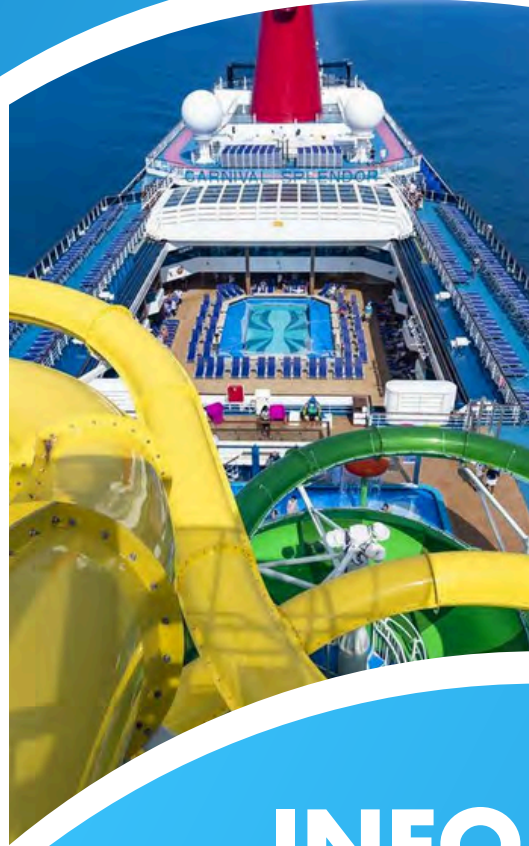

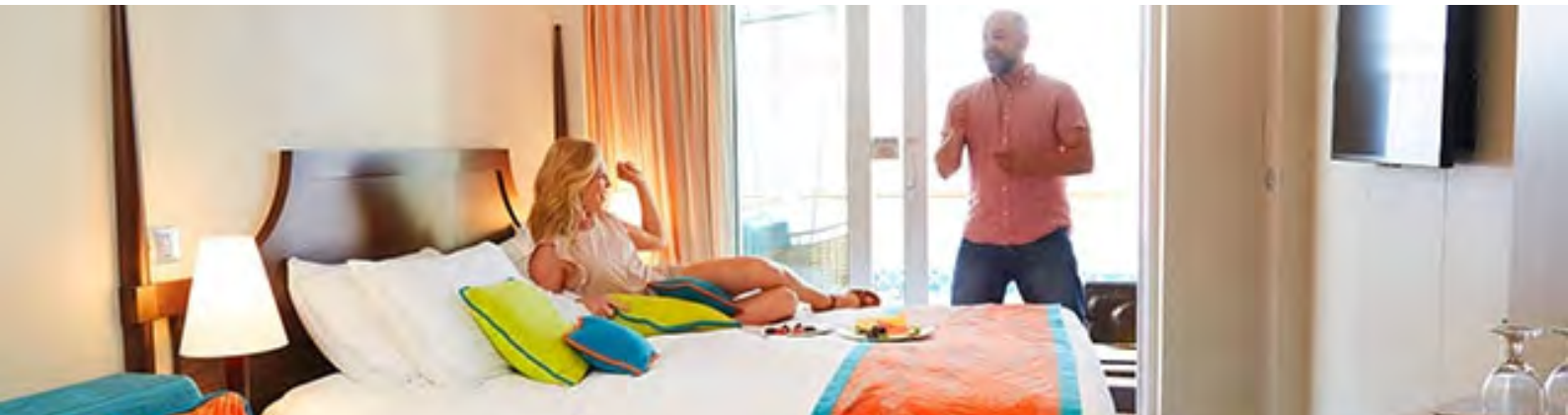

DEPOSITS:

A non-refundable deposit per person is required to secure your booking with us. Please refer to the payment schedule in the itinerary.

If the tour does not go ahead due to lack of numbers (as per the studio's minimum number requirements) all deposits received will be refunded but an administration fee of \$60.00 per family will apply. Payment of the deposit confirms you have read and accepted these terms and conditions.

PROGRESSIVE PAYMENTS:

Global Travel Group Pty Ltd have a company trust account where payments are held. Additional progressive payments can be accepted at any time up till 90 days prior to departure. Receipts are issued for each payment made to us.

FINAL PAYMENT:

You will receive your final Invoice approximately 90 days prior to departure from Australia with final payment due then.

METHODS OF PAYMENT:

Global Travel Group Pty Ltd have a company trust account where payments are held.

We offer various methods of payments including: Direct deposit, credit cards, cash or cheque.

Should you wish to pay by credit card we are happy to accept MasterCard or Visa with a 1.4% surcharge. Amex 1.8% & International Credit Cards 3% Surcharge. This MUST be processed through our Secure 'Travel Pay' website. Once your payment is processed you will receive a receipt from travel pay.

SERVICE FEES:

In some circumstances a service fee for processing may be charged. Check with your Global Travel Group agent if any such service fee applies.

DISCLOSURE AUTHORISATION:

In the event that a natural disaster or other emergency is reported to have occurred in a country where you may be visiting at that time, you authorise Global Travel Group Pty Limited to disclose the details of your itinerary and contact details to the Australian Department of Foreign Affairs and Trade.

LAND ONLY PACKAGE:

If you require a land only package due to alternate options for flights i.e.: Frequent Flyer points, staff travel etc. Global Dance Tours require written notice at least 6 months prior to departure. If this is not advised, a fee of \$200.00 per person will be charged.

HOTELS & AIRLINES:

Flights cannot be confirmed until eleven months prior to travel, hotels are subject to availability and can change up until Final Invoice.

GOVERNMENT FEES AND AIRPORT TAXES:

At Sydney International Airport a local departure tax and airport noise reduction tax is levied on all departing passengers. In addition, foreign government fees and airport taxes may be applicable on your journey. Certain airport taxes must be collected before departure and will appear on your airline ticket.

The tax amount may change at any time until your airline tickets are paid in full and issued.
